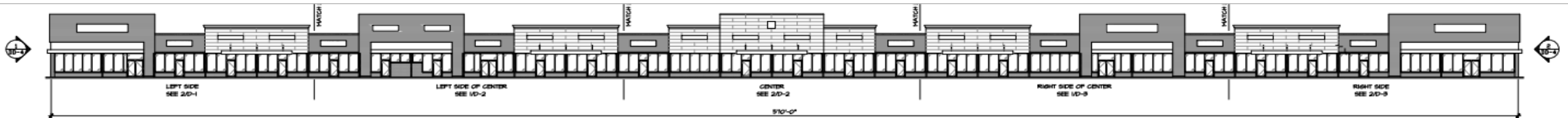

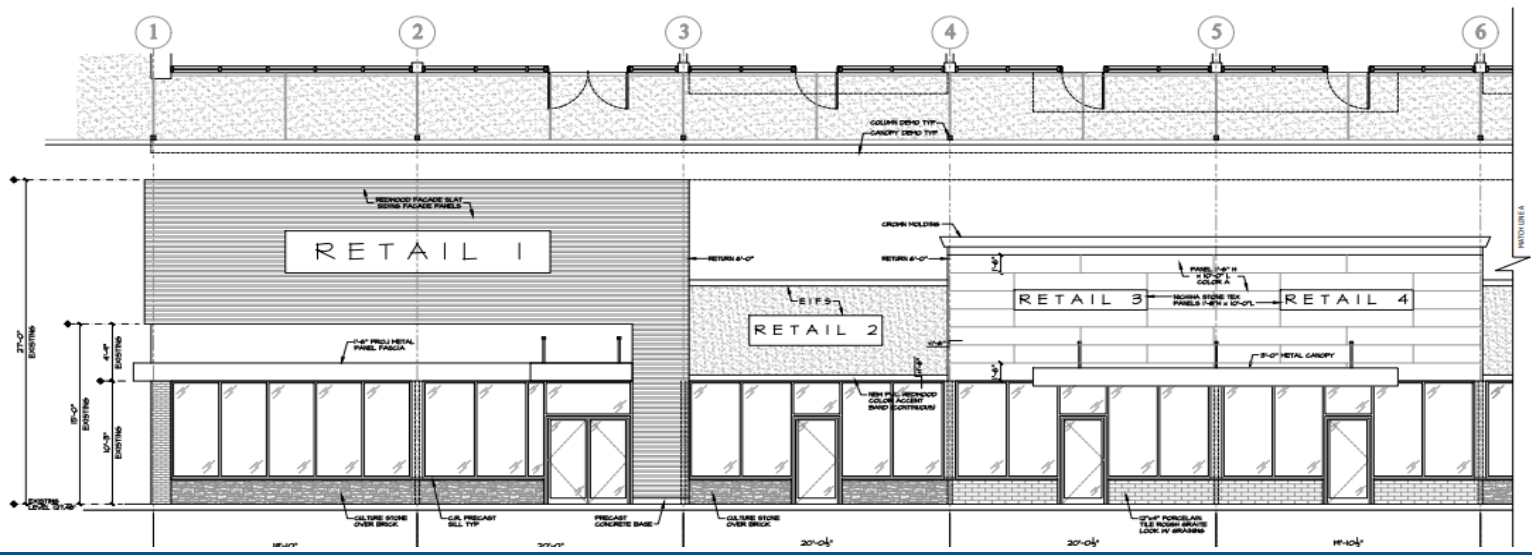

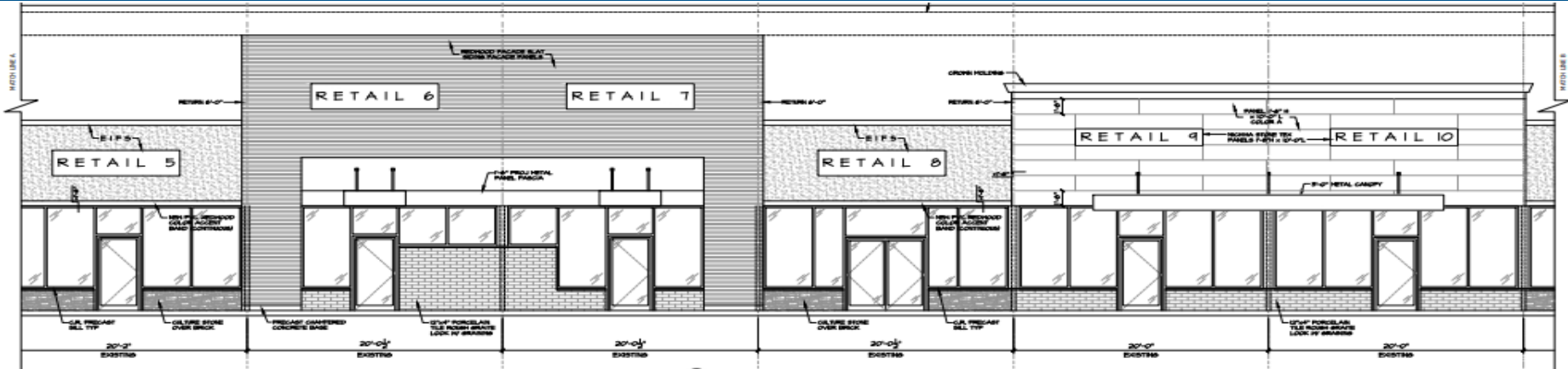
1 PROPOSED FRONT ELEVATION

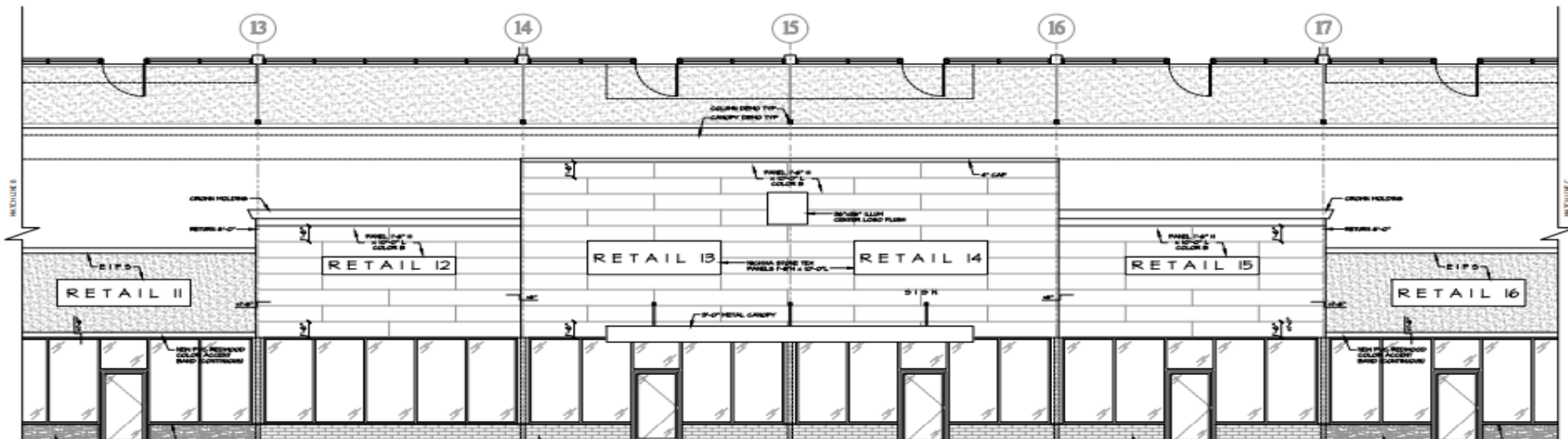

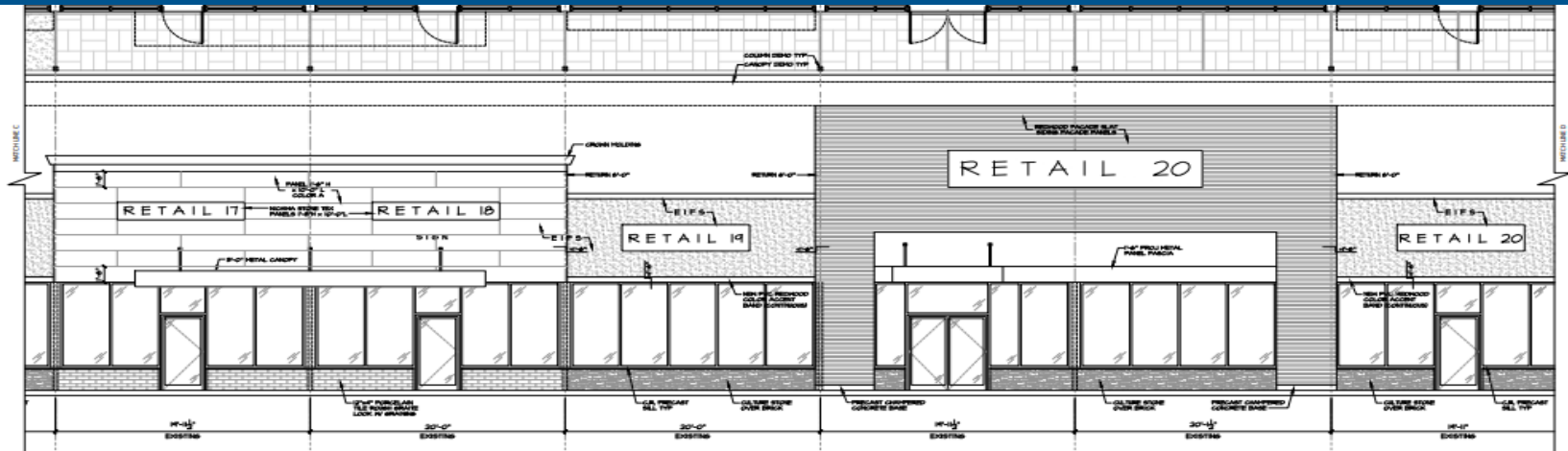
1 LEFT SIDE OF CENTER ELEVATION
SCALE: 1/8" = 1'-0"



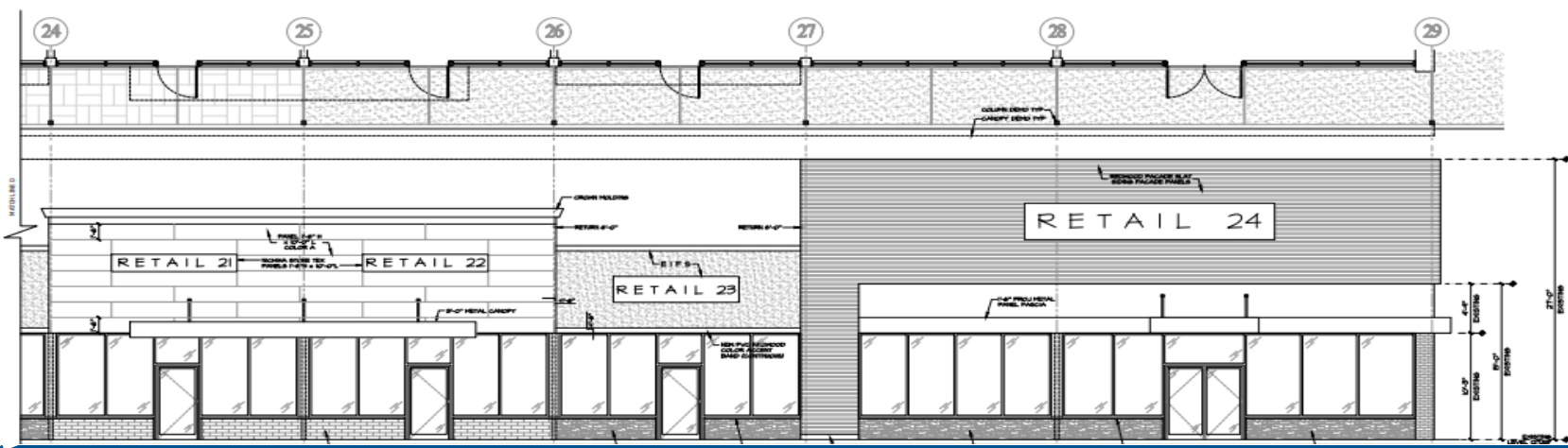
