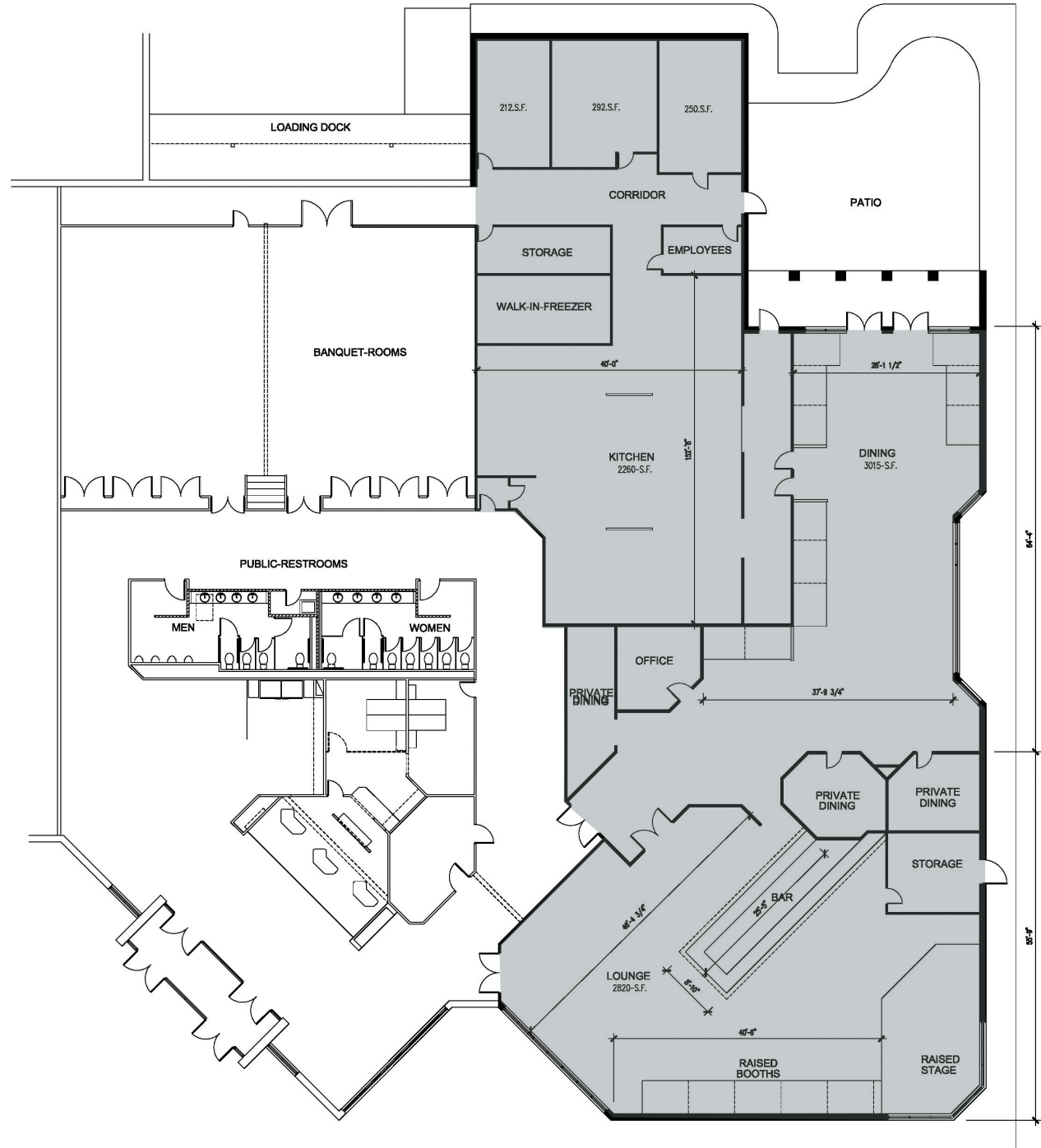

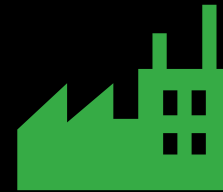

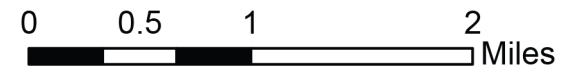
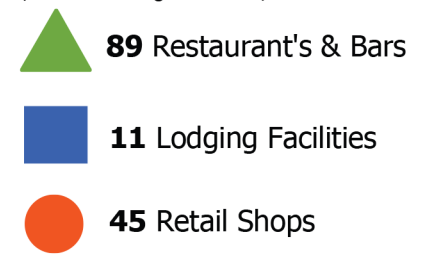


Drive Time Areas in Minutes
