M-1 ZONING

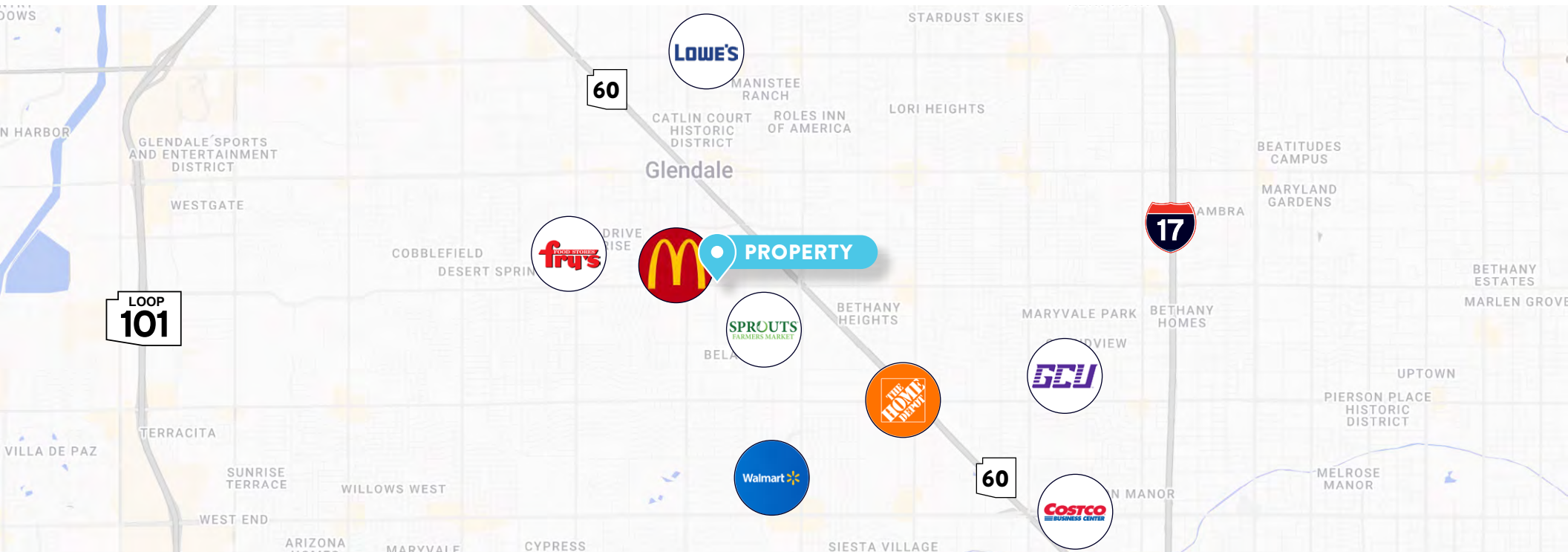
