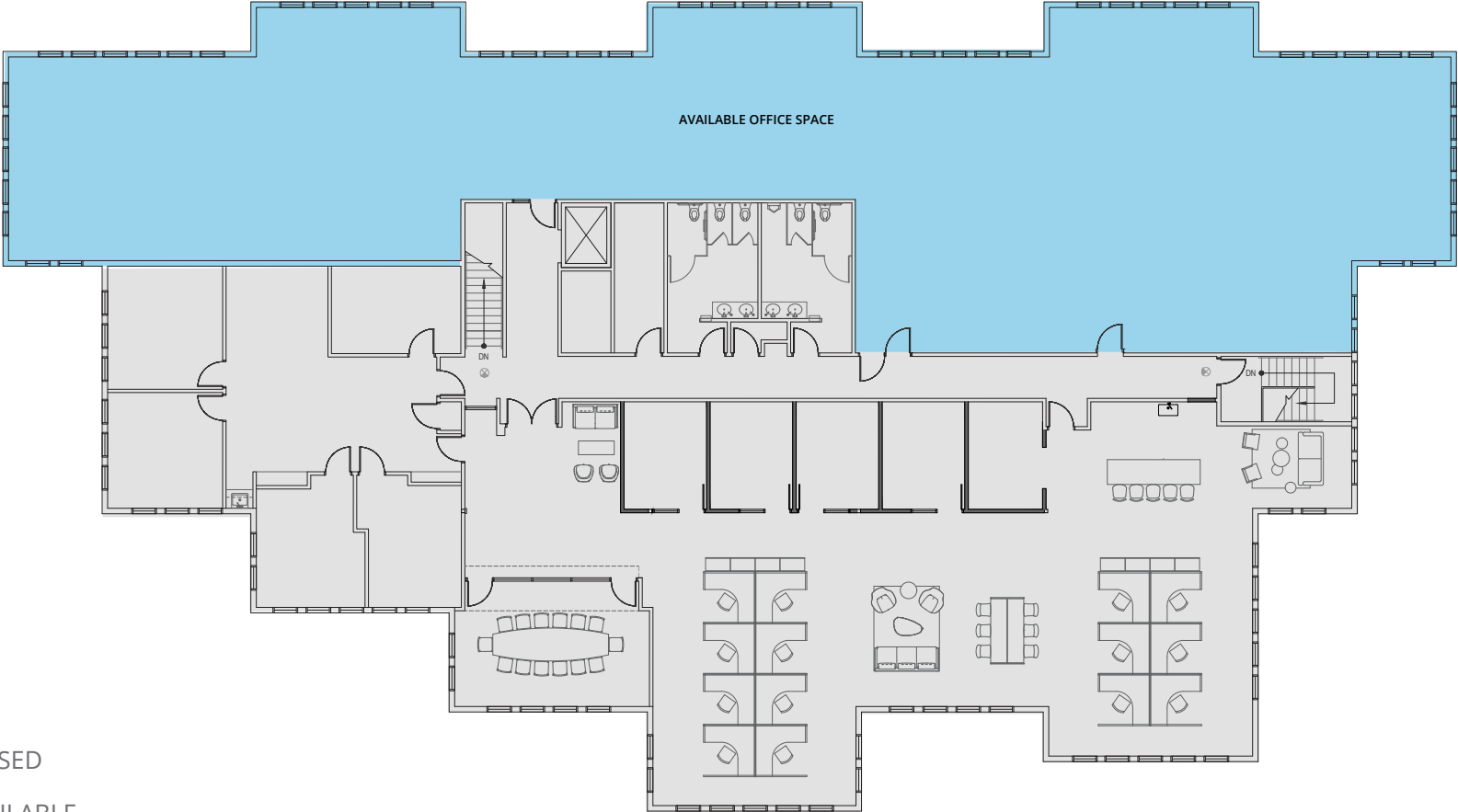

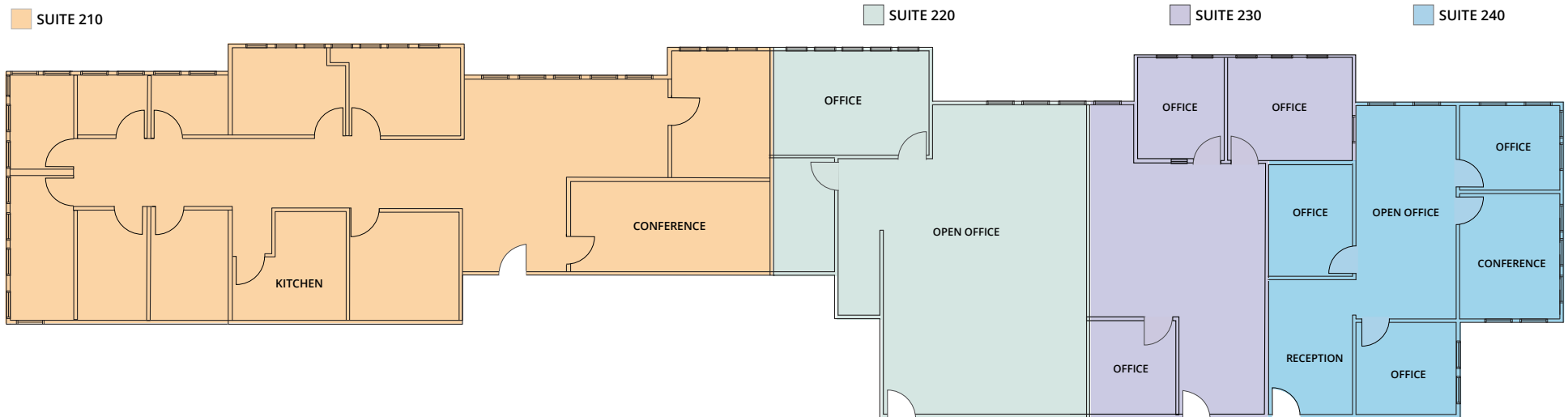

Suite 210 + Suite 220 + Suite 230 + Suite 240: ±6,157 SF



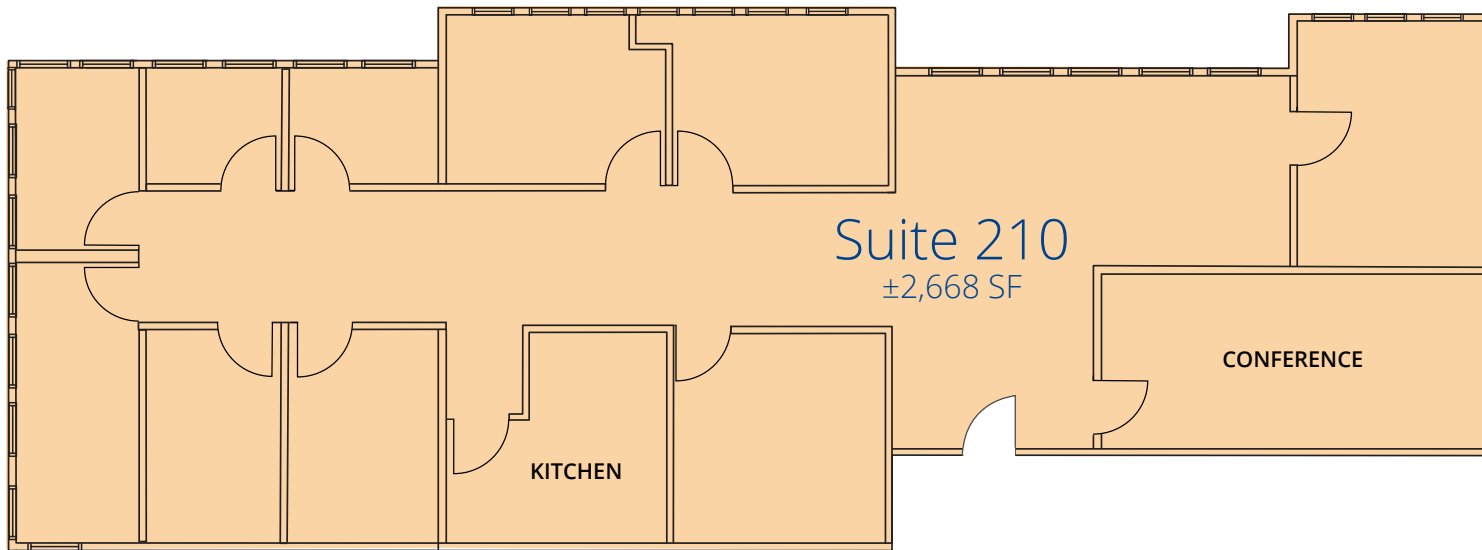
