Going Green at Schilling Green

- Redevelopment of an existing site, salvaging 77% of the building structure and maximizing resource conservation.
- Building envelope utilizing insulation with a greater R Value and Low-E glass, as well as energy-efficient boiler package and high-performance lighting. This decreases the building's energy consumption by more than 21%.
- 87% of the construction waste recycled, diverting construction debris from landfill disposal and reintroducing waste back into usable materials.
- Water-efficient restroom fixtures such as dual-flush toilets, water-free urinals and self-metering faucets, lessening the burden on municipal water supply by approximately 44%.

- 70% of the building's core energy use purchased from a renewable energy sources and photovoltaic panels installed.
- Carbon Dioxide monitoring system & increased ventilation, enhancing the indoor air quality.
- Low-VOC materials used for all adhesives, sealants, paints, coatings, carpet and composite wood used in the building.
- Preferred parking spaces for hybrid vehicles to promote the use of fuel-efficient vehicles in an attempt to reduce pollution from automobiles.
- Landscaping with native, drought-tolerant plant species, efficient irrigation heads and weather station, causing a 56% reduction in irrigation water use.


