RE: Public Hearing Notification

Bylaw 1908-2024 Land Use Bylaw Amendment-Direct Control Redistricting

The Town is undertaking the process to replace the Waterfront Direct Control and the Lakeshore Direct Control districts with more standardized land use districts as recommended in the Sustainable Waterfront Area Redevelopment Plan (SWARP) that was approved by Council in 2019.

Bylaw 1908-2024 will amend the Land Use Bylaw by replacing the direct control districts noted above with new districts that will provide clear development regulations supporting a more streamlined approval process. The new districts will specify the types of permitted and discretionary uses considered on a parcel and provide detailed regulations including building heights, setbacks, site coverage and more. This will provide more certainty for landowners on what can be developed on a parcel of land and clarity on how an area is expected to redevelop over time.

The bylaw received first reading on November 25, 2024 and a Public Hearing has been set for **January 13, 2024 at 6:00pm** in the Council Chambers of the Municipal Government Building at 5012 48 Avenue, Sylvan Lake, Alberta. Included in this letter, as attachment 1, is a map showing the proposed new districts for your reference. Bylaw 1909-2024 Sustainable Waterfront Area Redevelopment Plan Amendment

To support the redistricting proposed in Bylaw 1908-2024 noted above, the SWARP requires an amendment to update three maps in the document. These mapping amendments are required to ensure alignment with the boundaries of the proposed new land use districts. Specifically, the amendment affects the area north of 50 Avenue between 50 Street and 46 Street.

Bylaw 1909-2024 received first reading on November 25, 2024 and a Public Hearing has been set for **January 13, 2024 at 6:00pm** in the Council Chambers of the Municipal Government Building at 5012 48 Avenue, Sylvan Lake, Alberta. You may view the full



Notice of Public Hearing for Bylaw 1908/2024 and 1909/2024

The Town is proposing to replace the Waterfront Direct Control and the Lakeshore Direct Control districts with new land use districts. Unlike the current direct control districts, the new districts will provide clear development regulations including the types of uses for each district, building heights, site coverage, landscaping requirements and more. This will streamline the approval process for development applications in the waterfront and help residents in the area understand how their neighbourhoods are expected to redevelop into the future. These new districts align with the policies of the Sustainable Waterfront Area Redevelopment Plan that was approved by Council in 2019. An open house for the new districts was held on October 10, 2024 and the information that was presented can be viewed on the Town's Engage webpage at https://engage.sylvanlake.ca/housing-accelerator-fund



To support the redistricting noted above the Town is proposing to amend the Sustainable Waterfront Area Redevelopment Plan (SWARP) which was approved by Council in 2019. The amendments include an update to three maps contained in the document to ensure alignment with the boundaries of the new land use districts that are being proposed.
