SVN Stone Commercial Real Estate is pleased to offer a versatile industrial flex space located at 1050 Enterprise Drive in Lexington, Kentucky. The available space comprises approximately 3,500 square feet and offers flexibility to accommodate a variety of user requirements.

The space features an updated, functional office layout that includes private offices, open areas suitable for cubicle use, restrooms, and break areas. The balance of the space is dedicated to warehouse use, offering 20-foot clear heights sloping to 18-foot eaves, gas-fired forced-air heating, and a 10-foot by 12-foot automatic grade-level drive-in door.

Situated within the highly desirable Enterprise Industrial Park in Lexington's Northwest Industrial Corridor, the property benefits from excellent access to Interstate 75 and Interstate 64, both located within five miles, allowing for efficient connectivity throughout Lexington and the surrounding Central Kentucky region.

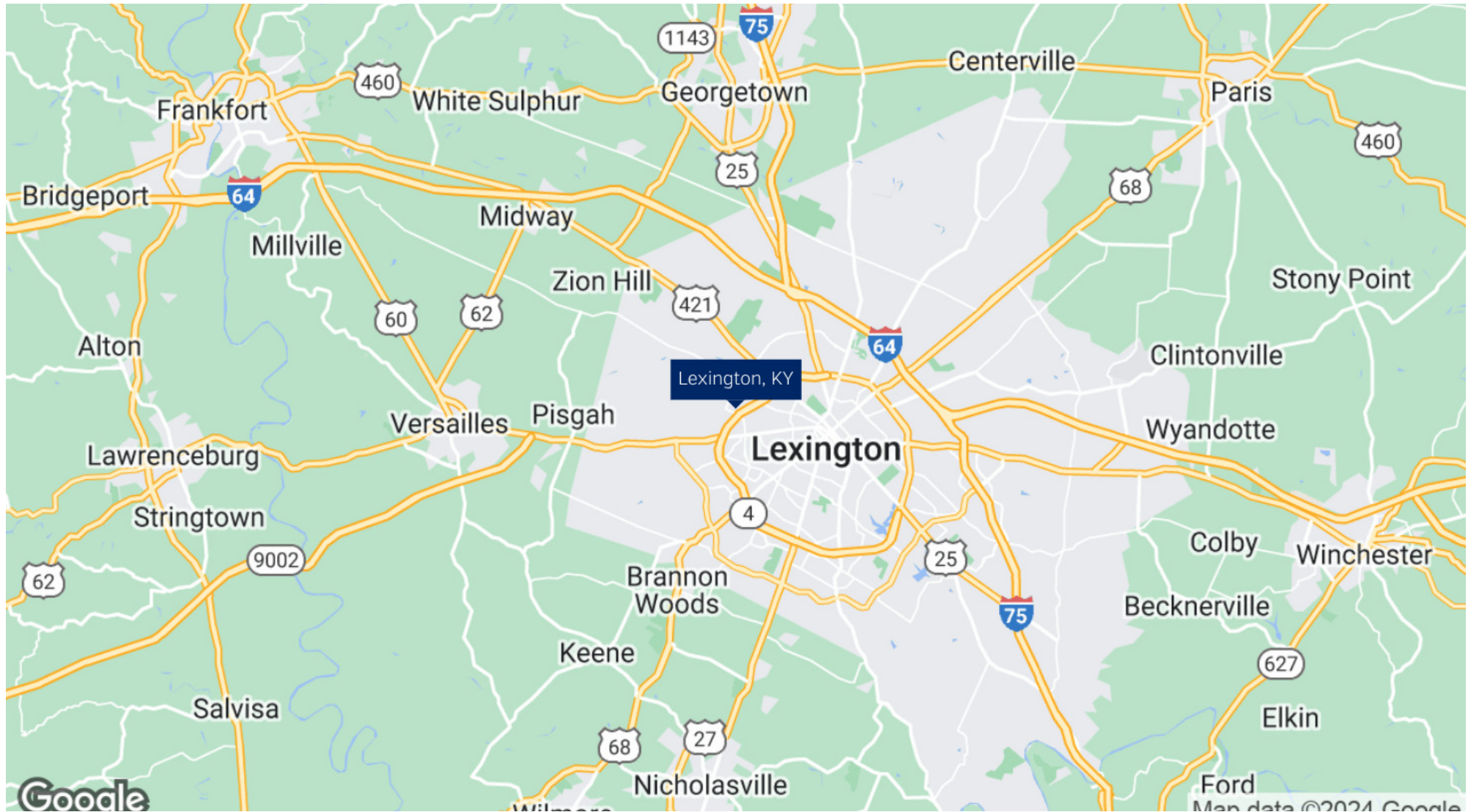
