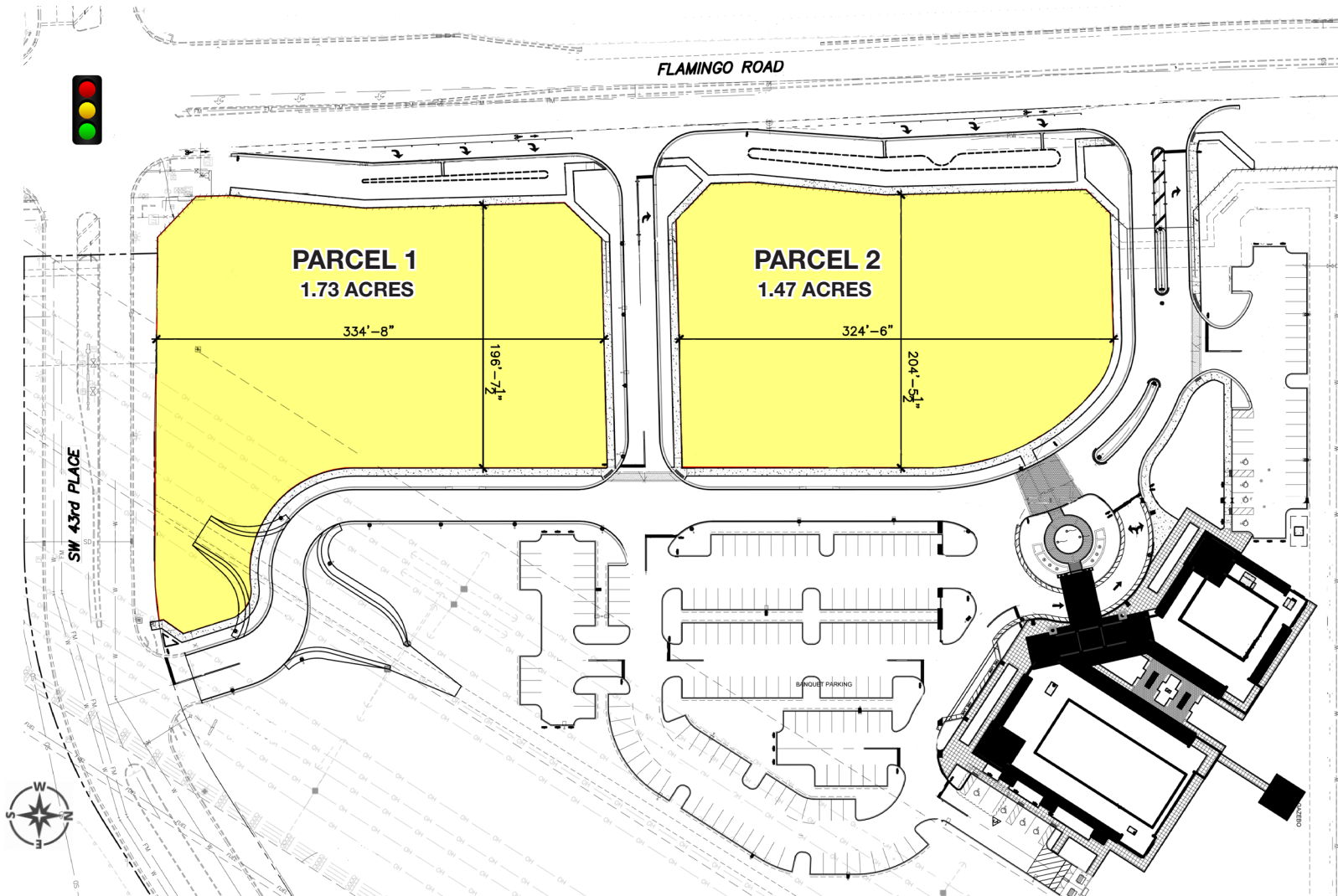

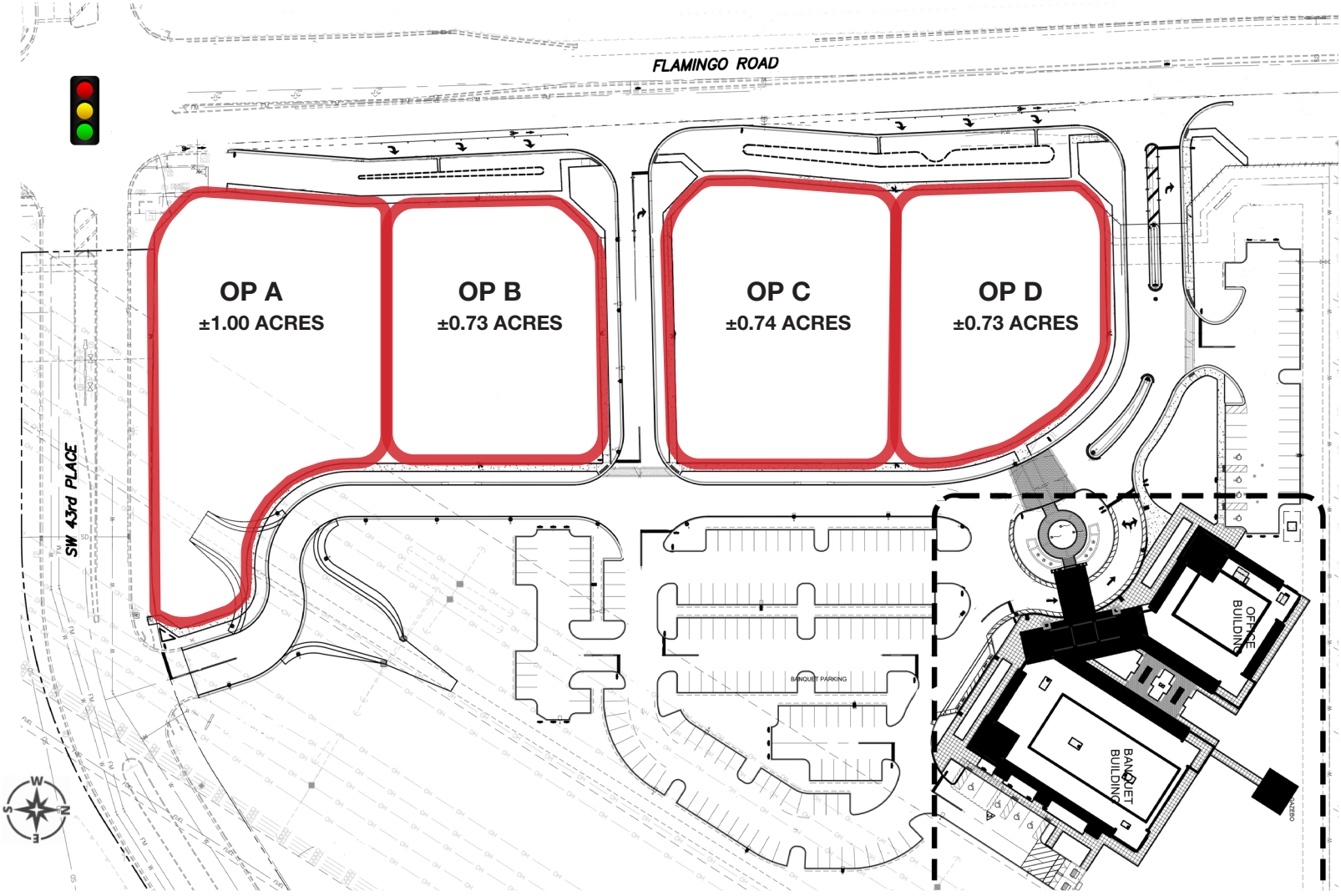

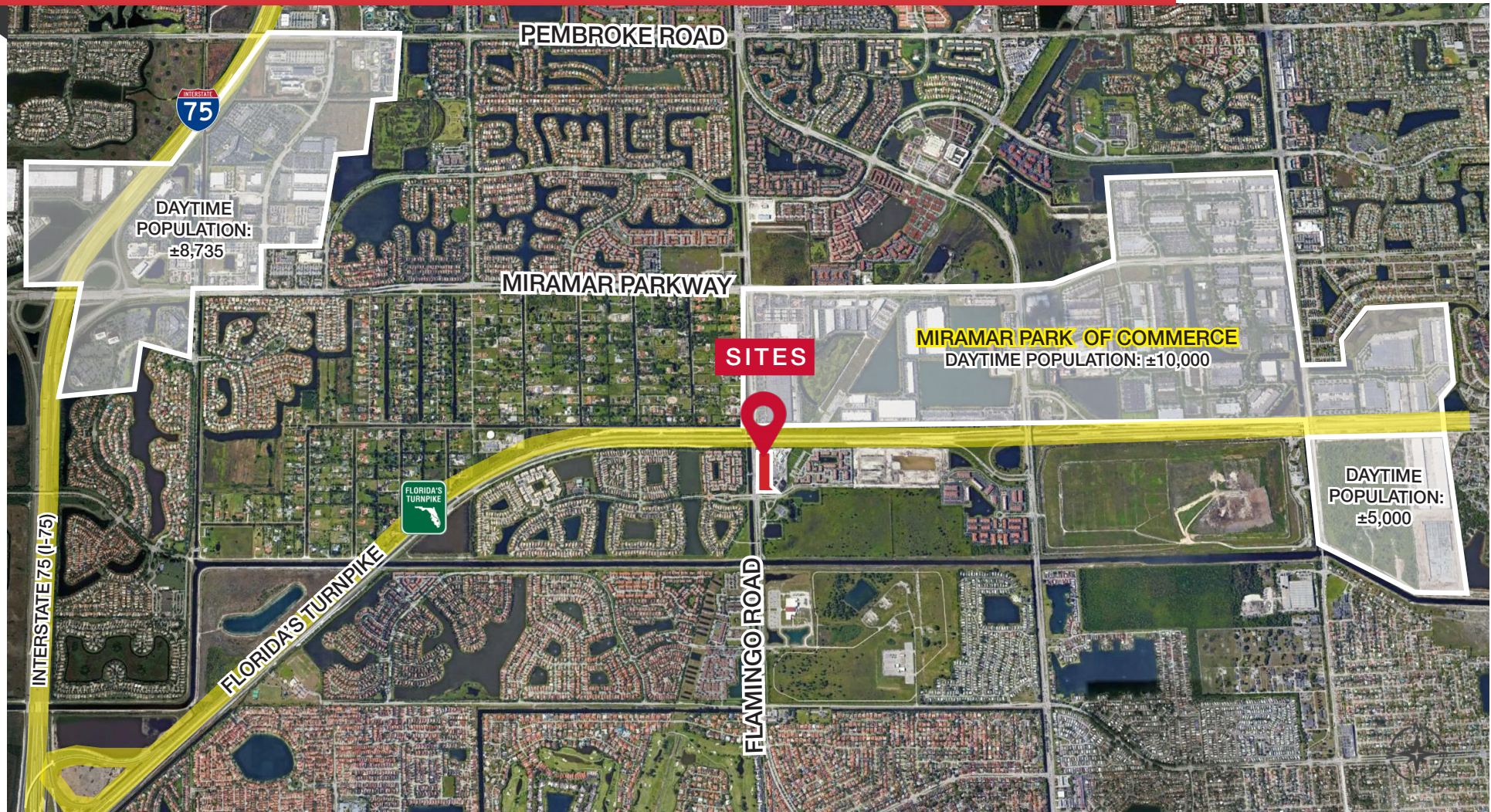


DAYTIME POPULATION MAP

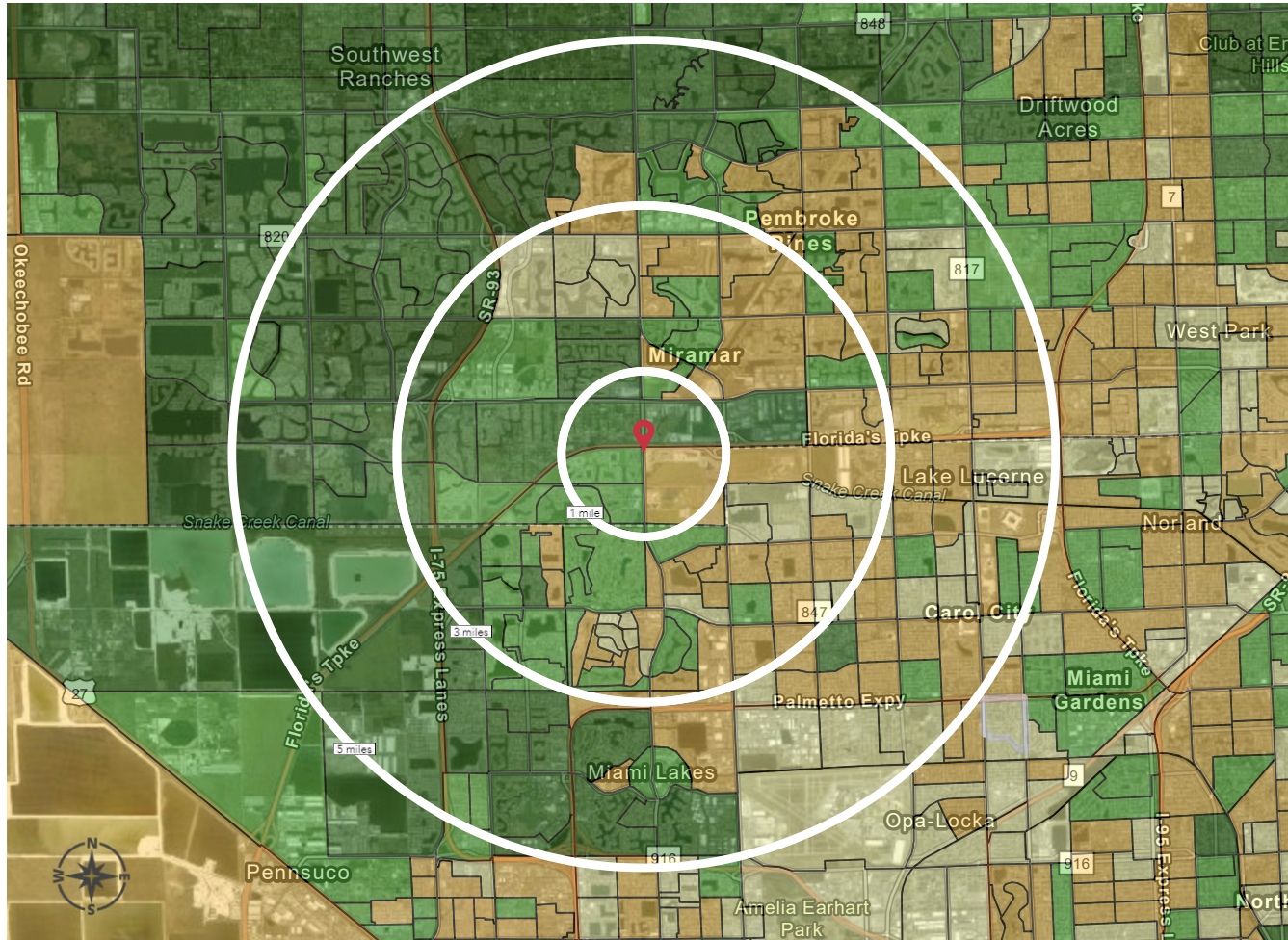
