## STATE OF WISCONSIN BROKER DISCLOSURE



Wisconsin law requires all real estate licensees to give the following information about brokerage services to prospective customers.

### Disclosure to Customers

- The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the advantages and disadvantages of the proposals.

### Confidentiality Notice to Customers

### Definition of Material Adverse Facts

A “Material Adverse Fact” is defined in Wis.
