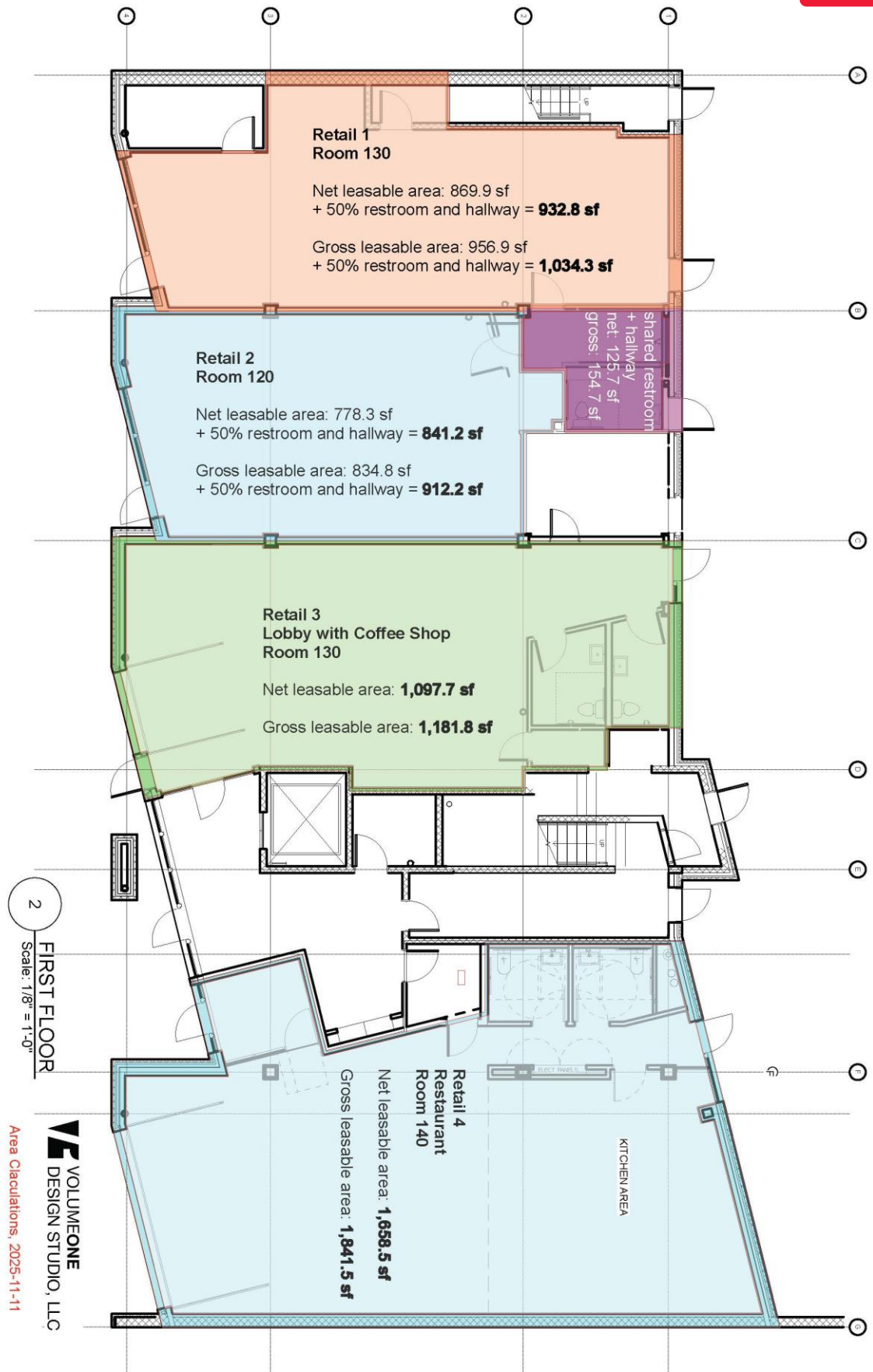

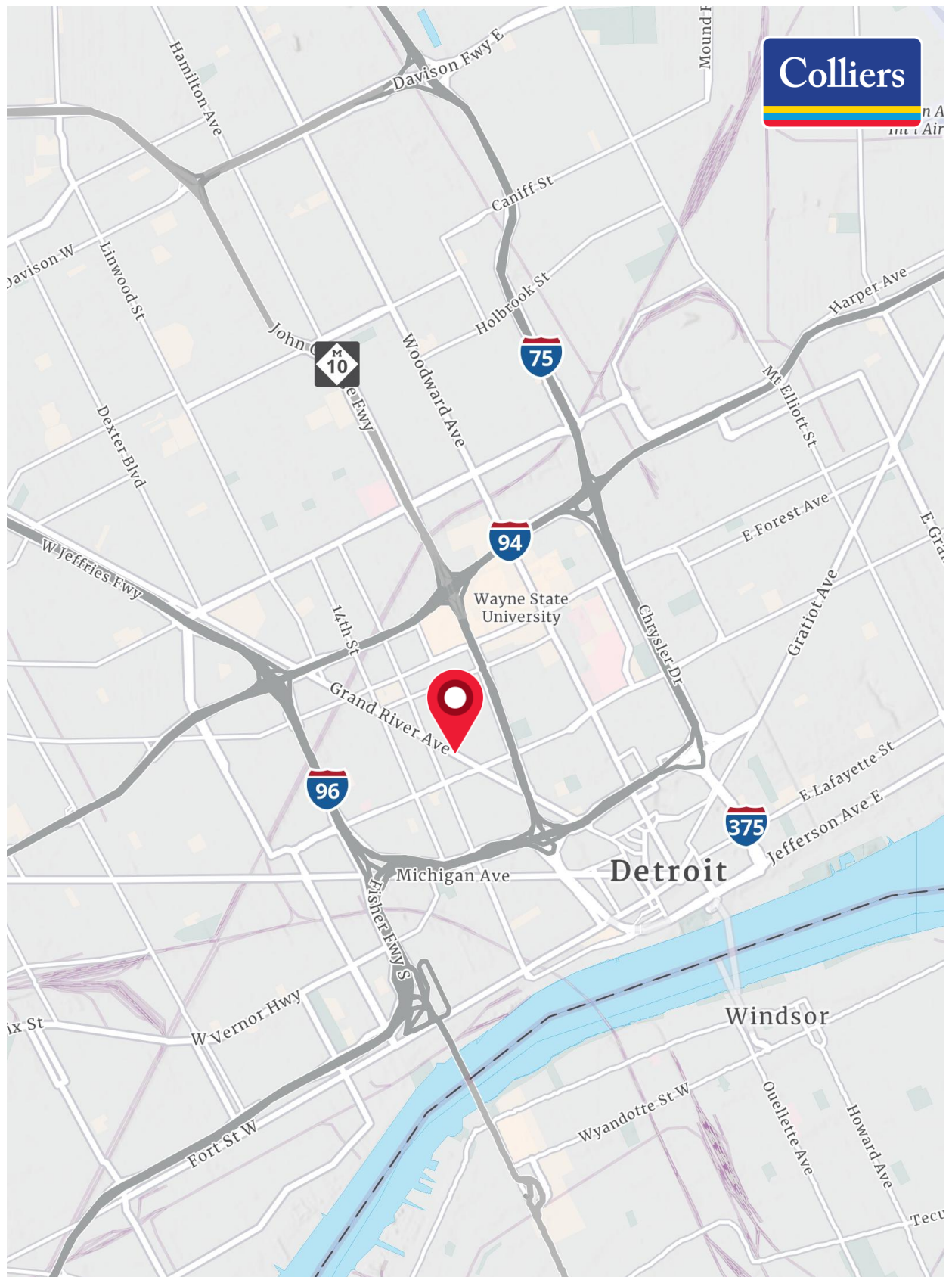
FLOOR PLAN
