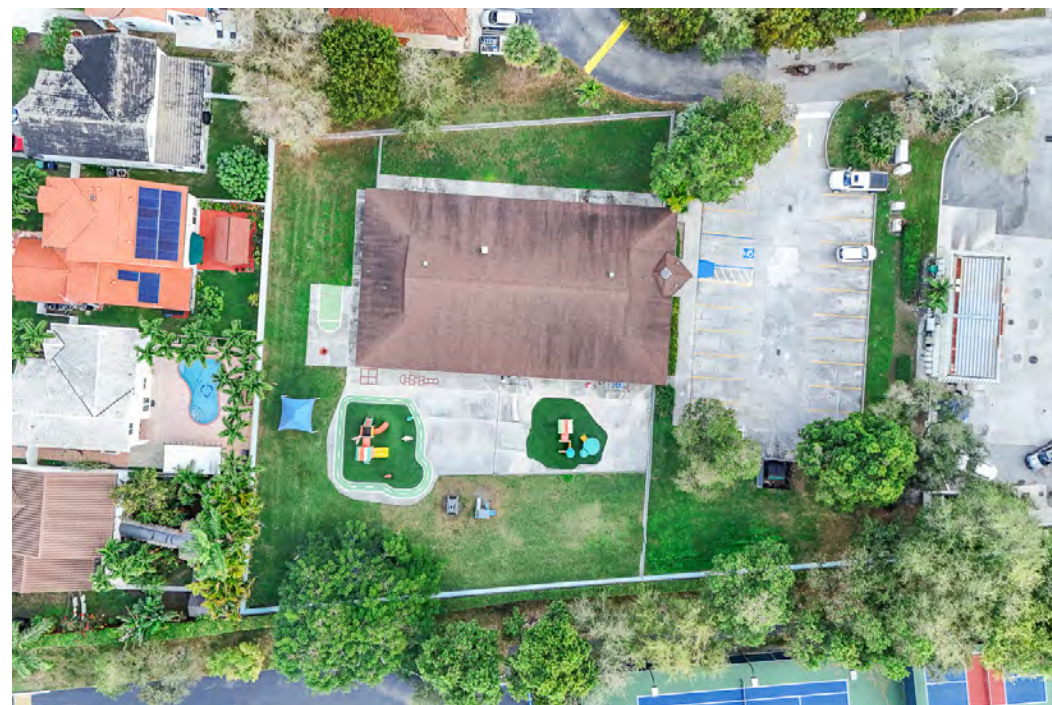

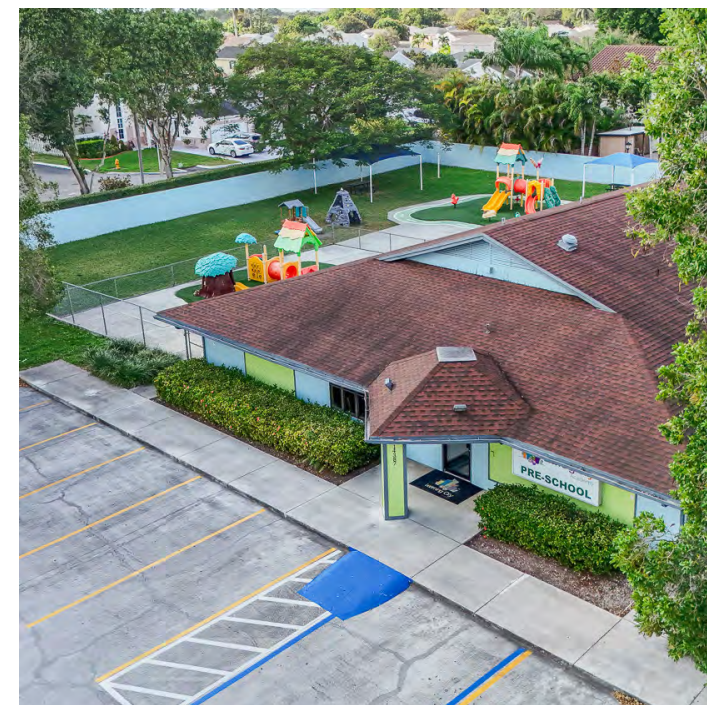

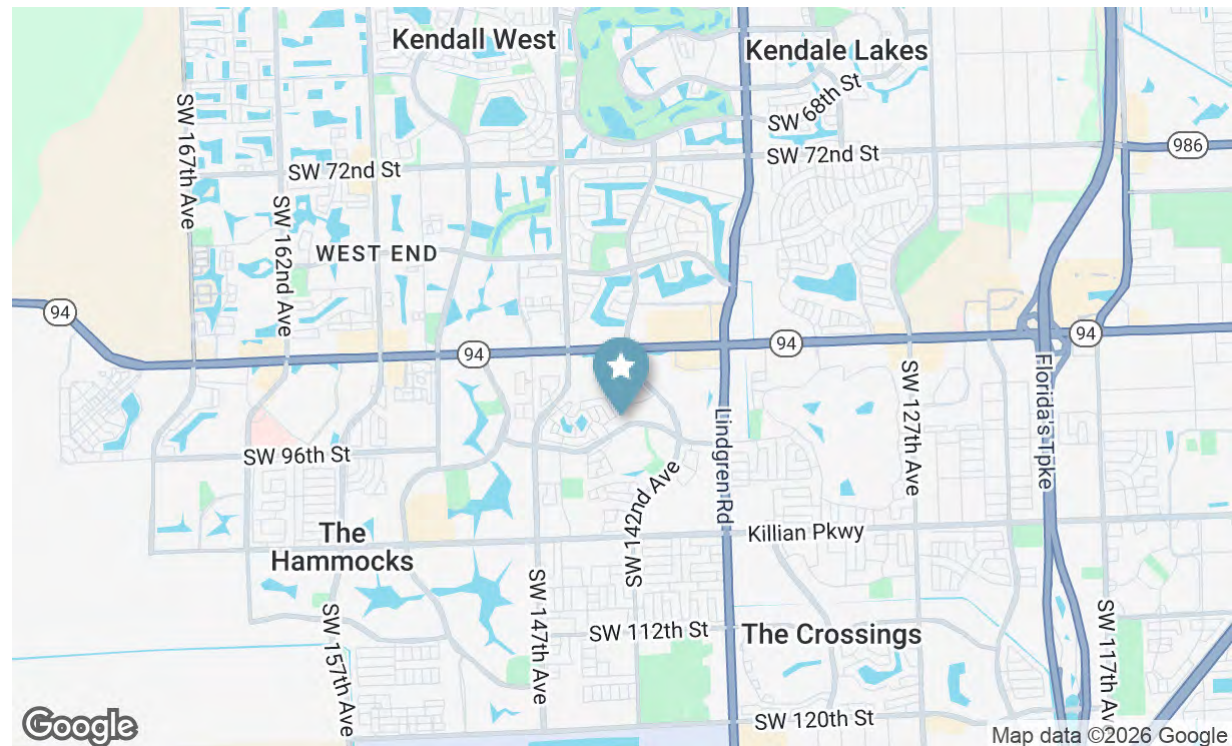

ABOUT MIAMI

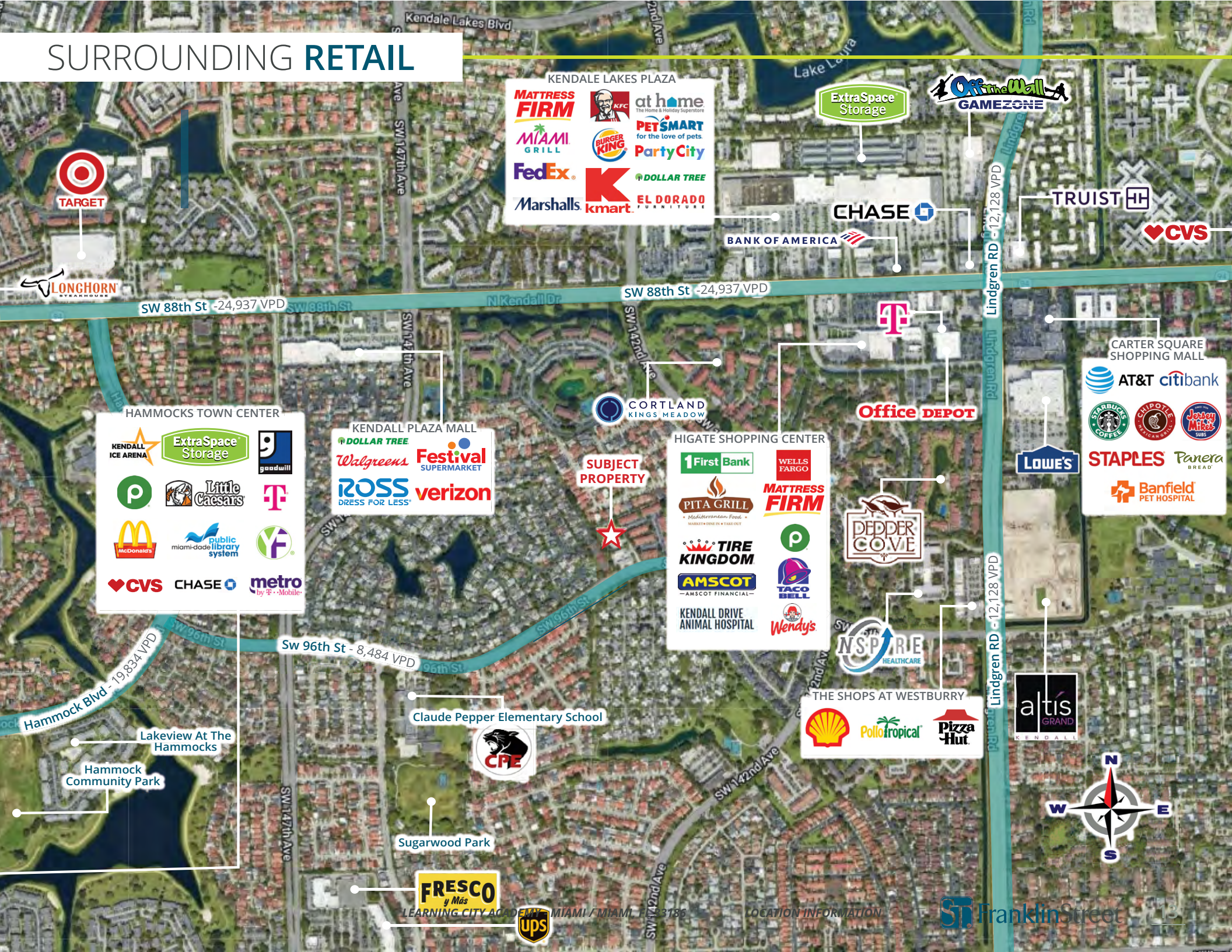

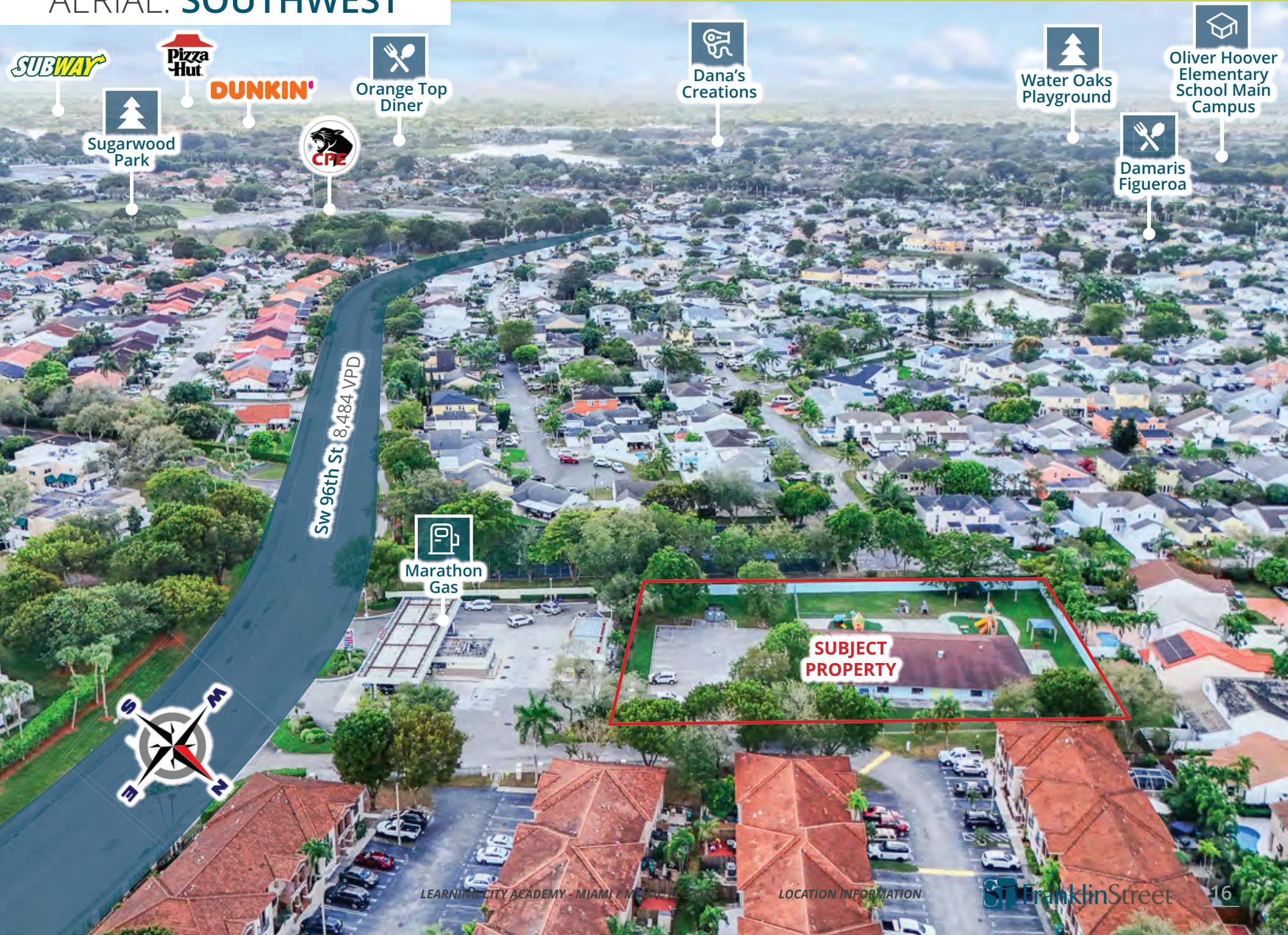

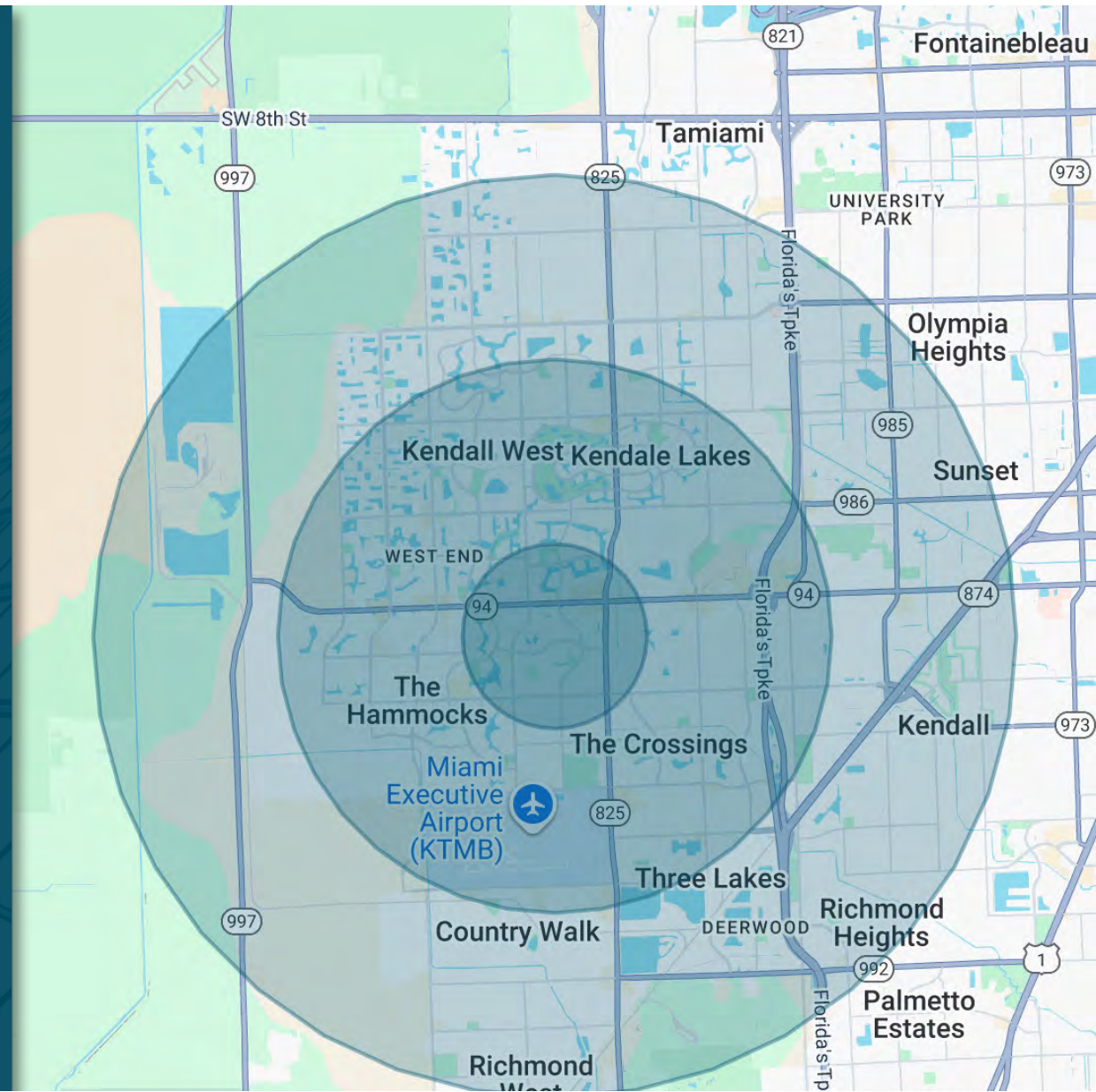
