








## **TYPICAL FLOOR PLAN**





### **PLAT MAP**







#### TOWN OF OSSINING

Ossining is situated about 30 miles from mid-Manhattan, nestled on the banks of the Hudson River. The town of Ossining is built on terraced hills overlooking the Hudson River, with views of Hook Mountain, High Tor, and on a clear day, the towers of Manhattan.

In 1685 Frederick Philipse bought the land from the Sint Sinck Indians; in 1812 the Village of Sing Sing was incorporated, and in 1846, on the advice of an eminent Indian authority, the town was christened "Ossining". Due to the history of the villages, a number of Ossining structures are on the National Register of Historic Places.

#### PARKS & RECREATION

Ossining has an extensive recreation program for all age groups, including a summer day camp for local children. The Ossining Village Fair is held each year, bringing everyone together for a day of fun and food. There is also a seasonal weekend Farmer's Market. Cedar Lane Park, one of many in the area, features 29 acres of walking trails, an athletic field, and community garden. The Teatown Reservation, a 780-acre preserve and nature center, offers over 14 miles of hiking trails and a 33-acre lake. There are three boat clubs: Shattamuc, Ossining Boat and Canoe Club, and Canoe Club, Inc.

#### THE LIFESTYLE

In the warm months, a popular Farmer's Market offers artisanal cheeses, organic produce, plants, homemade baked goods and more.


#### EDUCATION

In addition to Ossining's public schools, there are three parochial schools in the area that include kindergarten through eighth grade. The Ossining High School, offers students a variety of enrichment opportunities, including two high school programs which offer college-level courses.


