## SUMMARY

---

The building is situated on 0.56 leased acres, near Pacific Northwest National Laboratory, the Richland WSU Tri-Cities campus, and the Hanford site.

The area has experienced a tremendous amount of recent development activity, including residential, Washington State University housing, commercial, and research laboratory space. More development is planned for this area.

The building is comprised of two wings, one of which has historically been used to support a large, secured computer server. The remainder of the building has been used as laboratory space. Both spaces were utilized by long-term tenant PNNL for 18 years.

The building features additional security provisions including emergency lighting, fire alarm system including sprinklers throughout the building.

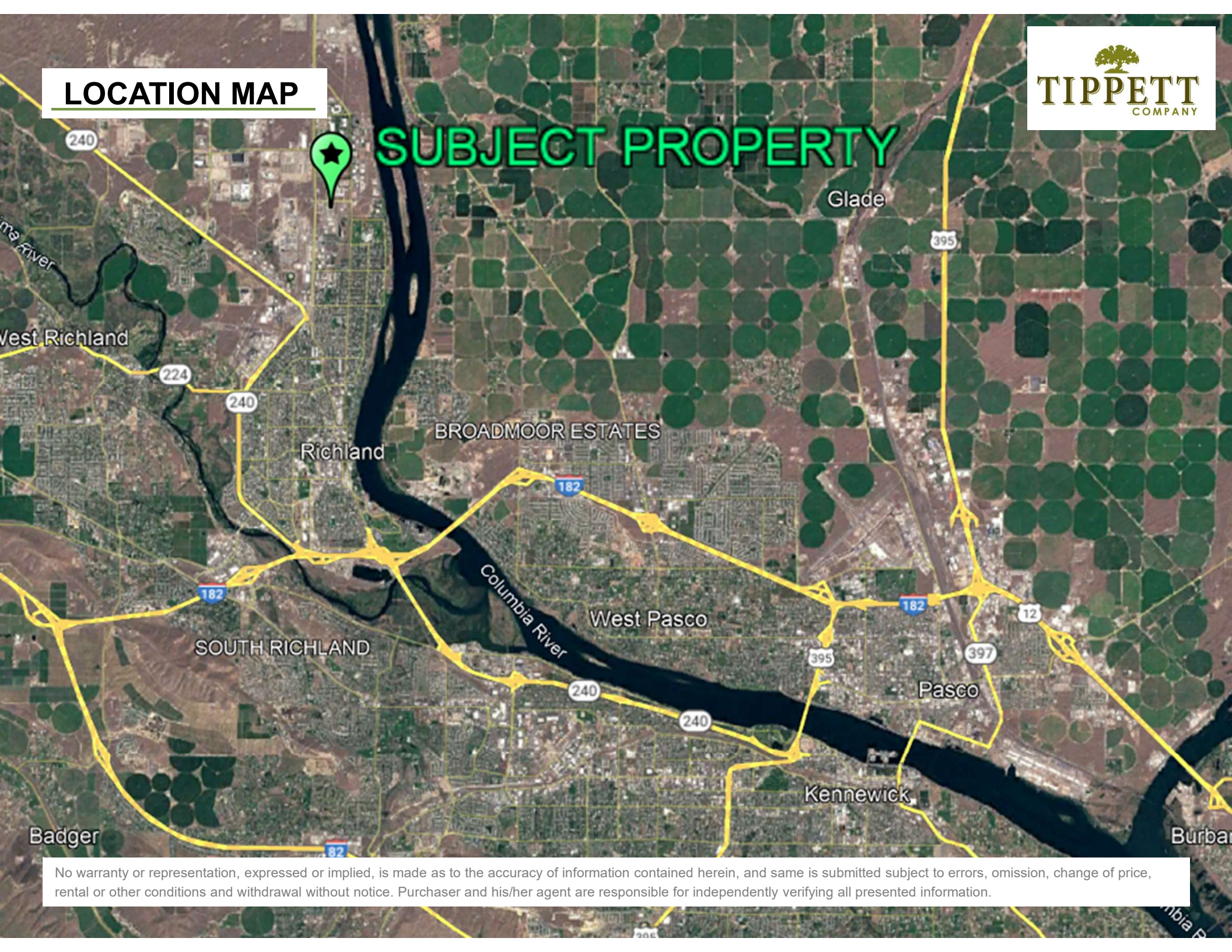

# LOCATION MAP

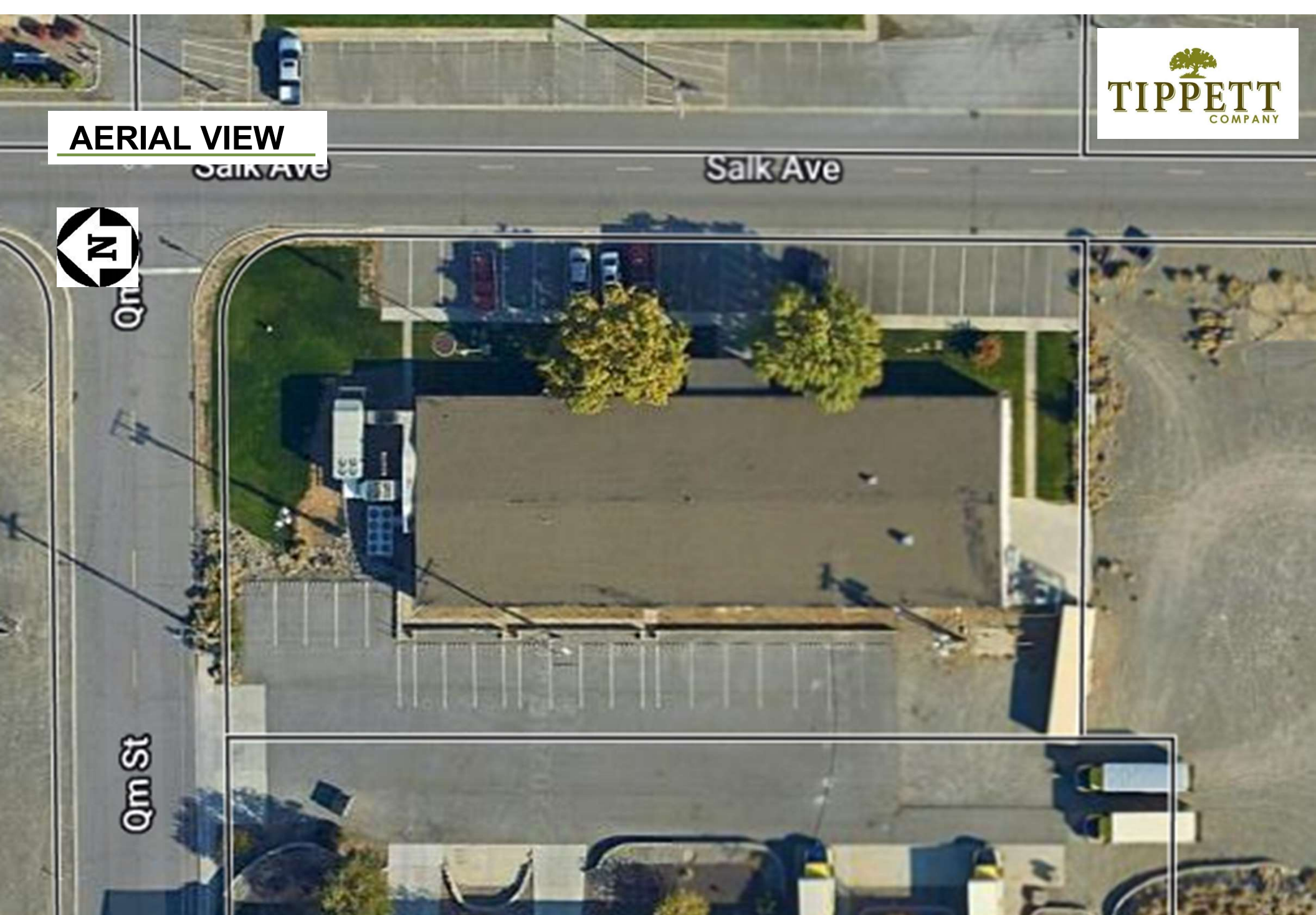

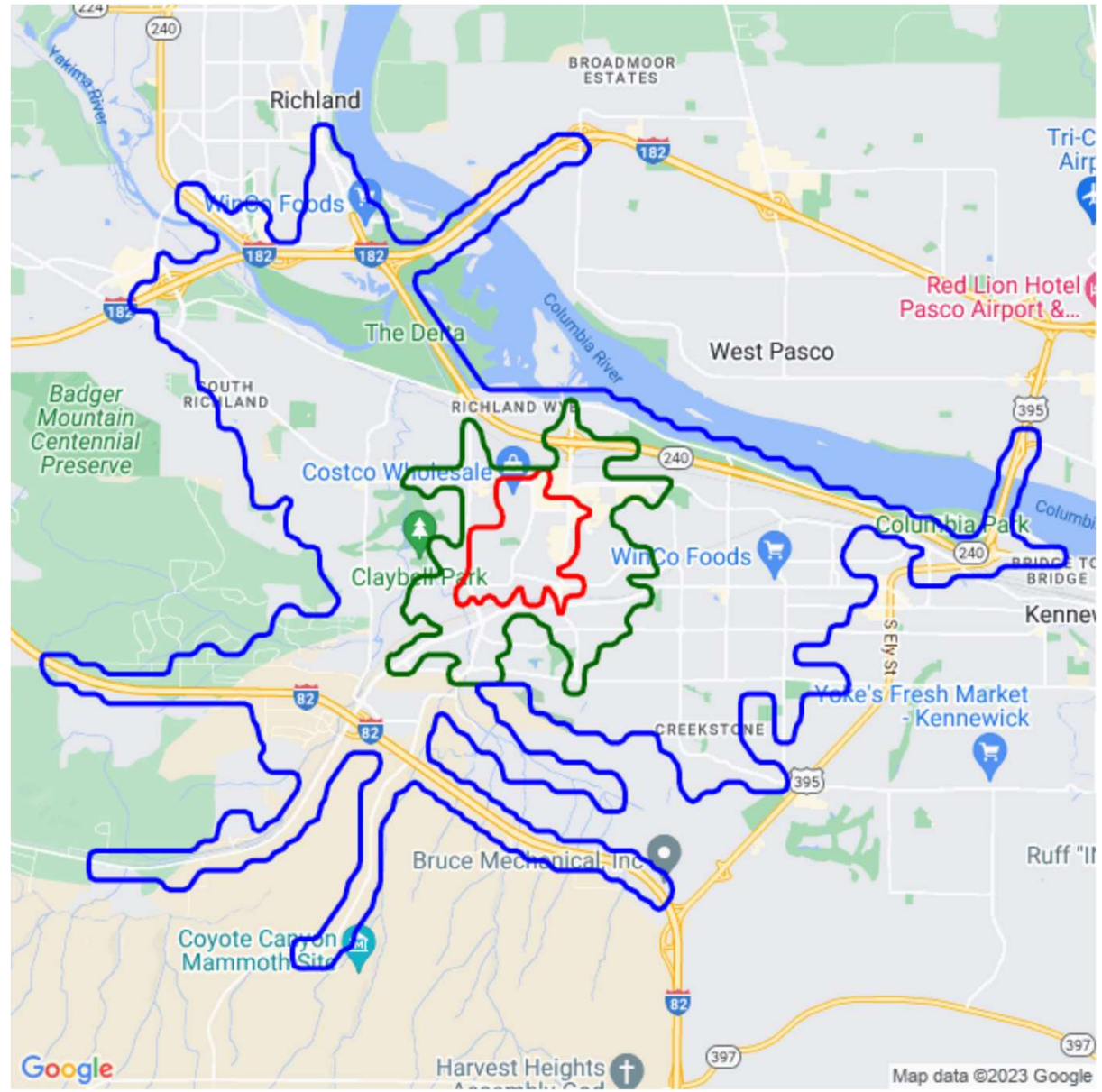

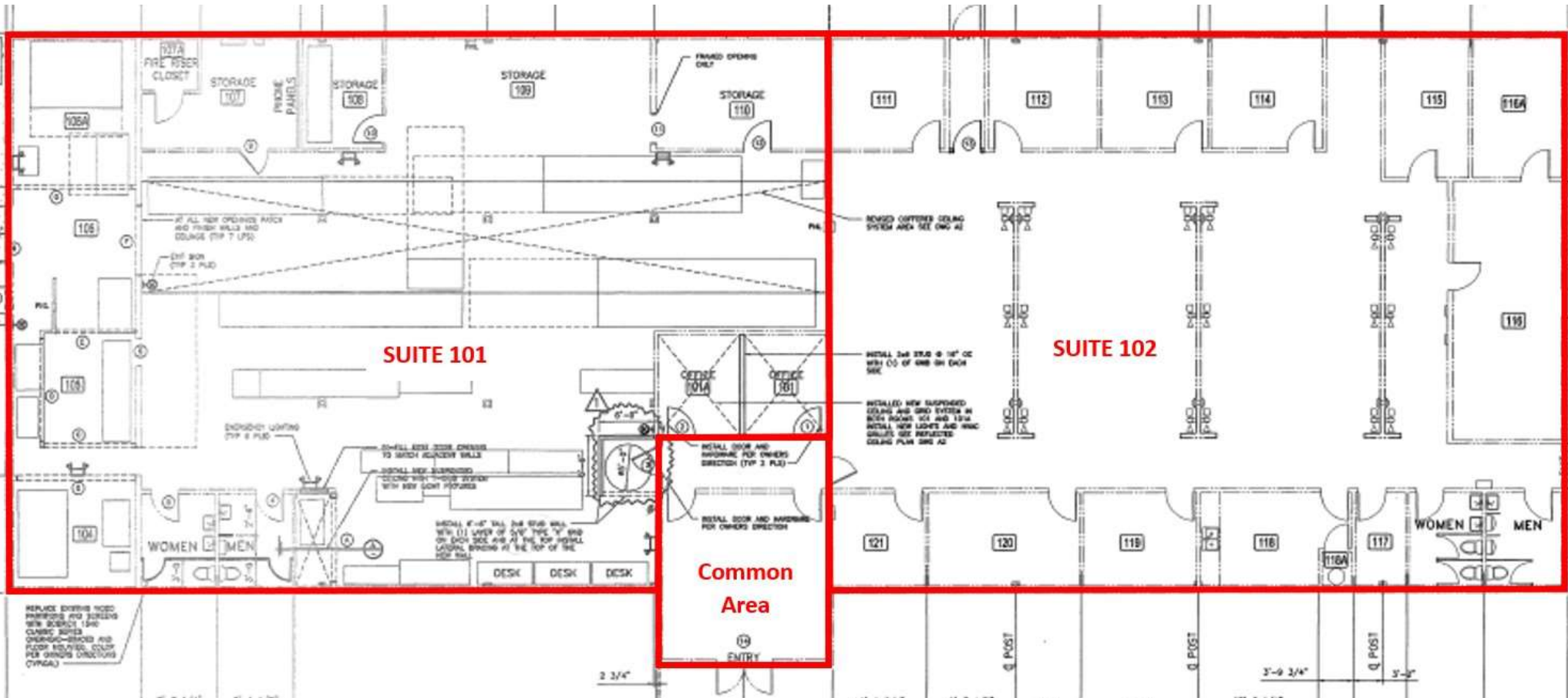
