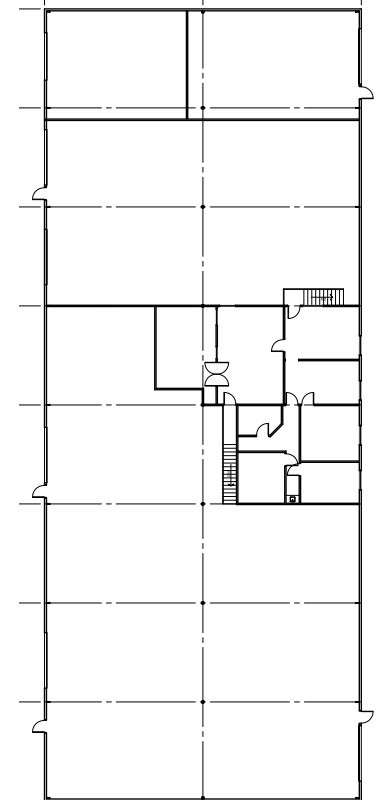
SITE PLAN

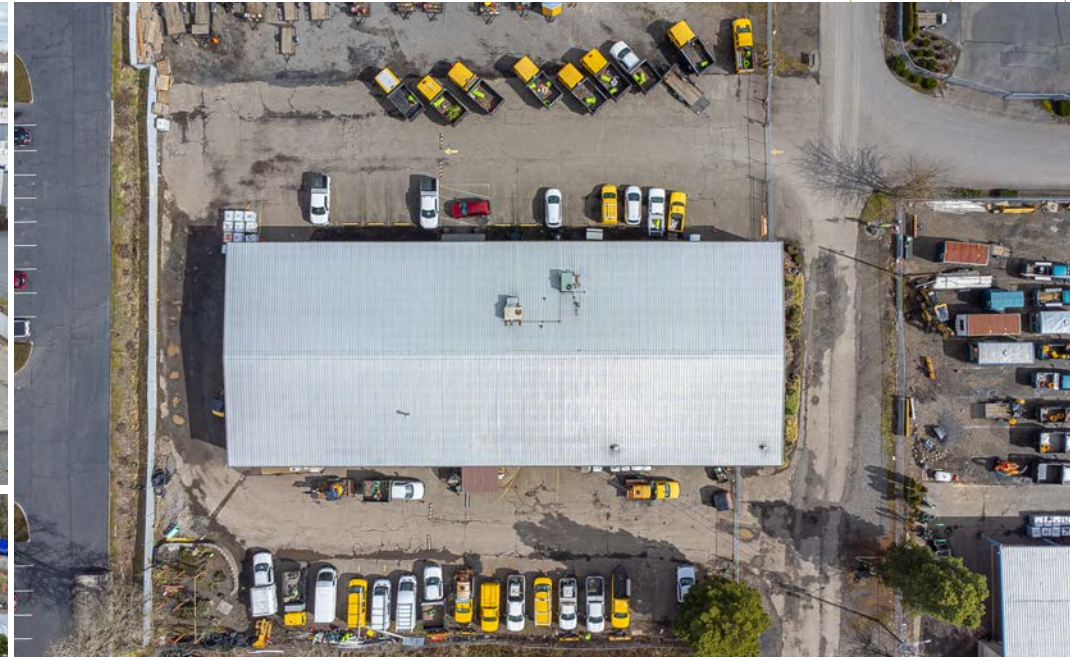
