Villatel Orlando Resort – 5120 Del Verde Way. 77 acres of mixed use development including 526 single family vacation homes, condos and town homes. Grounds include multiple lakes, community clubhouse with resort-style pool, lazy river, restaurant and water park. Phased opening started 2023. Completion early 2026.
Phase 1: 96 condominiums, 34 single family homes and 120 townhouses.
