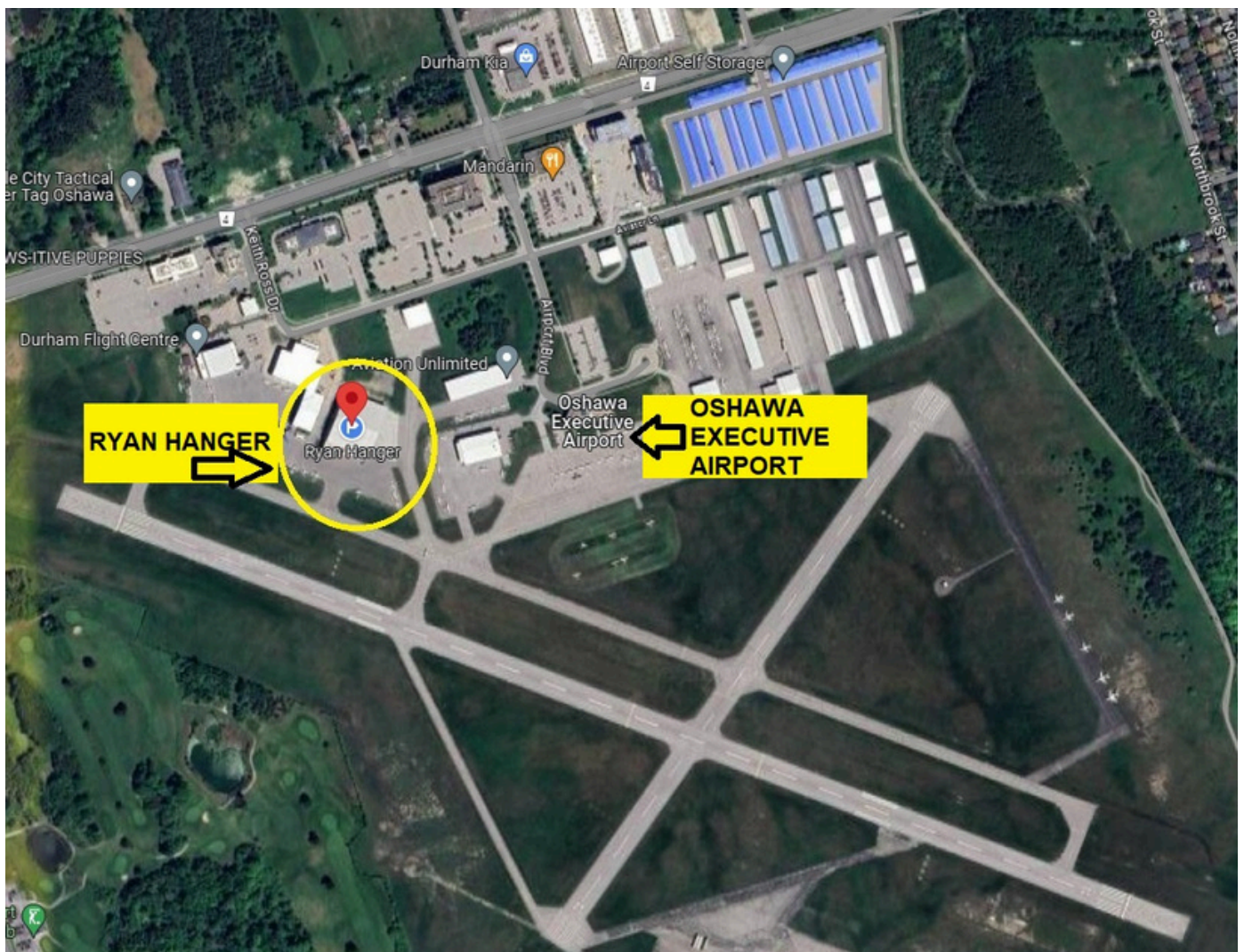
200 feet of heated hangar doors creating open span of up to 150' in width.



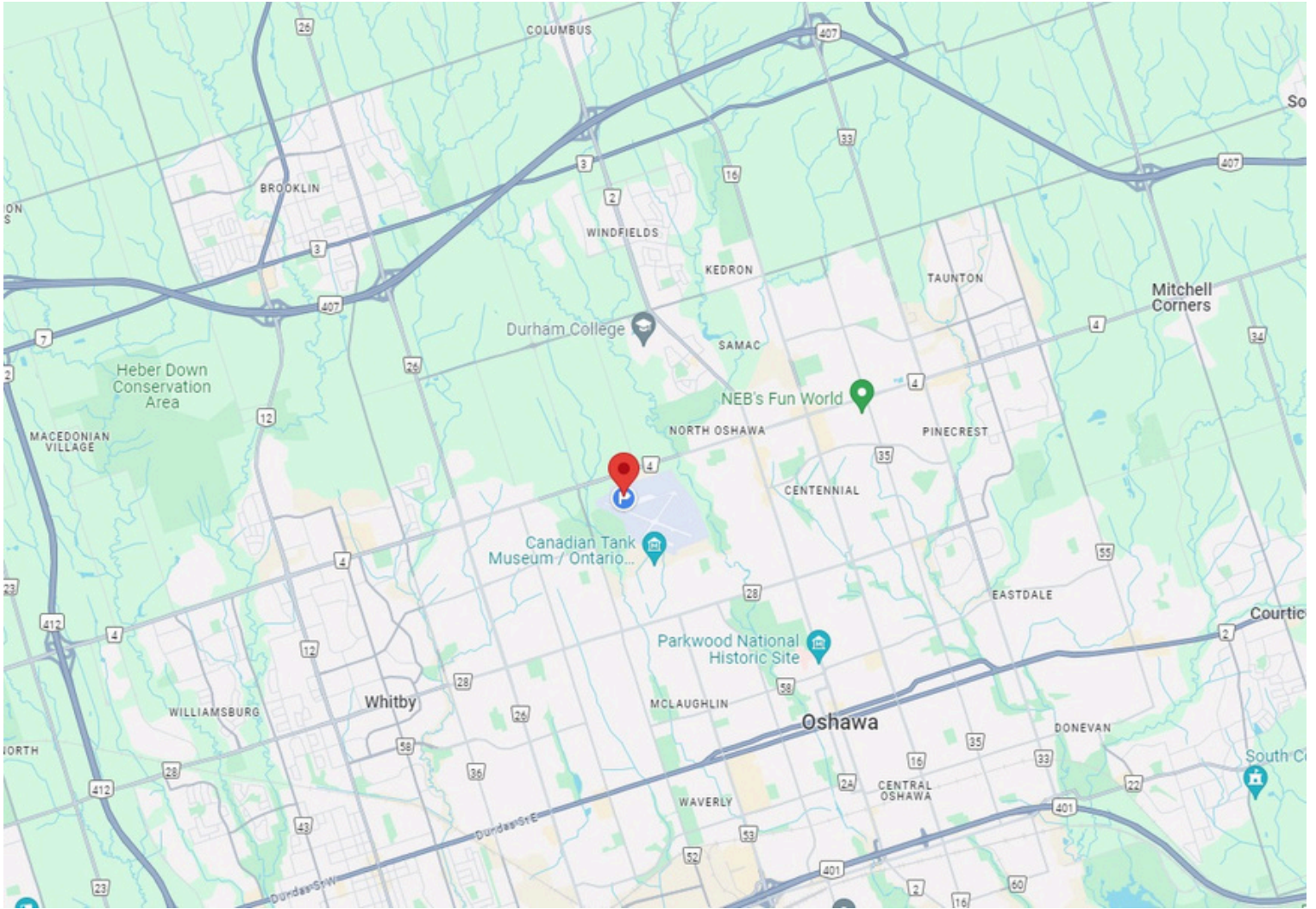
The Hangar has many possible uses in addition to being used for short and long term aircraft storage and a movie studio.
