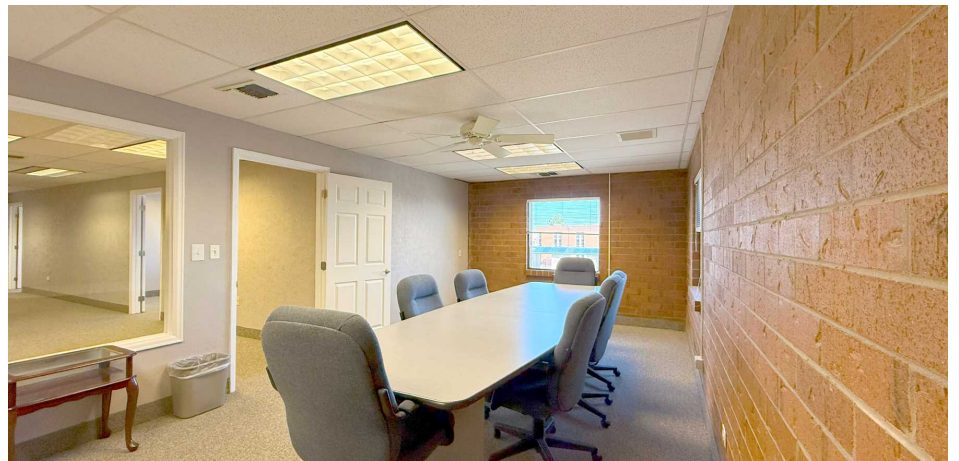

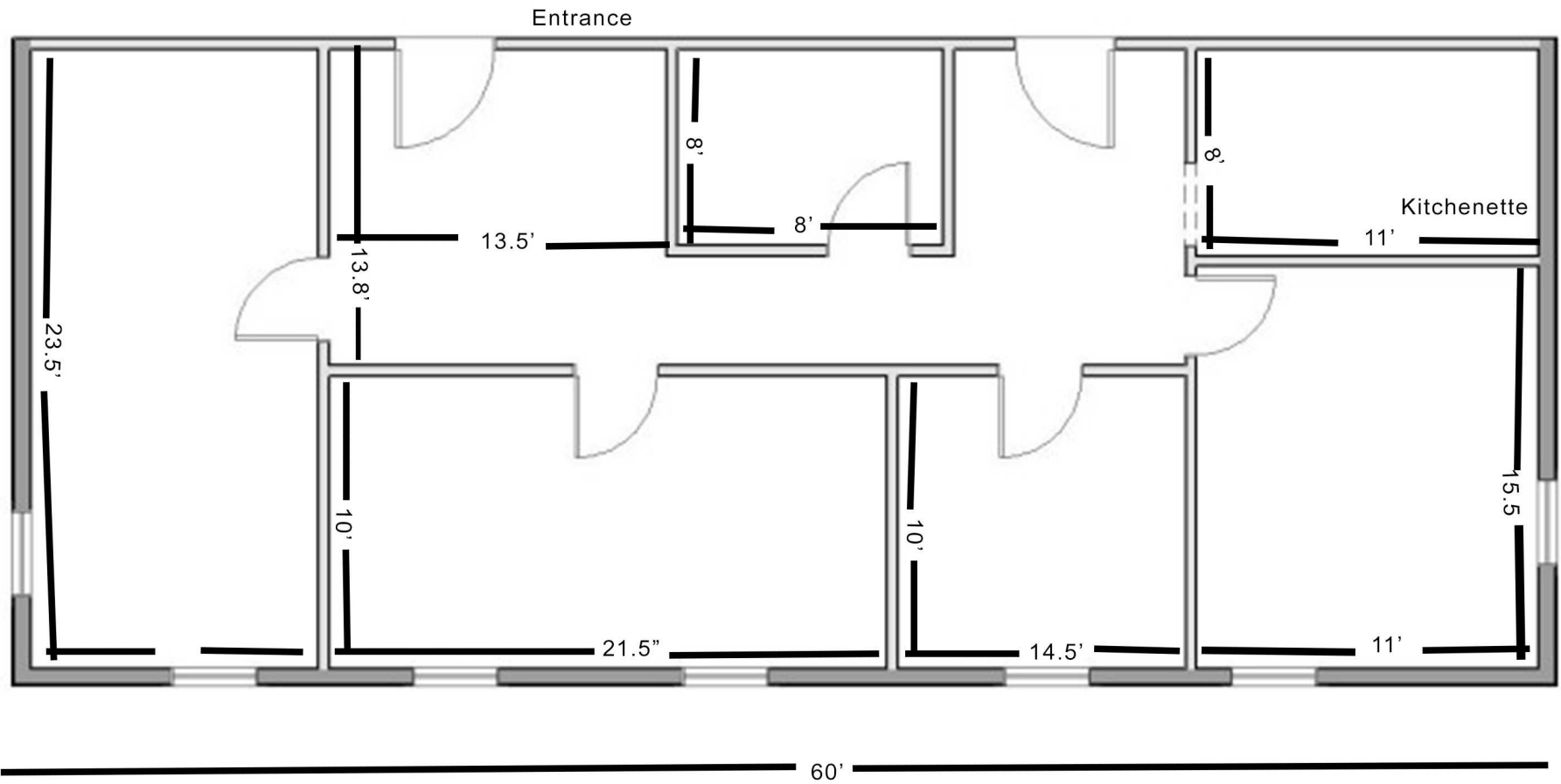


# FLOORPLAN

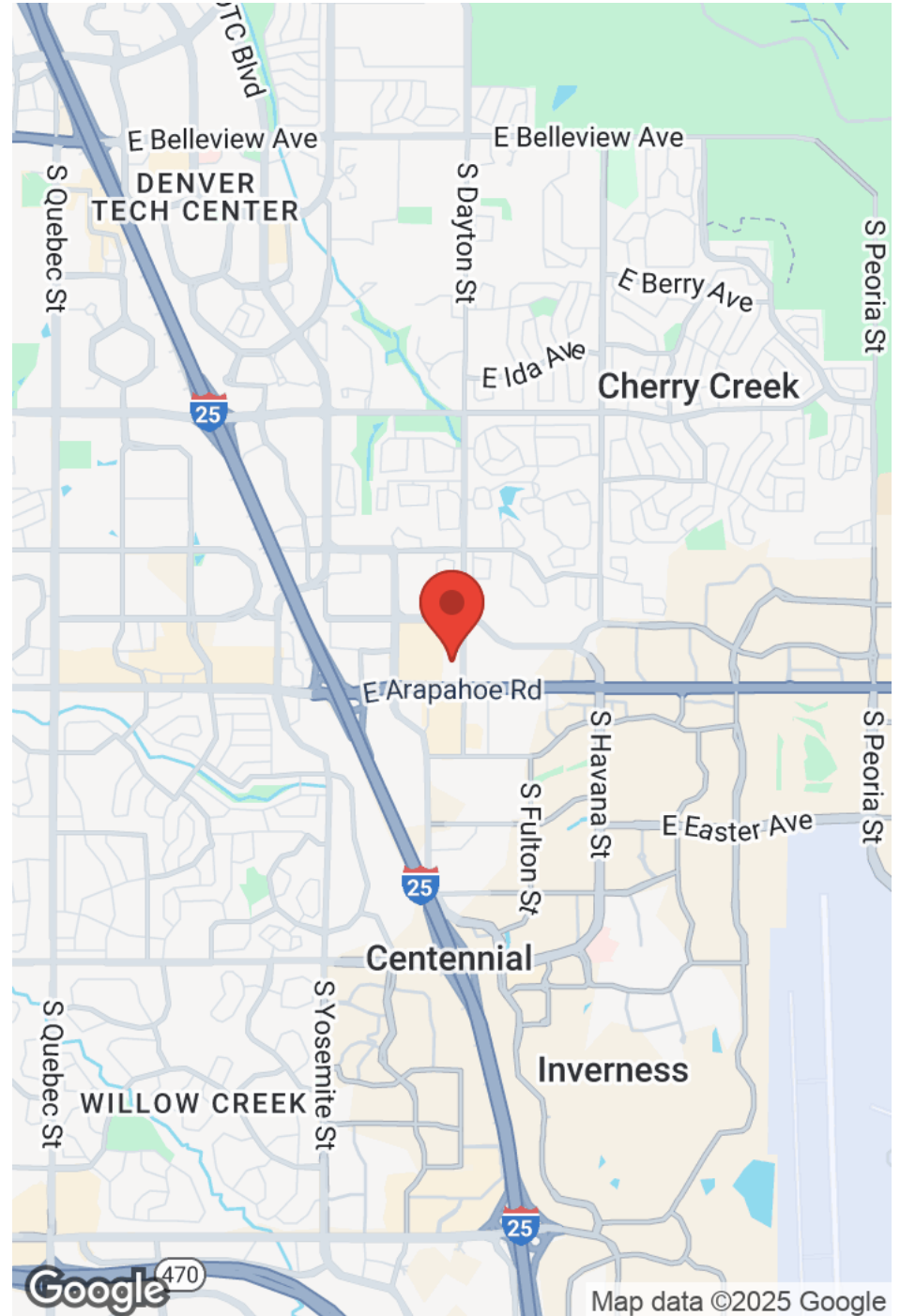
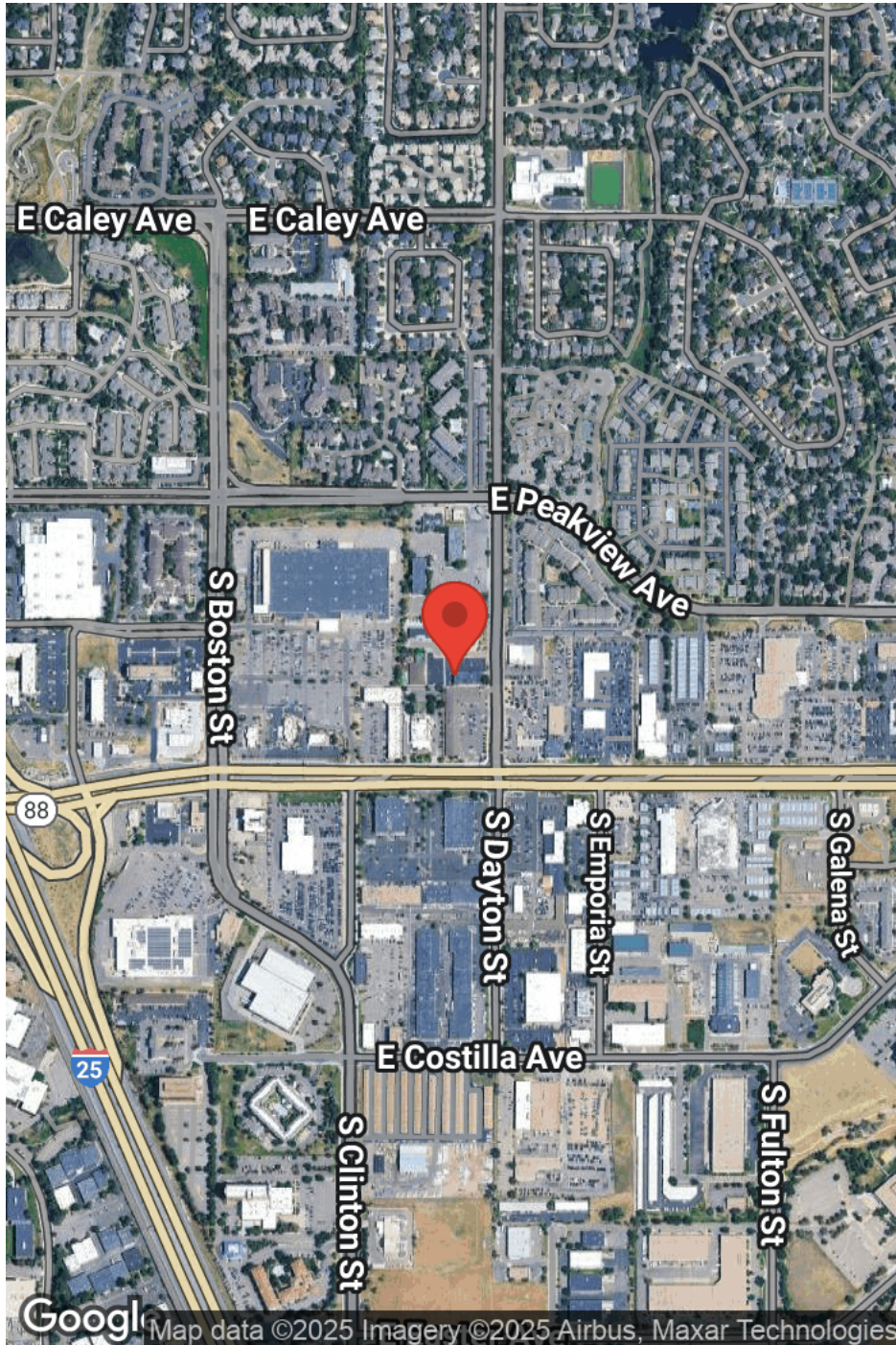

## LOCATION MAPS

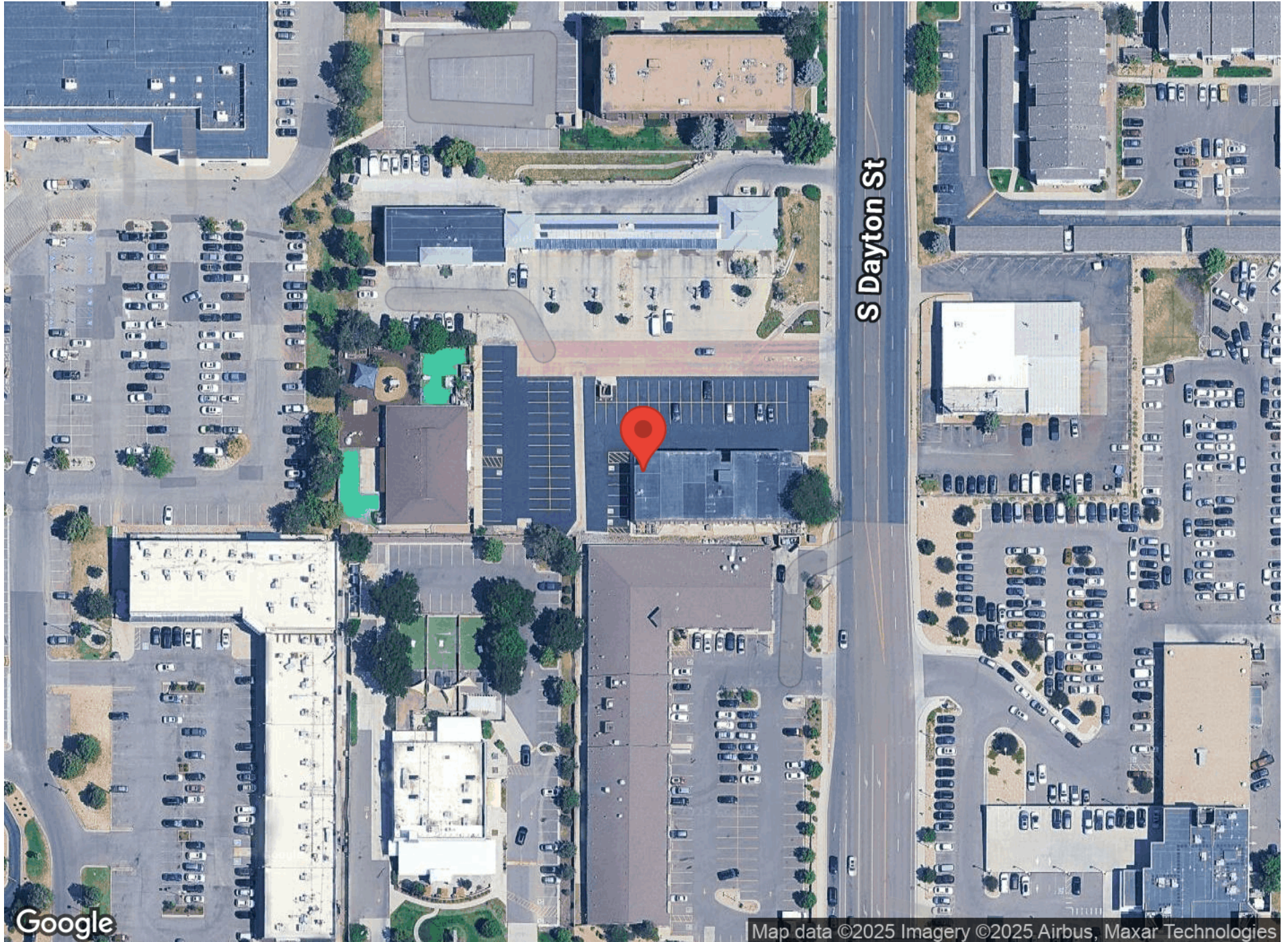

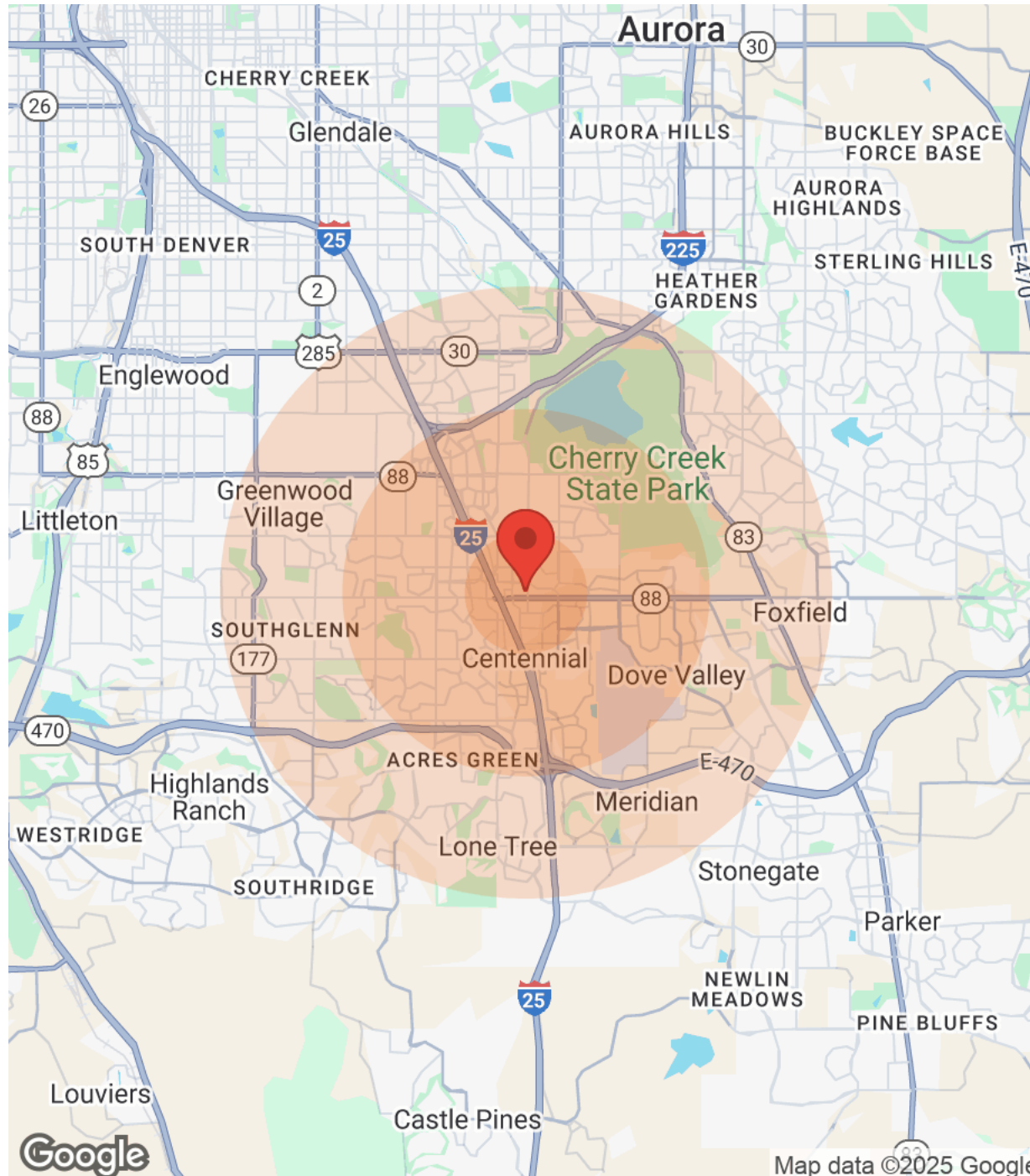
