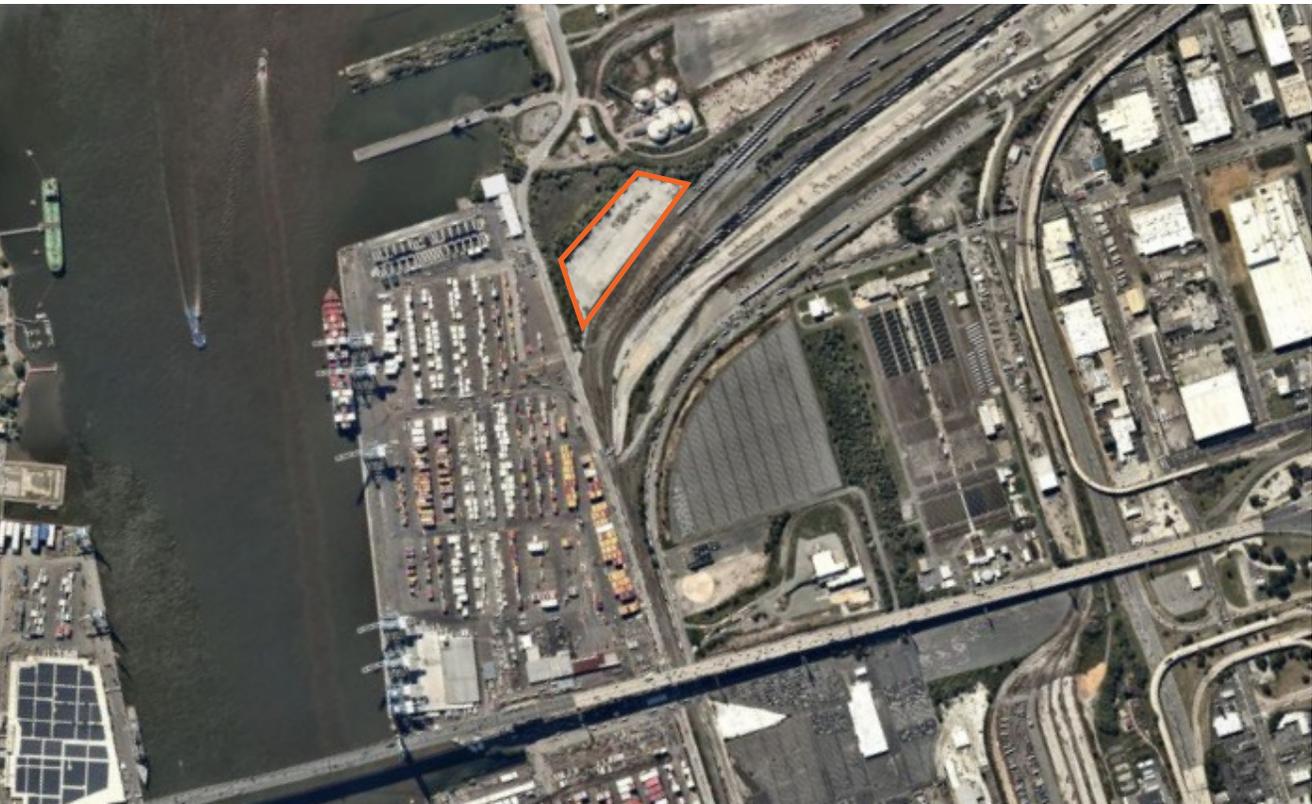
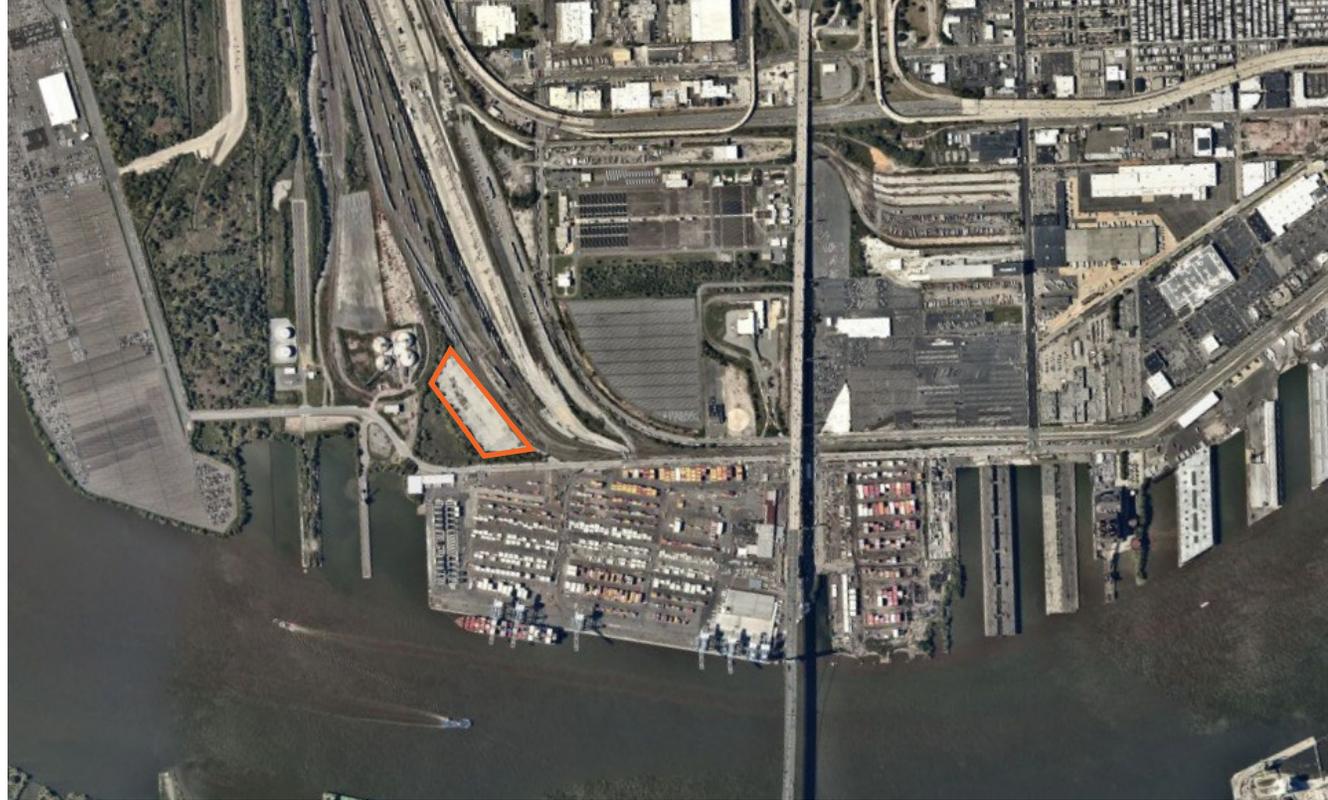
Regional Access Map
