Zoned industrial, the property offers visibility & positioning for a variety of commercial or industrial uses. Approximately 14 miles from Pinehurst, the site benefits from N.C. 211 AADT of 9,600 in front of the property & up to 11,500 at the intersection. N.C. 211—the primary route between Raeford & Aberdeen/Moore County—is undergoing upgrades to improve accessibility. The property consists of two parcels totaling an estimated +/- 2.44 acres, including Lot 1-B (+/- 0.17 acres) with a mobile home and the larger tract improved with an approximately 3,000 SF storage warehouse. 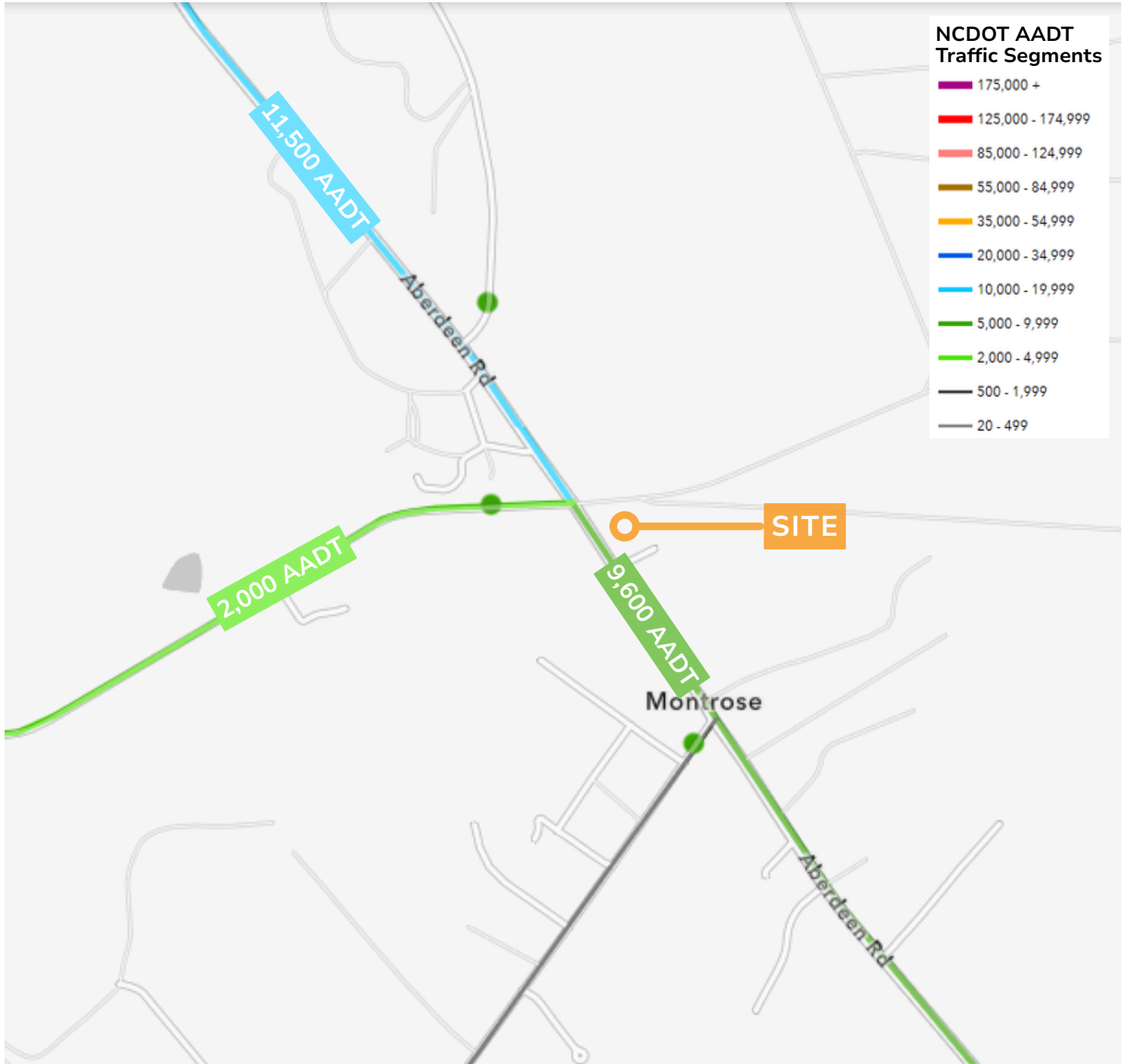

## TRAFFIC COUNTS

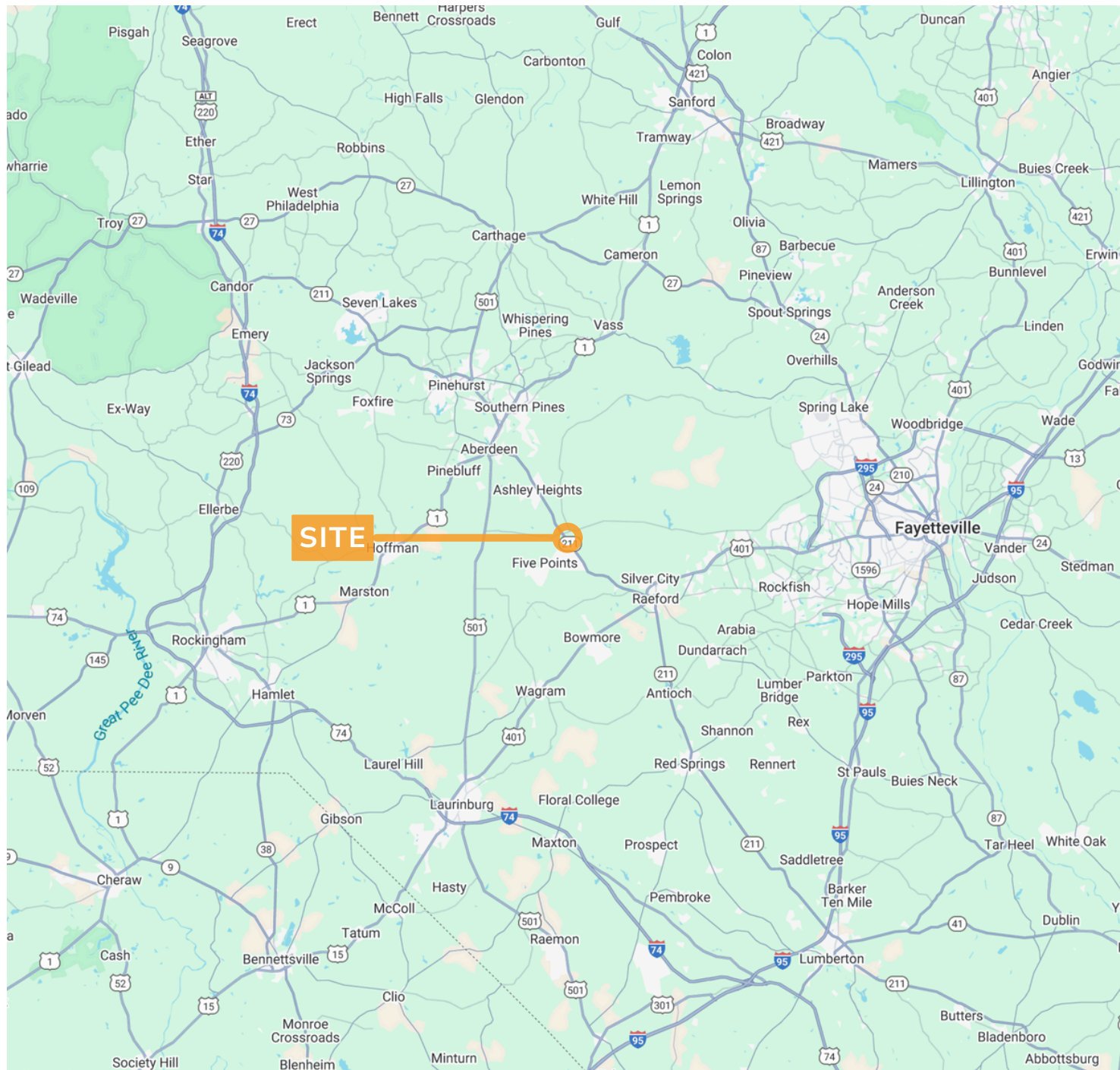
