

Executive Summary

Colliers is proud to exclusively present 1401 Ezell Street, a 90 bed long term acute care hospital located in Ruston, LA. This well maintained building is located just minutes from I-20 and blocks from downtown Ruston and Louisiana Tech University – Louisiana's second largest university as well as Grambling State University. This 2 story building presents a unique opportunity to treat a largely underserved market of patients with sub-acute needs or behavioral health disorders such as in-patient psychiatry, substance use disorders or primary Mental health.

The NW Louisiana corridor of Ruston/Shreveport/Monroe MSA contains over 1.2MM residents and a multitude of large companies and is home to Barksdale Air Force Base. This facility is well positioned to serve the NW Louisiana corridor with superior access to I-20 and is just 5 blocks from Northern Louisiana Medical Center. In addition to Louisiana Tech University, Ruston is also home to Grambling State University and is in close proximity to Northwestern State University of Louisiana, and University of Louisiana Monroe representing more than 27,000 college students within 80 miles.

Property Profile

The Ruston facility is a purpose-built inpatient rehab hospital that was completed in 1988 and converted to LTACH use in 1997. The facility contains two inpatient rehab gyms (inpatient and outpatient), an above-ground indoor therapy pool, an imaging suite, cafeteria with commerical kitchen, and other therapy rooms. The LTACH is adjacent to Northern Louisiana Medical Center, a Community Health Systems hospital. The medical campus is surrounded primarily by vacant land, commercial, and industrial facilities.






Floorplan - 2nd Floor

Ruston

Located in North Louisiana, Ruston & Lincoln Parish is known for its lively college-town atmosphere, 25-block historic downtown district, thriving arts culture, and scenic outdoor attractions.

Ochsner LSU Health - Monroe Medical Center is the largest hospital in Monroe. St Francis Medical Center serves the area as a Level 3 trauma center.


