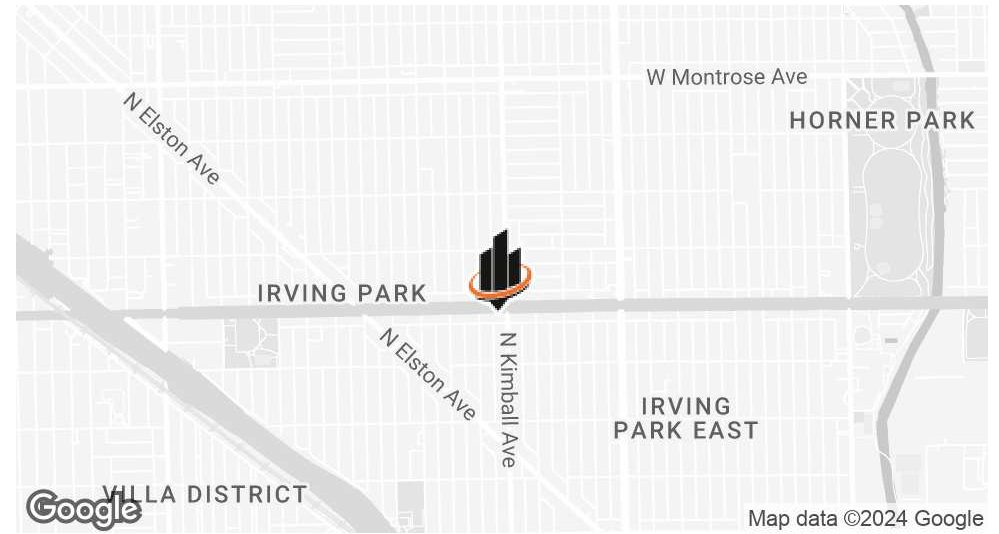

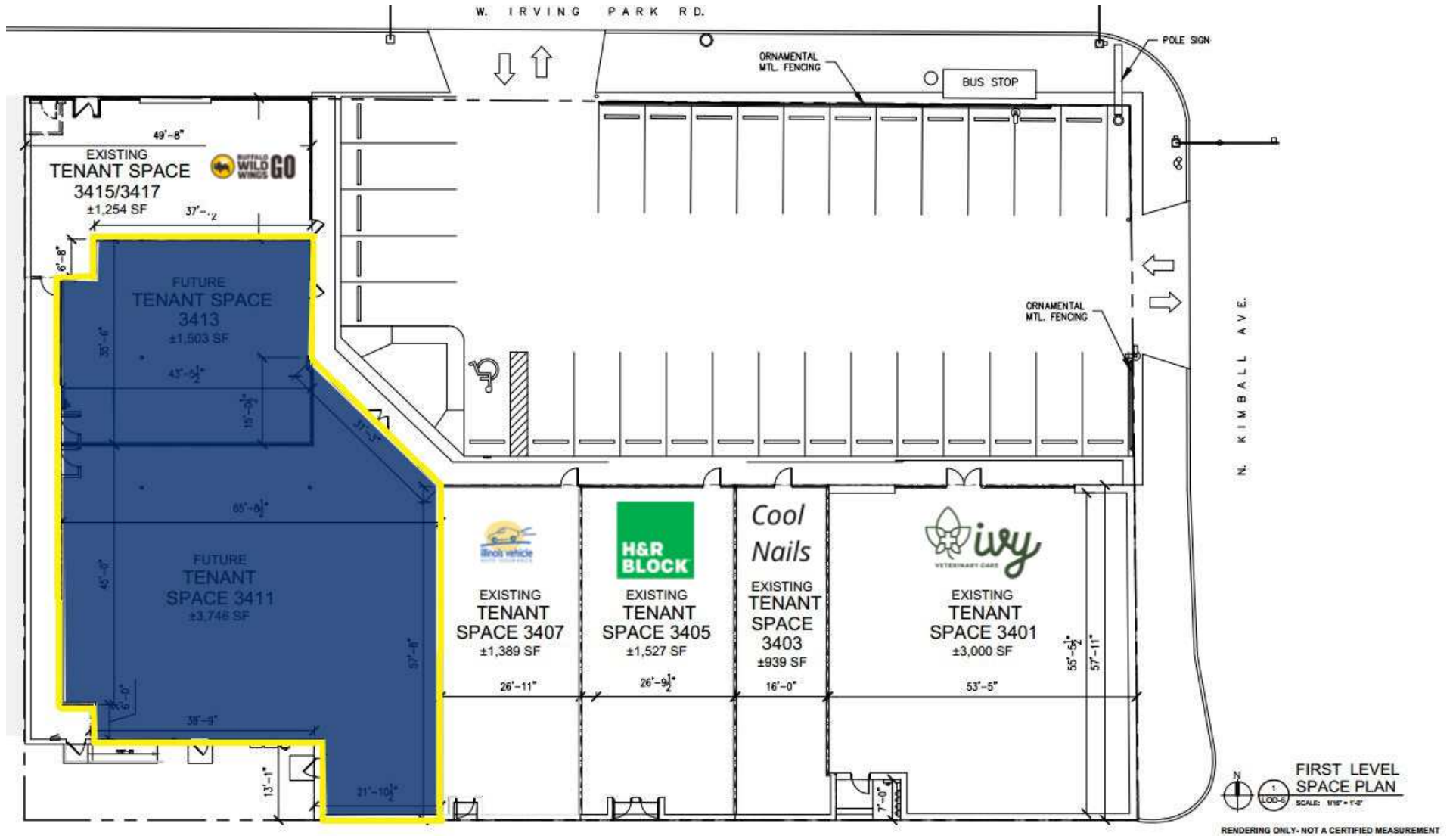

RETAIL AERIAL MAP

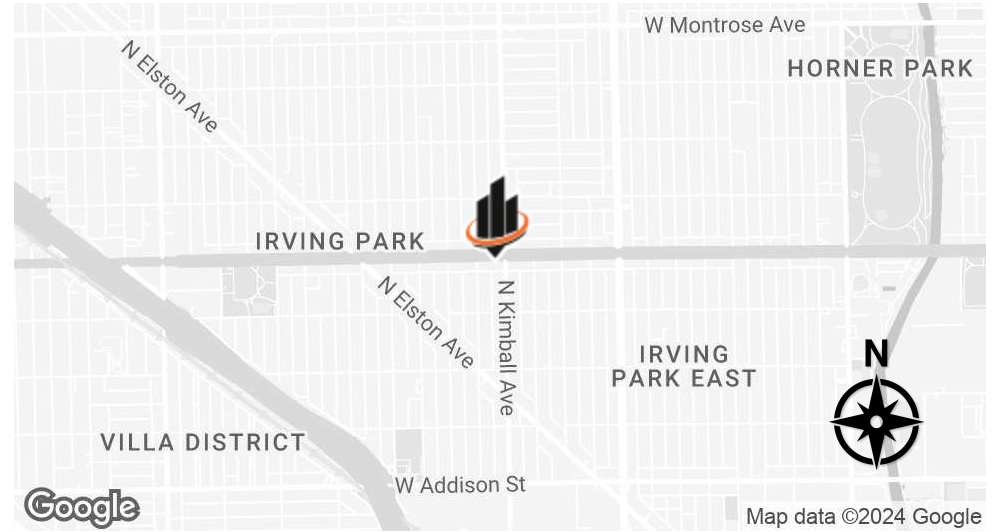
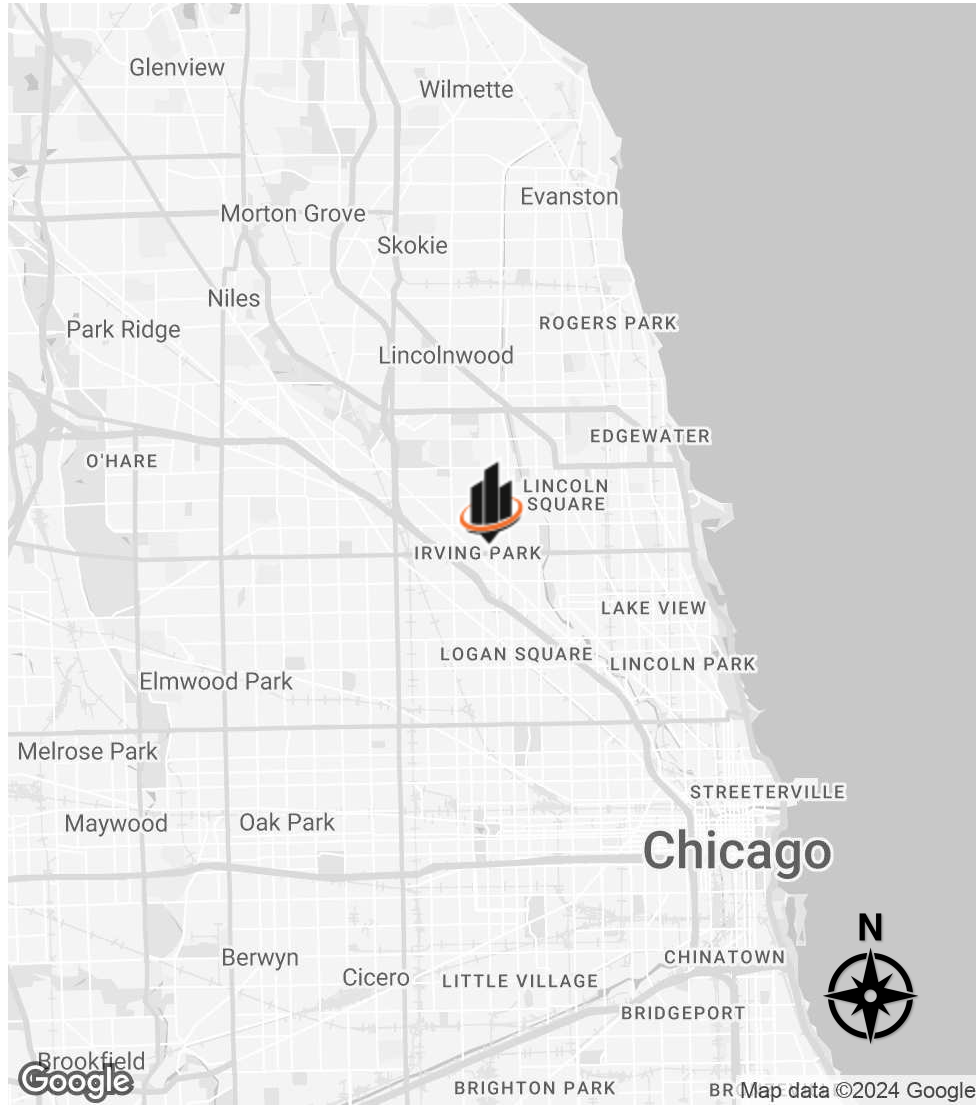

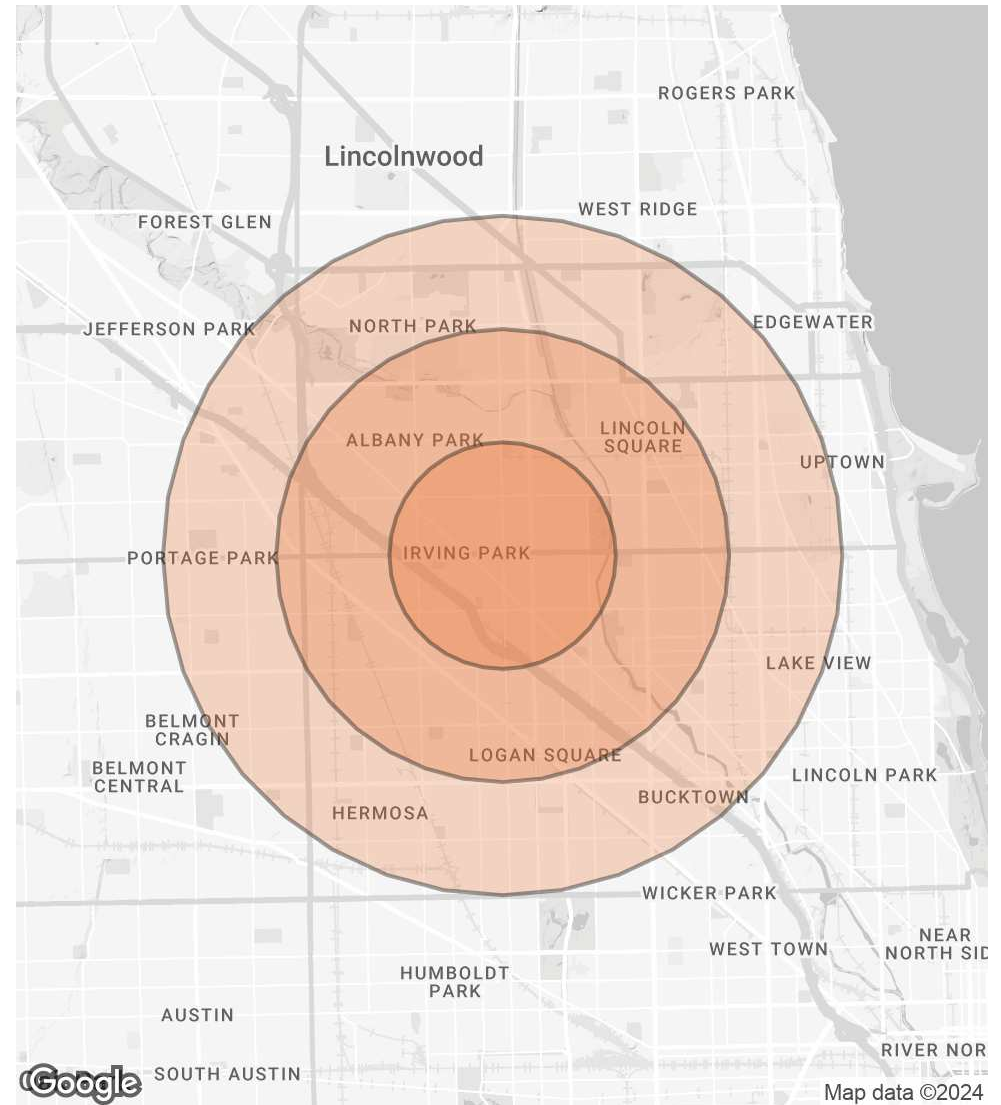
