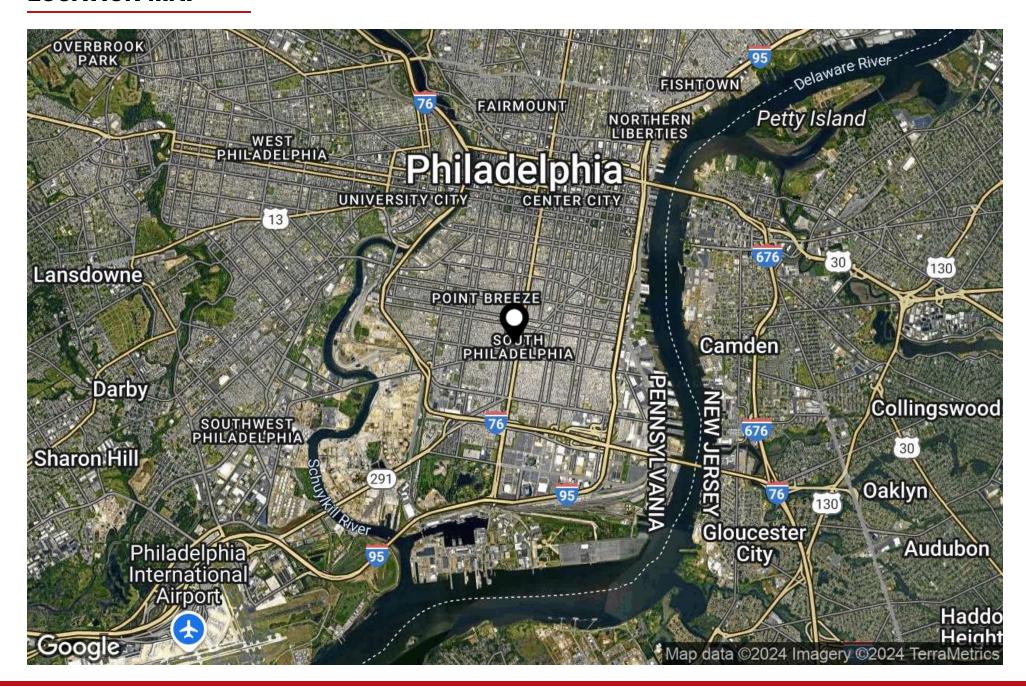


RETAILER MAP

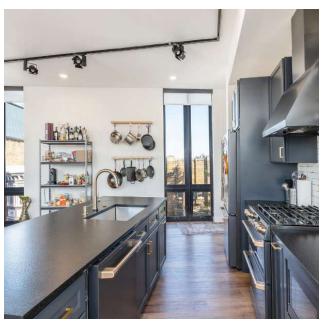
