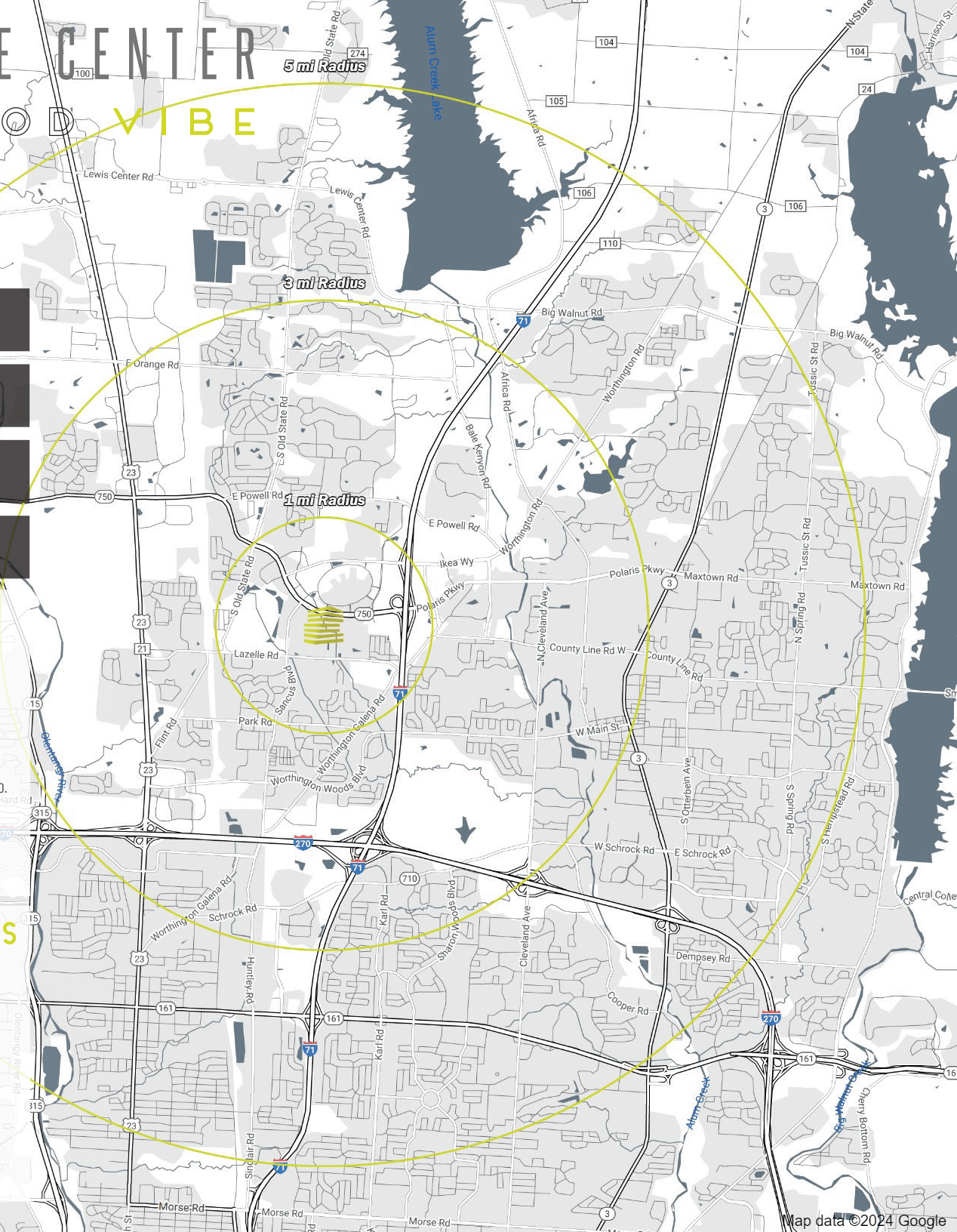

Located just north of Columbus, the Polaris area is a bustling shopping hub frequented by Columbus residents and visitors. It is located in southern Delaware County, one of Ohio's fastest growing counties. The area is home to stores selling everything from groceries to beauty products to home furniture, as well as plenty of local and chain dining options, and an interactive art space, Lighthouse Immersive.

Also located in the Polaris area is the McCoy Center, an office campus acquired by JPMorgan Chase in 2004. The facility—¼ mile from end to end—houses approximately 13,000 employees in a space equal in square footage to the Empire State Building. At 2 million square feet, it is the largest JPMorgan Chase & Co. facility in the world, the largest office building in the Columbus MSA, and the second largest single-tenant office building in the United States behind The Pentagon.

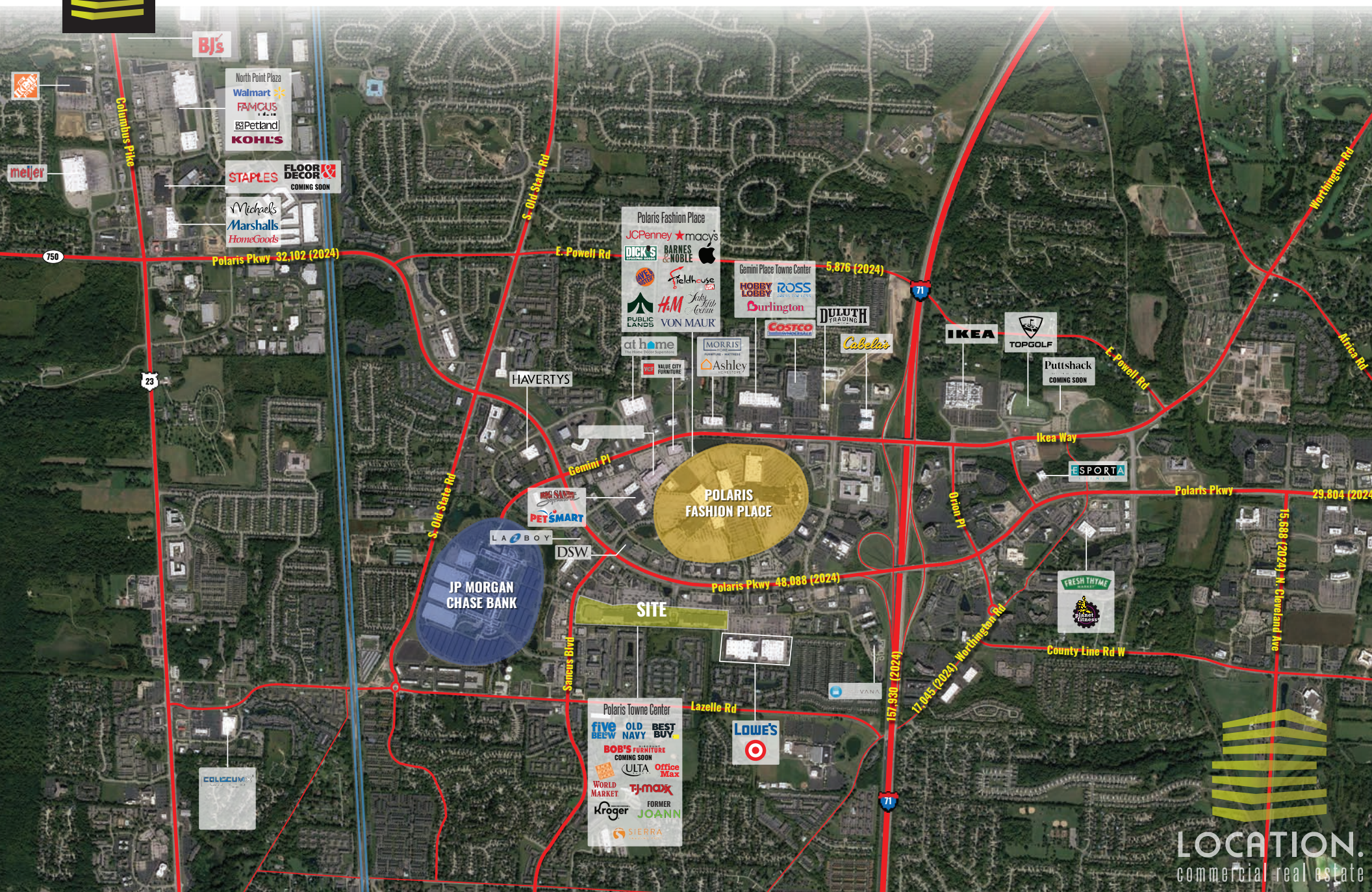
