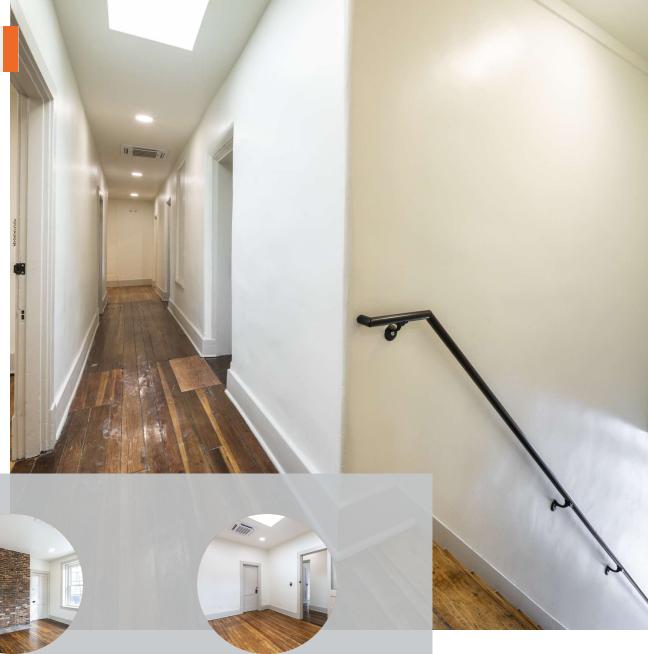

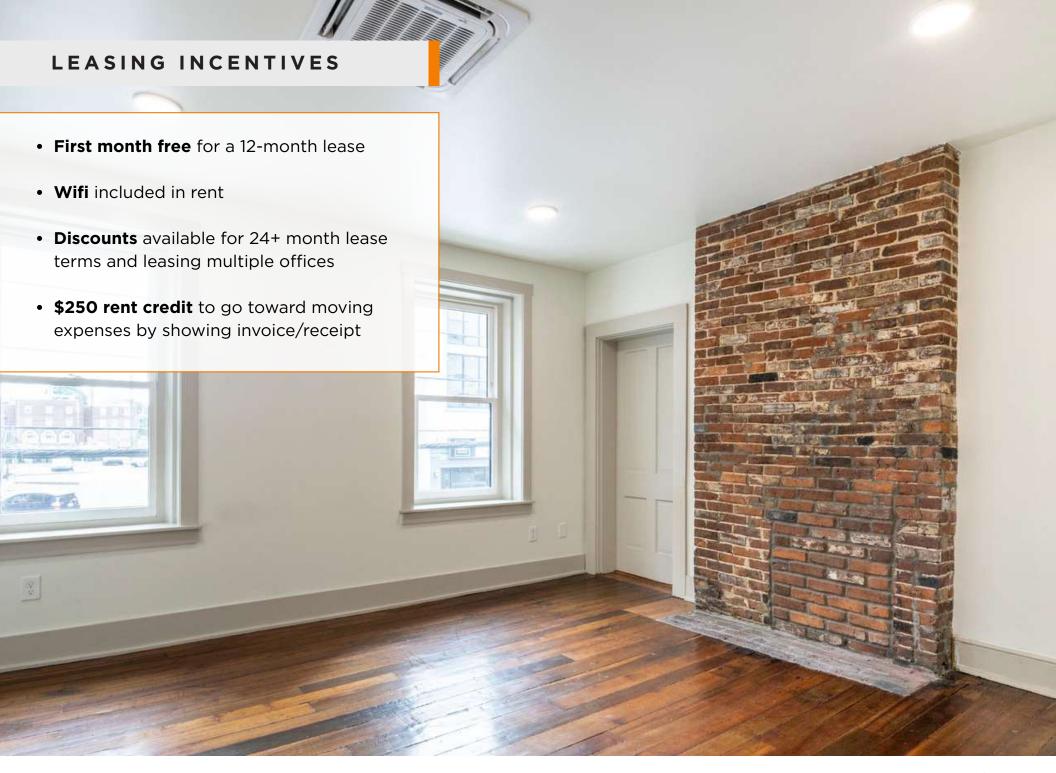
Hardwood Floors

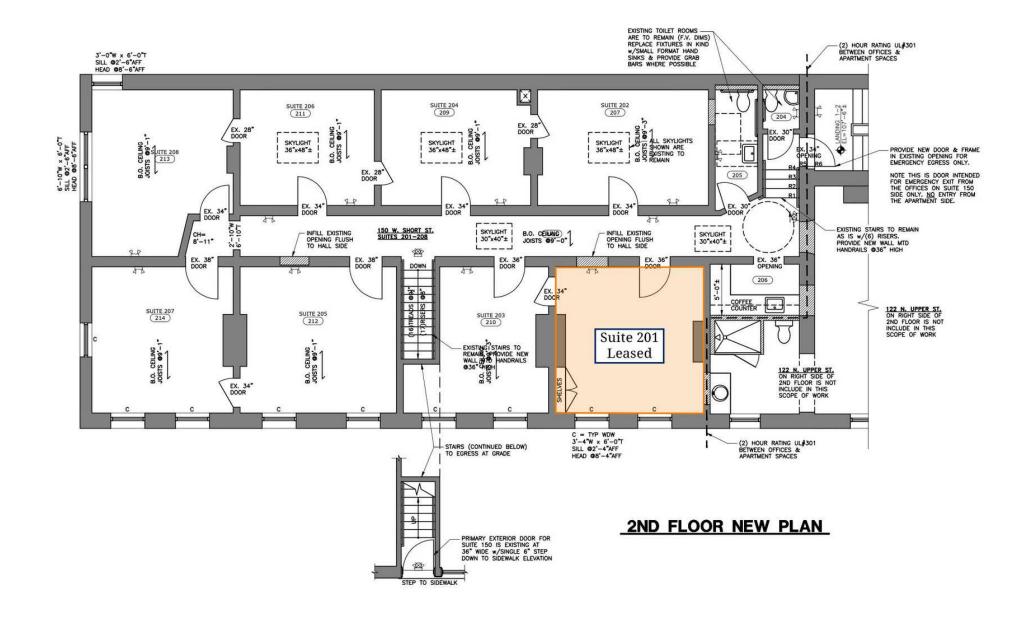








FLOOR PLAN
