PROPERTY DESCRIPTION

South Bay Marketplace is located in the Heart of the South Bay's very own Redondo Beach. The development fronts Hawthorne Blvd, one of the highest traveled north/south arterials in the south western region of Los Angeles County, and consists of approximately 117,858 square feet of retail/commercial space. South Bay Marketplace is a half a mile from the Hawthorne Boulevard interchange of Interstate 405, one of the most heavily traveled freeways in the nation. In addition to the property's anchors (Nordstrom Rack, Sprouts, Total Wine and ULTA), which represent 80% of the shopping center, South Bay Marketplace is shadowed by Living Spaces and adjacent to a Target and Ralph's grocer.

SOUTH BAY GALLERIA

Adjacent to the Development is the South Bay Galleria a 955,000-square foot, three-level enclosed regional mall (anchored by Macy's, Kohl's and AMC).

This 30-acre property was recently acquired by Australian Investment Company QIC, and will feature a 150-room hotel, 300 apartments, and an additional 217,000 sq ft of office and retail scheduled to break ground in 2020.



AREA DESCRIPTION

South Bay Marketplace is situated in a part of the southwest region of Los Angeles County known as the South Bay. Located in North Redondo Beach, bordering such cities as Torrance, Manhattan Beach, Hermosa Beach, Lawndale and Hawthorne, South Bay Marketplace is surrounded by both the most affluent and culturally diverse neighborhoods in Los Angeles. The beach cities and the Palos Verdes Peninsula have strong demographics, with Manhattan Beach and Palos Verdes ranking as two of the wealthiest communities in the United States. Torrance is the sixth largest city in Los Angeles County and boasts a healthy and competitive commercial and economic presence in Los Angeles County.


