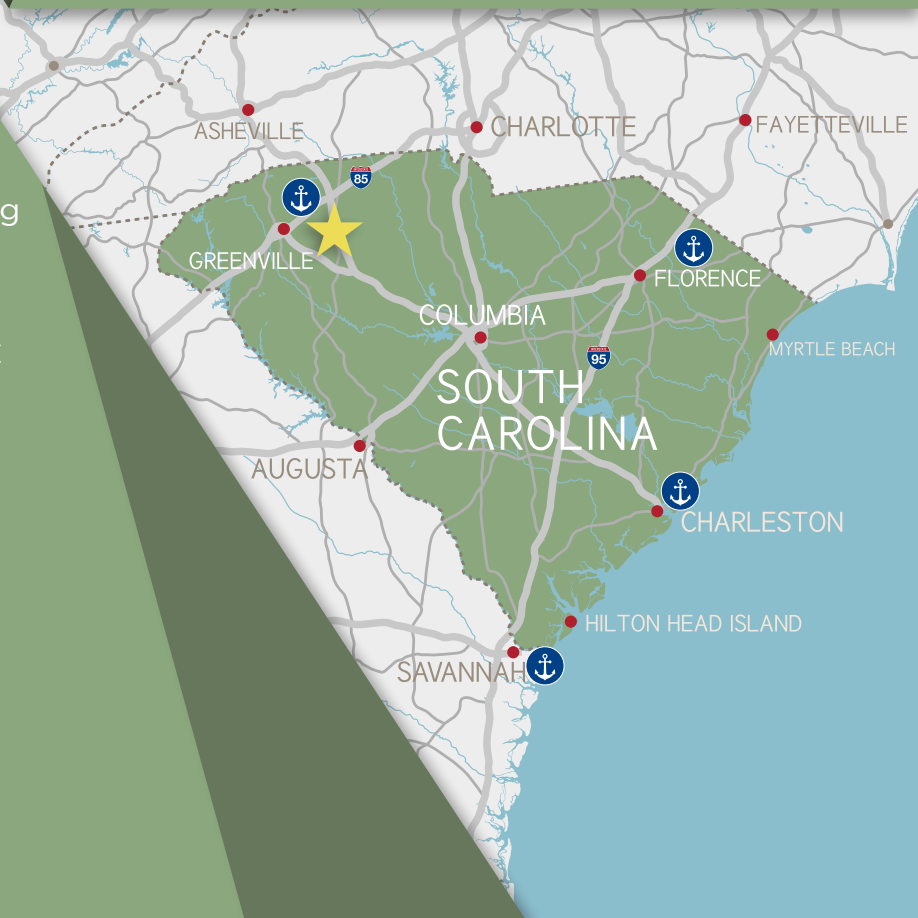

### CONCEPTUAL SITE PLAN

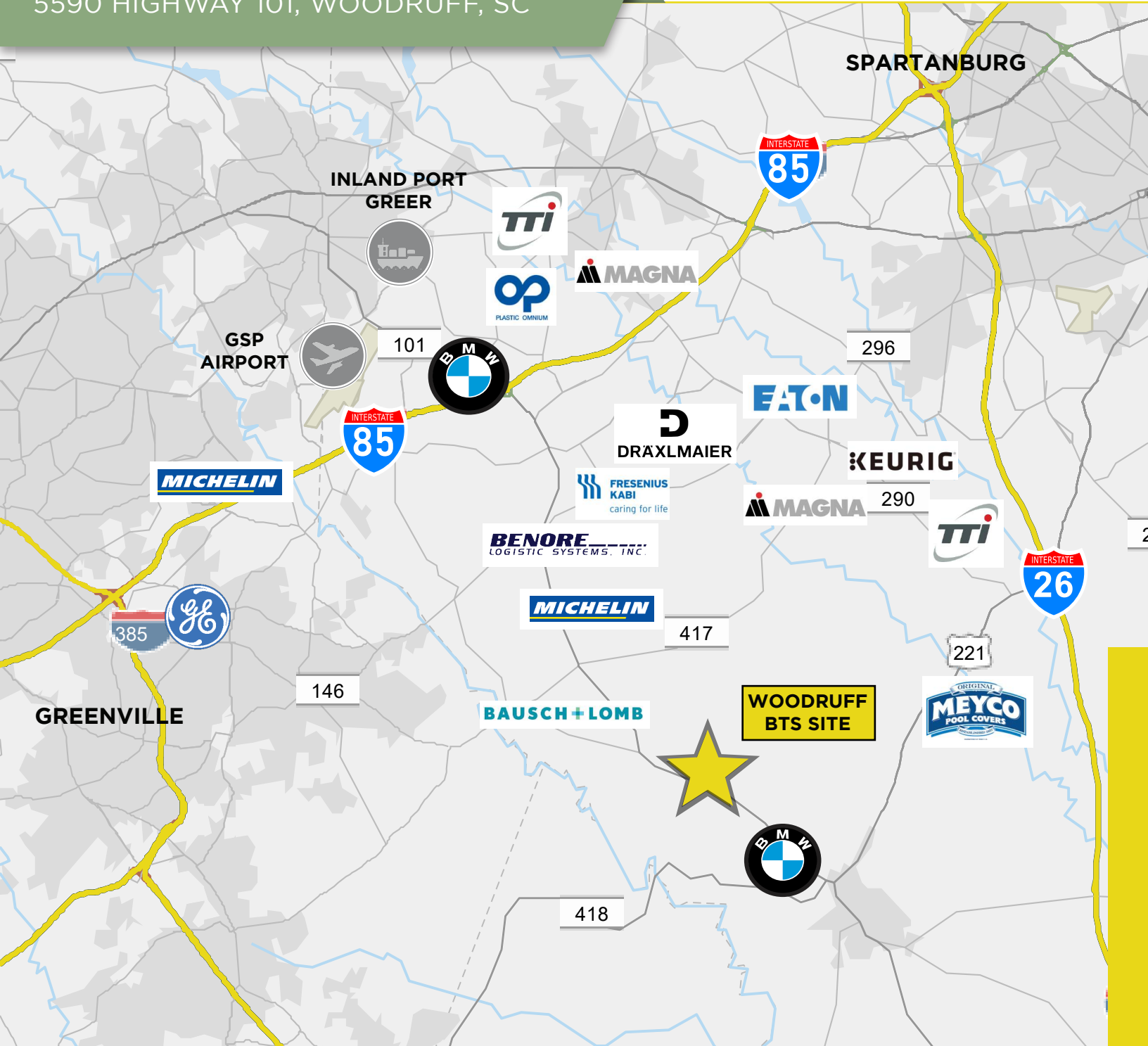

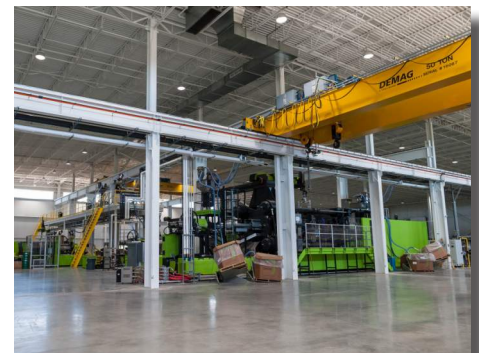
