

The surrounding area is seeing a massive amount of ongoing investment including the City's "ROC The Riverway" which brought \$15 million in upgrades to the attached garage, rooftop park and pedestrian bridge. 2024 also saw the arrival of Constellation Brands 170,000 sf world headquarters directly across Main Street. First Federal Plaza is now being offered for sale at a price of \$10.8 million.
