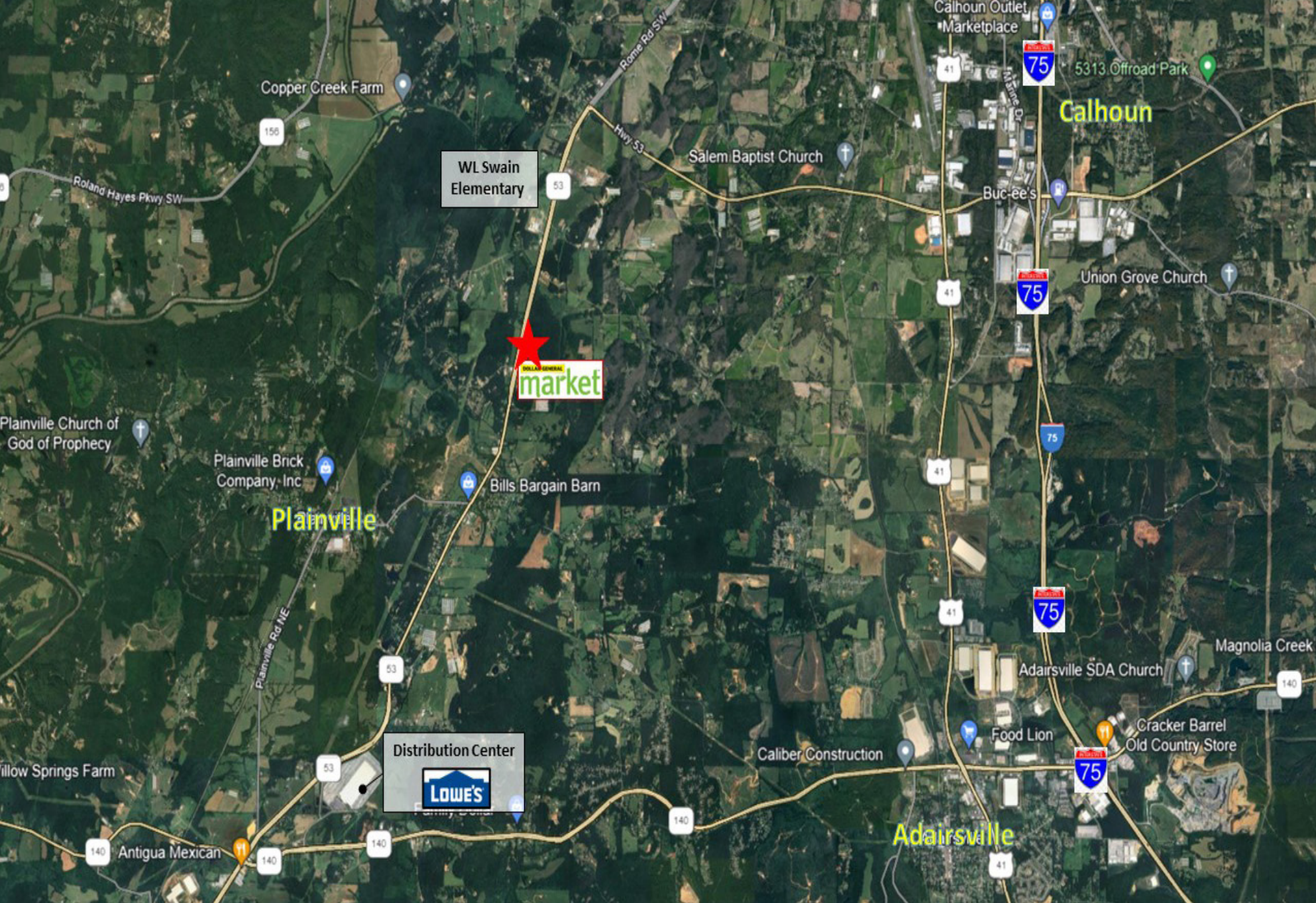

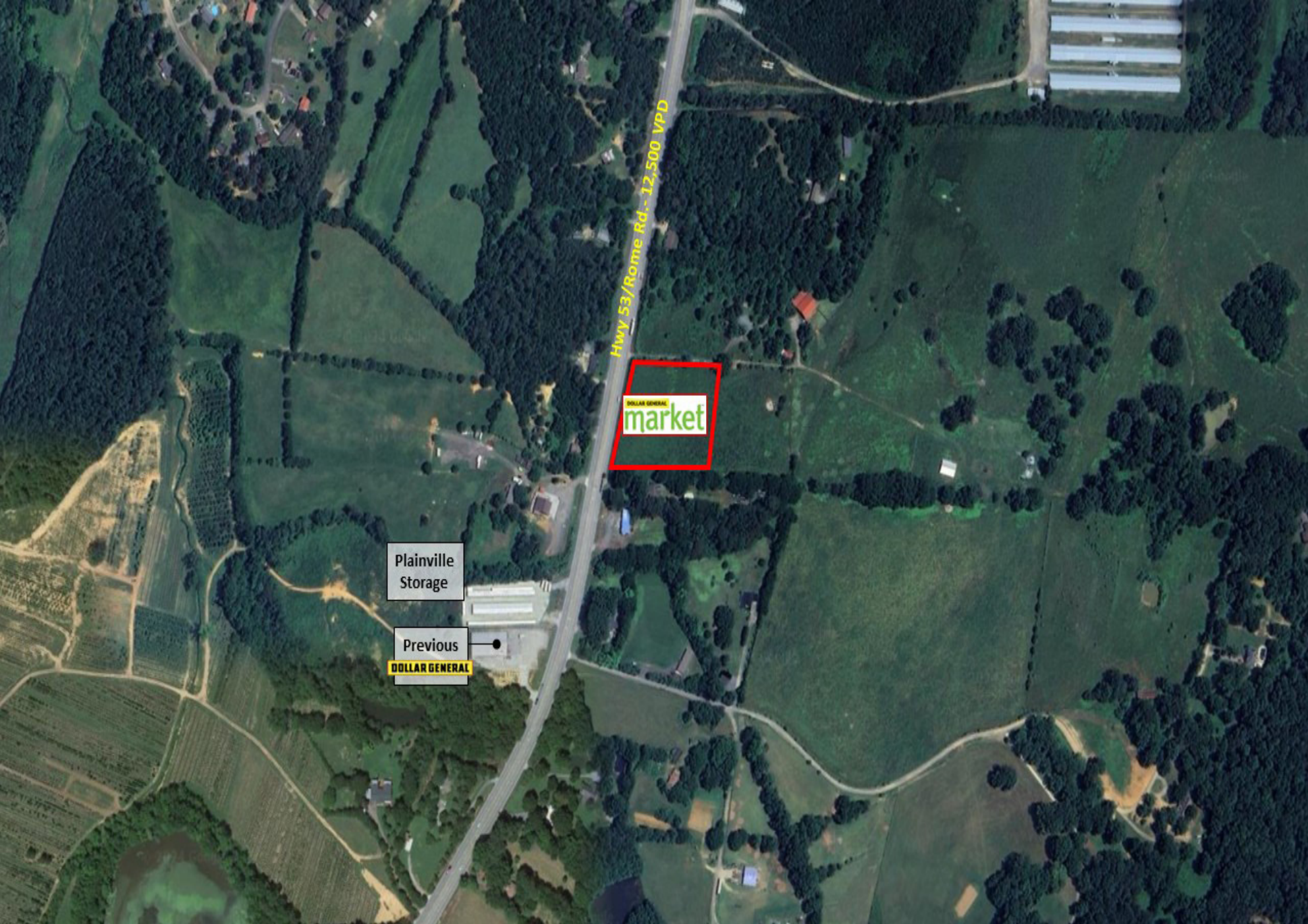

Plainville is located in southwestern Gordon County. The southern border of the town is the Floyd County line. Georgia State Highway 53 passes 1.5 miles east of the city, leading northeast 8 miles to Calhoun, the Gordon County seat, and southwest 14 miles to Rome. Plainville is situated in the Ridge-and-Valley region of northwest Georgia, about 3 miles east of a bend in the Oostanaula River, an area known as "the Bend". Atlanta, GA is located 70 miles south of Plainville and 7 miles from Interstate 75.
