Field Note description for a 4.283 acre tract being located in the DON THOMAS QUEVADO GRANT Section 27, Abstract No. 18, and being all of the same land a called 4.946 acre tract Less & Except 0.656 acres as conveyed to J & K Properties as described and recorded in Document Number 2011 1.00014381 of the Deed Records of Smith County, Texas, Said 4.283 acre tract to be more particularly described as follows.

Bearings are based on the State Plane Coordinate System, Texas North Central Zone 4202, N.A.D. 1983.

BEGINNING at a ½" iron rod found for the Southeast corner of herein described tract, same point being the Northeast corner of a called 5.943 are: tract conveyed to losel D. Donner et ux Kimberly A. as described and recorded in Documen Number 2014-28876 of the Deed Records of Smith Courty, Texas, same point being on the West line of Highway 155 S.;

THENCE North 71º21'43" West along and with the North line of said called 5.943 acre tract a distance of 707.00 feet to a conton spindle set for corner in C.R. 1100, same point being the Northwest corner of said called 5.943 acre tract, same point having a ½" iron rod found for reference at South 71º1'4'. Past a distance of 25.25 feet, THENCE North 01°39'26" West along and with C.R. 1100 a distance of 16.04.1 feet to a cotton spindle found for corner in C.R. 1100, same point being the Southwest corner of a called 0.656 acre tract conveyed to Marcelino Arredondo et al as described and recorded in Document Number 2009-42206 of the Deed Records of Smith Courny,

THENCE North 87'36'05" East along and with the South line of said called 0.656 acre tract passing a ½" iron rod set for reference at a distance of 21.59 feet and continuing on a total distance of 171.15 feet to a ½" iron rod found for corner, same point being the Southeast corner of said called 0.656 acre tract;

THENCE North (0°23'38" West along and with the East line of said called 0.656 acre tract a distance of 135.15 feet to a ½" from rod set for corner, same point being the Northeast corner of said called 0.656 acre tract, same point being on the South line of a called 6.097 acre tract conveyed to Ruby J. Haralson as described and recorded in Volume 2548 Page 286 of the Deed Records of Smith County, Texas:

"THENCE South 71"20"22" East along and with the South line of said called 6.097 acre tract a distance of 352.19 free to a 3" from pipe found for corner, same point being on the South line of said called 6.097 acre tract, same point being the Northwest corner of a called 1.053 acre tract conveyed to Cole FD Portfolio III, LLC as described and recorded in Document Number 2012-20428 of the Deed Records of Smith County, Texas:

THENCE South 18°45'34" West along and with the West line of said called 1.033 acre tract a distance of 149.92 feet to a 3" iron pipe found for corner;

THENCE South 71°13°56" East along and with the South line of said called 1.033 acre tract a distance of 299.51 feet to a 3" tron pipe found for corner, same point being the Southeast corner of said called 1.033 acre tract, same point being on the West line of Hwy 1.55 S.;

THENCE South 18°37'59" West along and with the West line of Hwy 155 S a distance of 187.47 feet back to the PLACE OF BEGINNING and containing 4.283 scress of land.
