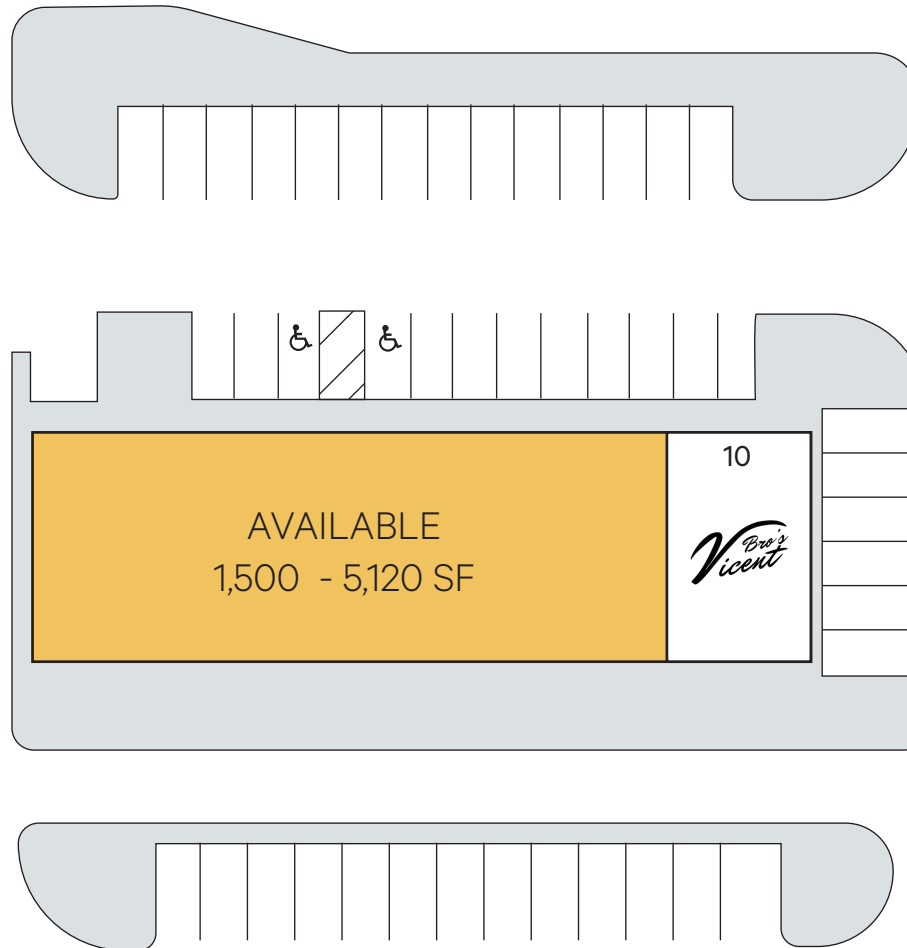

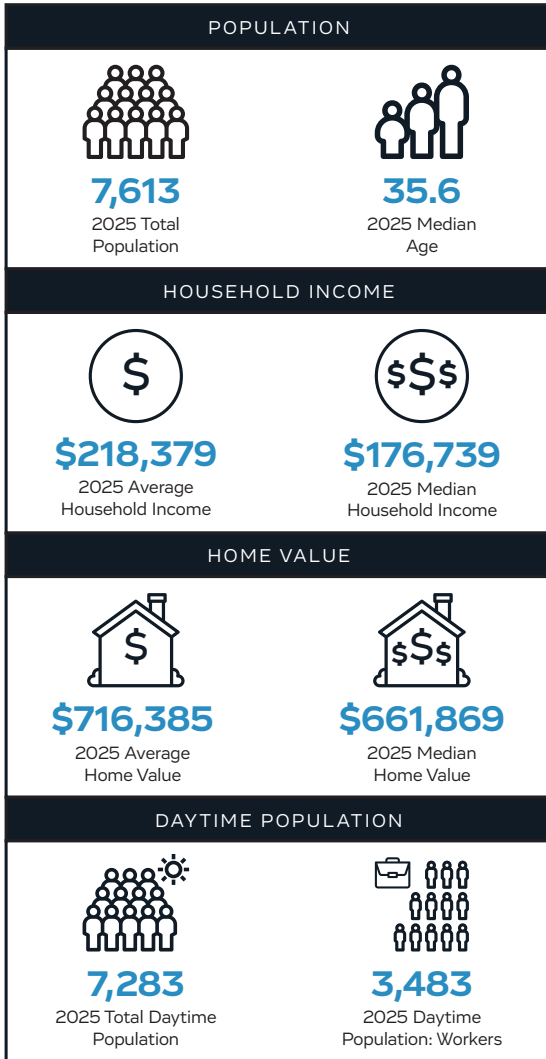

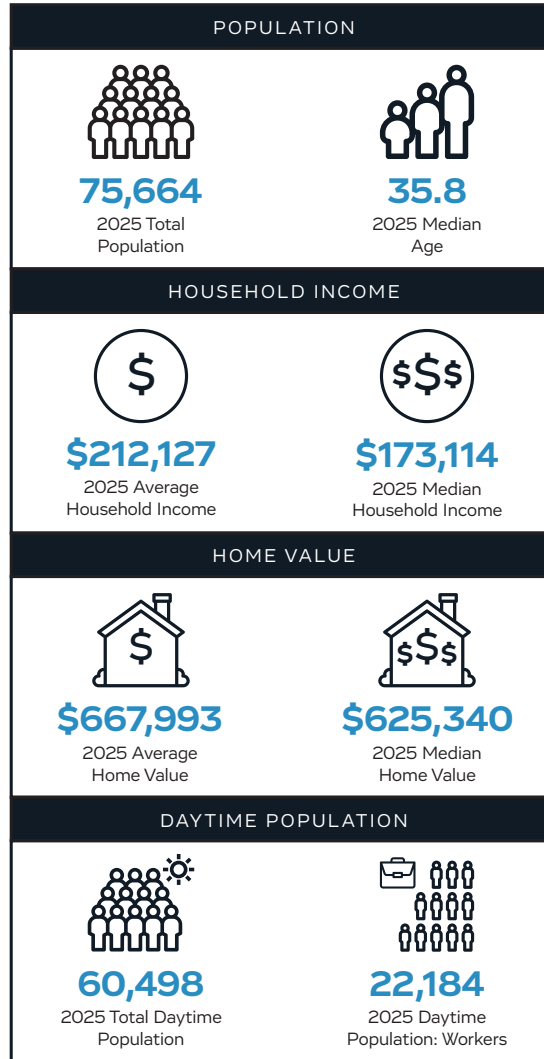

DEMOGRAPHICS

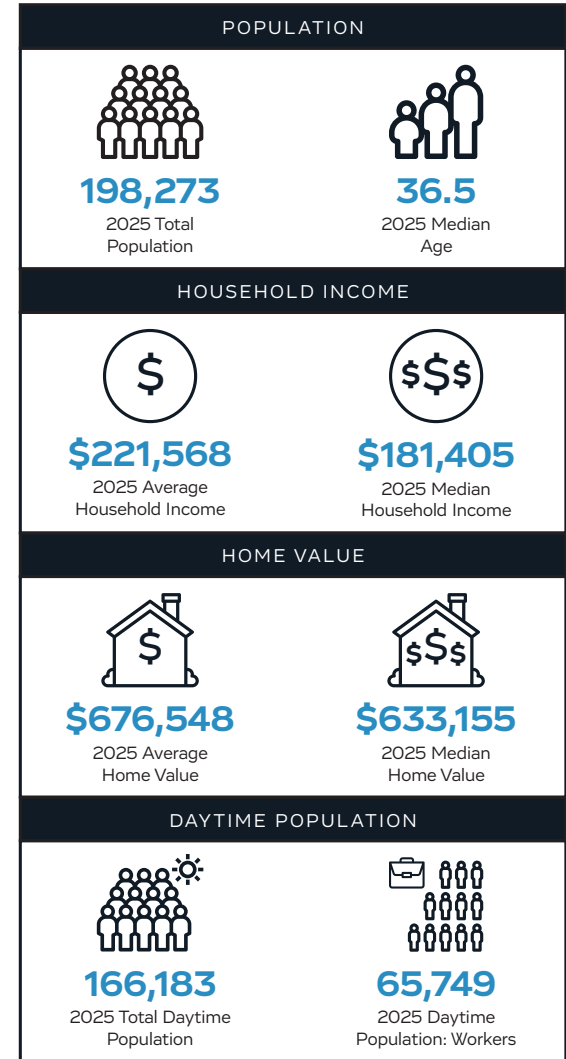
