A temporary easement for the purpose of constructing a water line in the right-of-way of Two Notch Road beginning at the southern property line of said lot and extending parallel and adjacent to the right-of-way of Two Notch Road for a distance of two hundred twenty (220) feet to the northern property line of said lot, be all measurements a little more or less.


