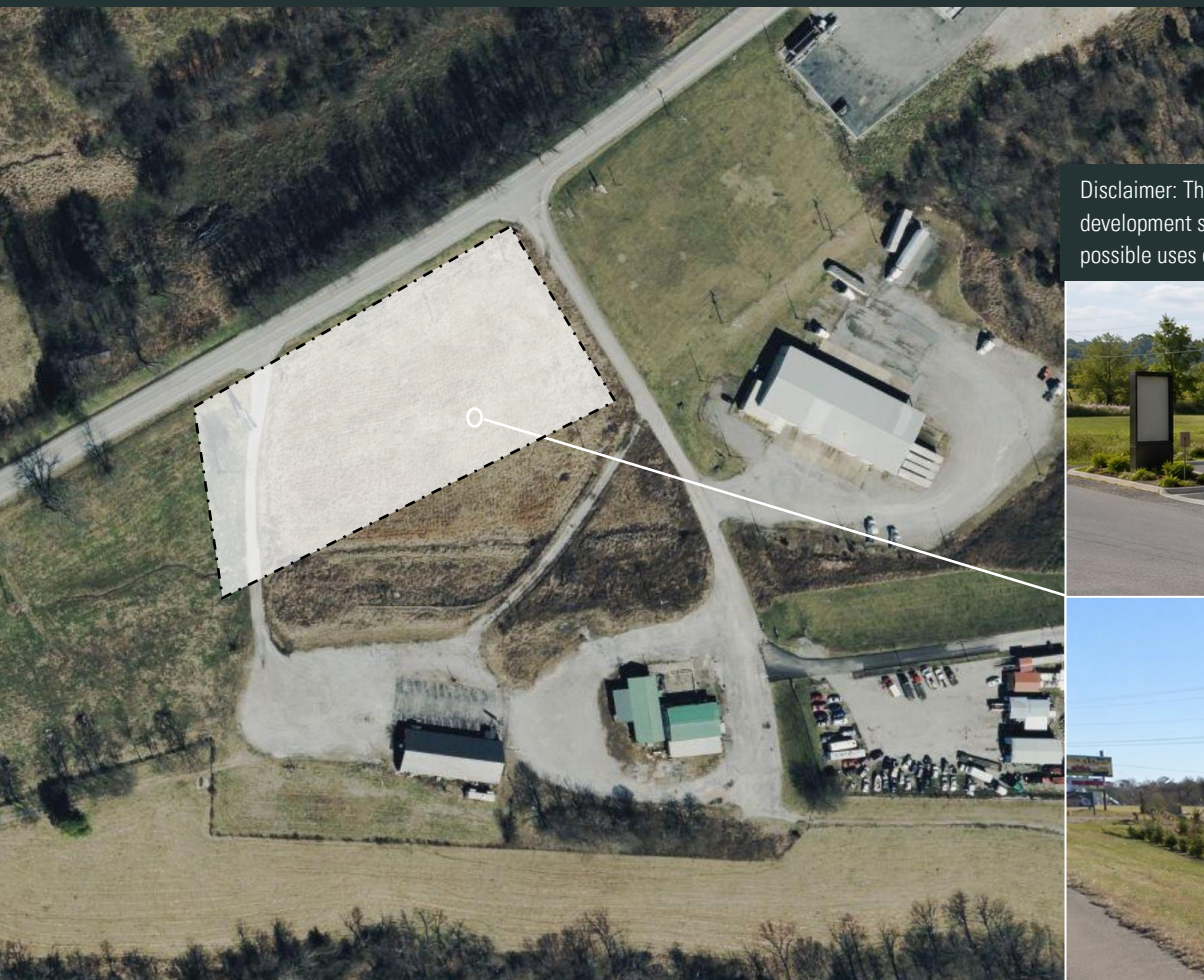

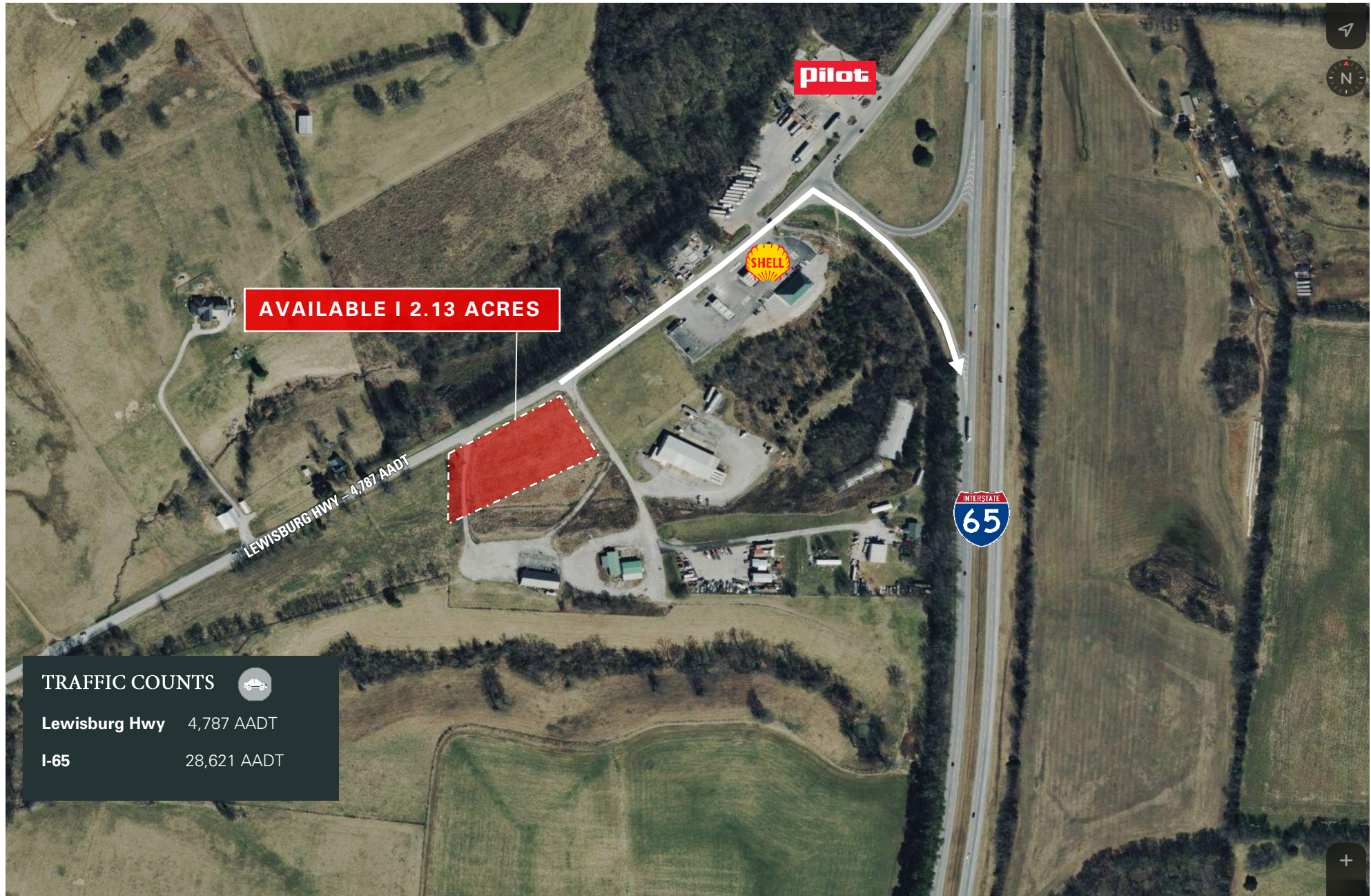
EXCELLENT VISIBILITY & ACCESSIBILITY

The initiative is being positioned as a reimagined roadside destination serving families, tourists, commuters, and professional truck drivers.

Flagship Location: Cornersville, Tennessee

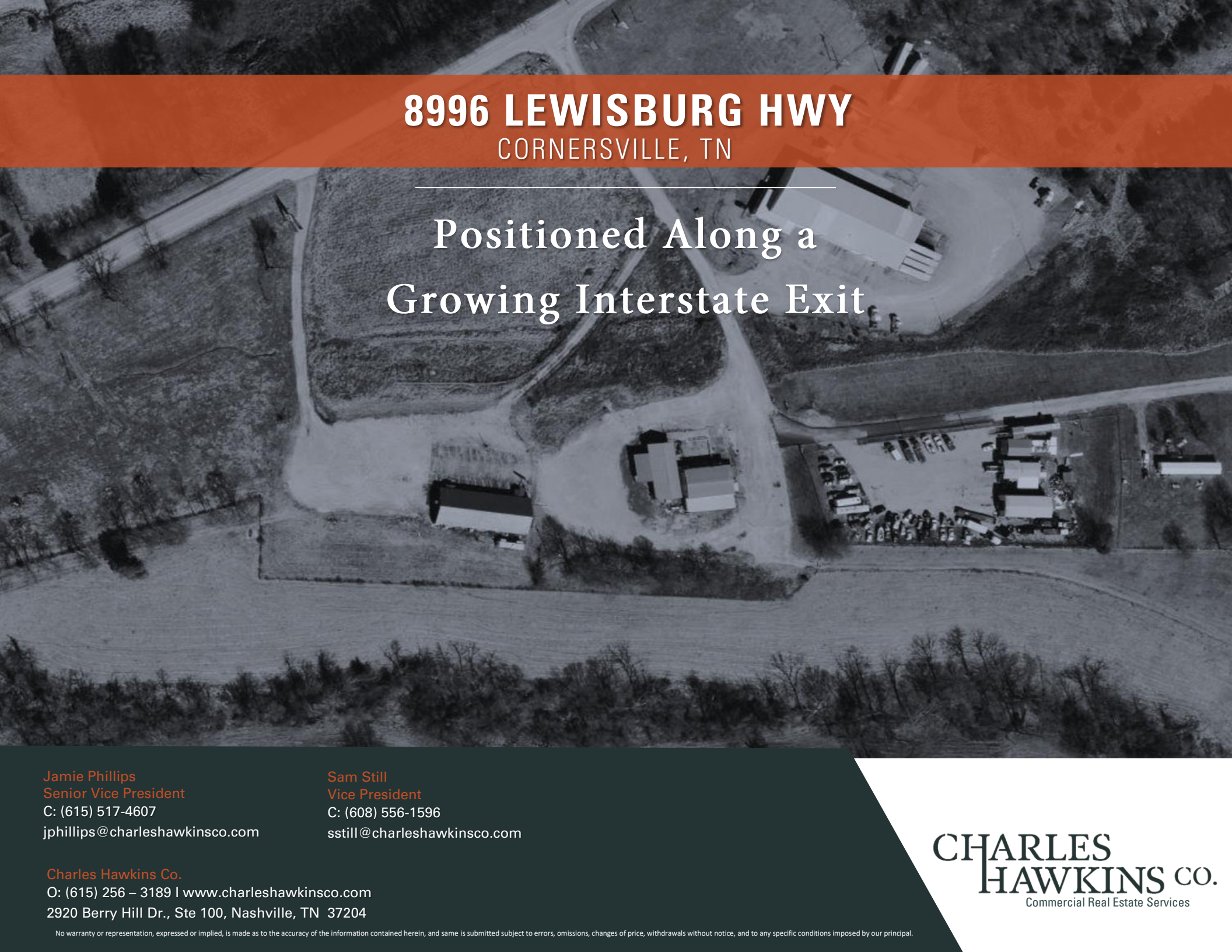
The first and flagship location is located at Exit 22 on Interstate 65 in Cornersville, Tennessee, approximately one hour south of Nashville and one hour northwest of Huntsville, Alabama. The project is a redevelopment and expansion of the existing Tennessean Travel Stop, which has served travelers along I-65 for decades.

Amenities and Features

Unlike a traditional gas station or truck stop, the concept is designed to be a destination experience. Planned amenities include:

- Full-service restaurant and café
- DLY BBQ restaurant concept
- Dolly's "Cup of Ambition" coffee program
- Tennessee-themed merchandise and gift retail
- Truck parking and driver lounge facilities
- EV charging stations
- Dog park ("Doggy Parton Dog Park")
- Event and gathering spaces
- Live music stage
- Dolly-inspired tour bus photo attraction
- Custom artwork and murals celebrating Tennessee heritage and Cornersville's history
