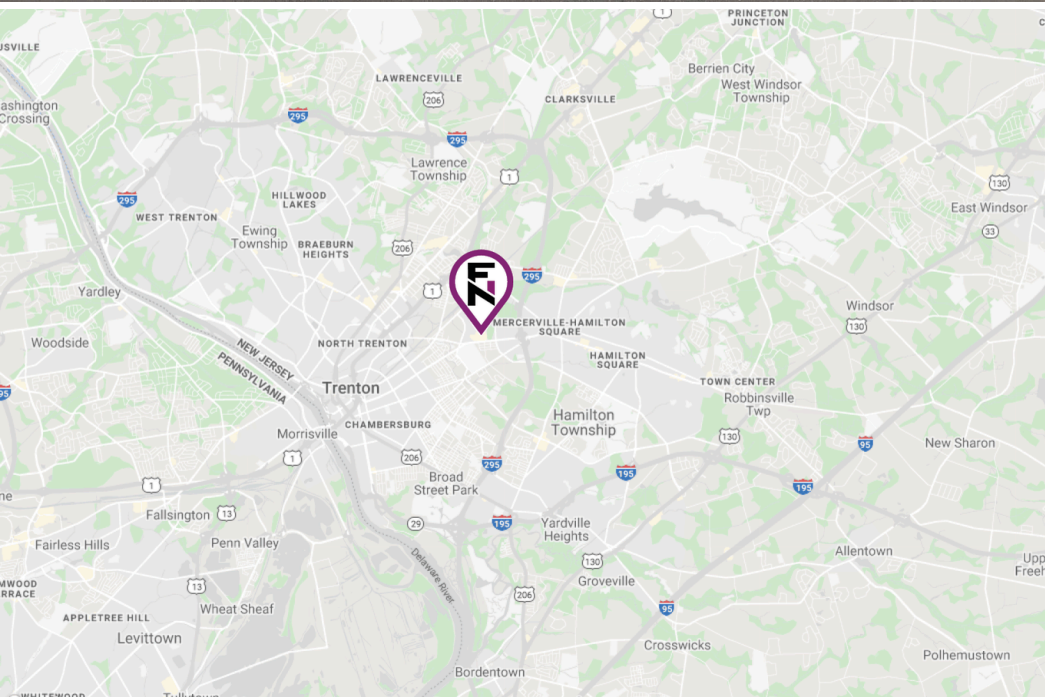

- Within a 5-mile radius of the property the population is 260,403 with an average household of \$114,000.



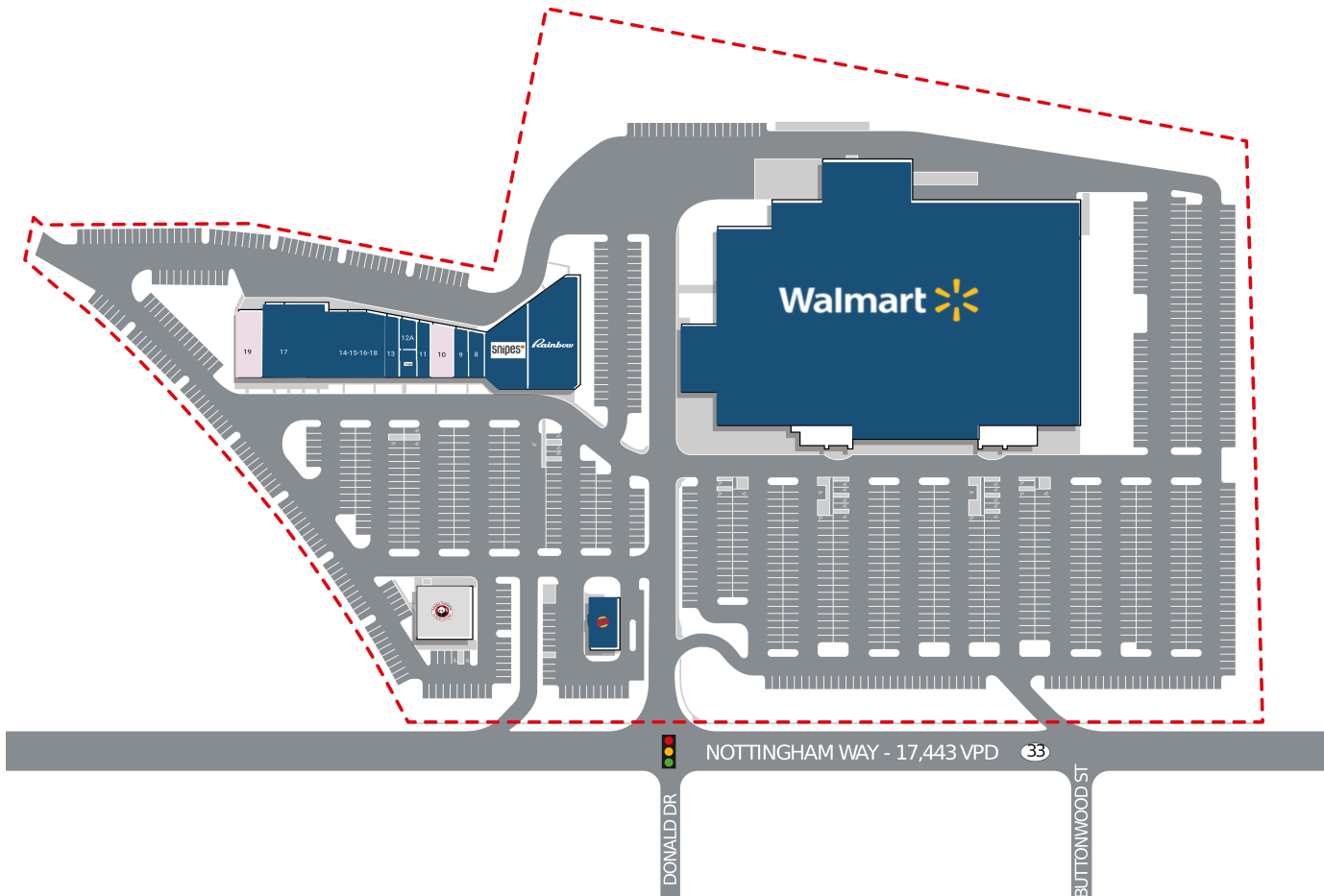
