PROPERTY DESCRIPTION



Location Description

This property sits on the north side of Havendale Boulevard just to the west of Jersey Road. Located approximately 11 miles from Interstate 4 (I4) and approximately 12.5 miles to State Road 60 (SR60) provides quick access to Orlando and Tampa and is nestled roughly halfway between the two major cities.

Site Description

This property consists of one 1,611 sf restaurant building along with a bbq cooking shack and an additional storage building with an outdoor dining area nestled between the restaurant and storage building. Sitting just outside of the Auburndale city limits Polk County provides services such as trash pickup while escaping the additional city taxes. The Polk County future land use is Linear Commercial Corridor. "The purpose of the Linear Commercial Center (LCC) land use district is to recognize existing linear concentrations of commercial, office, institutional, and industrial uses along roadways. The LCC land use also allows for multi-family residential development on the second floor or higher of new or redeveloped buildings." (Polk County Comprehensive Plan)

Restaurant Description

Since the opening of Smokin' Jim's House of Bar-B-Q in Winter Haven back in February of 2005, the restaurant has turned into a local gem. The restaurant is a beloved spot in Polk County with nearly 20 years in business. People come from far and wide to savor mouthwatering dishes like fall-off-the-bone ribs, award-winning shredded pork, beef brisket, smoked turkey, and steaks. The menu also boasts daily and nightly specials, all prepared with Jim's signature recipes and techniques. Smokin' Jim's also offers catering – there's no event too big or too small for Jim's BBQ expertise. The owner is willing to remain involved for a limited period of time for a smooth transition.











Todd was the Commission liaison to the Central Florida Development Council (CFDC), the economic development arm of the county, and past chairman of the CFDC.

In addition, Todd is the immediate past Chairman of the Winter Haven Hospital/BayCare Board of Trustees. The Winter Haven Hospital is a 529-bed major medical center serving the east Polk and Highlands counties and is the largest private employer in East Polk County.

Todd received a Bachelor of Science degree in Business Administration with a major in Marketing from the University of Florida and is a member of the Florida Blue Key at UF. He was the president of his fraternity, Alpha Tau Omega, where he won the Morton Wolfson Award for the Best Fraternity President at UF in 1981 and the Harry L. Bird Award for best Public Relations Officer.

In addition to real estate, Todd serves as a Senior Consultant with Two Blue Aces, an executive leadership and management development company led by six retired United States Air Force (USAF) General Officers. Professional Background

Jonathan Fleming is an Advisor at Saunders Real Estate.

Jonathan also managed facility moves. He was one of two leads responsible for the remodeling of a dry warehouse to build a 50,000-square-foot freezer and cooler. He also worked on an implementation team for new hardware and software for warehouse management and transportation management systems.
