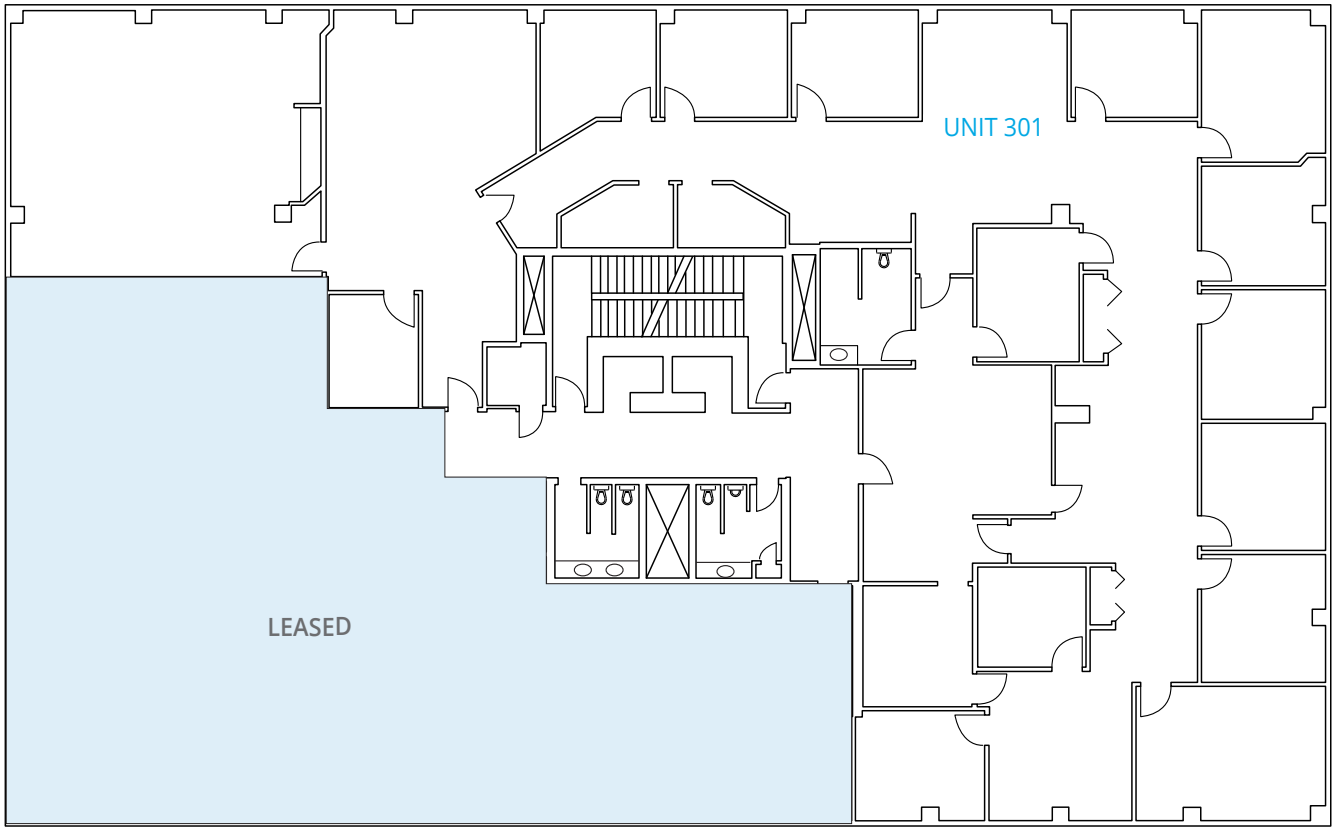

124th Street Business Park East Floor Plans

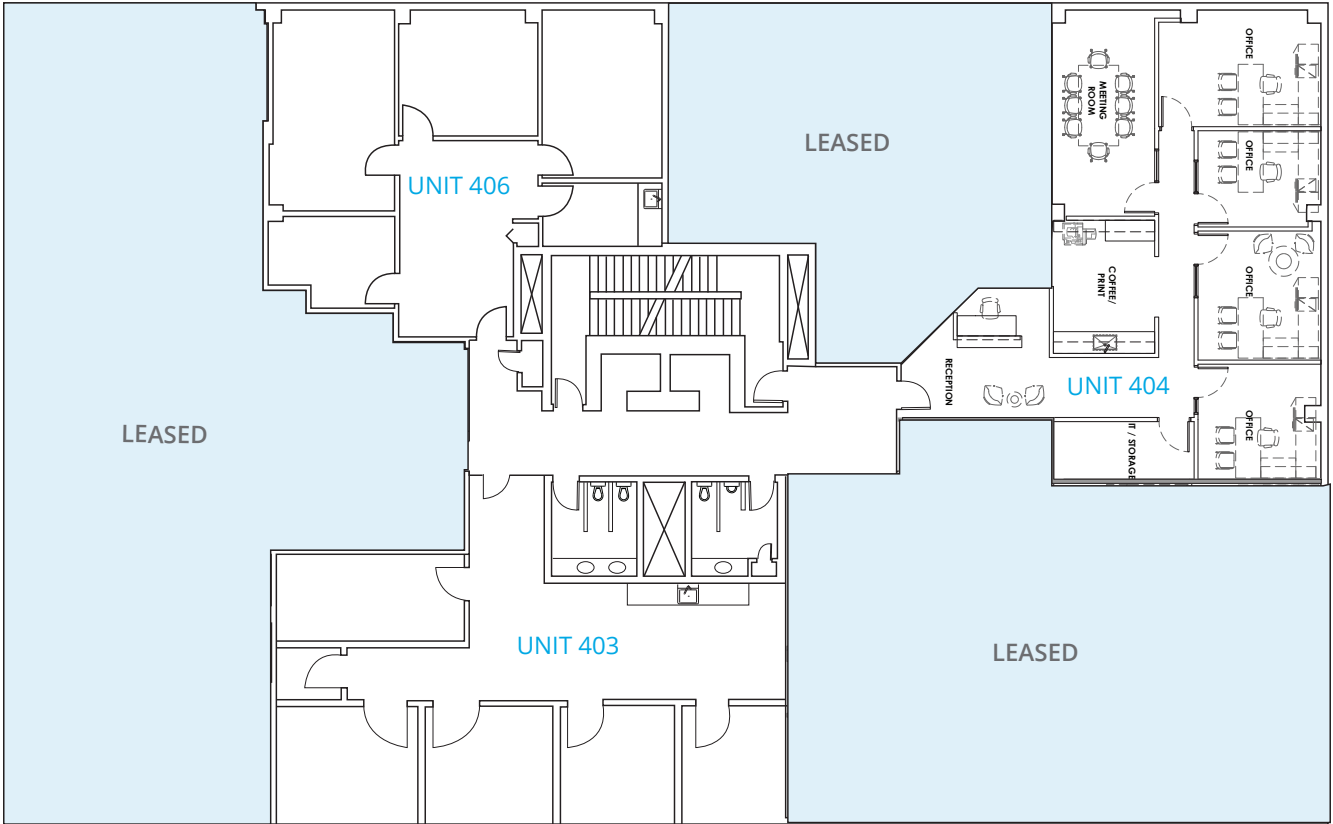
