



Commencing at the Southwest corner of said half quarter section said point marked by a brass plug found matching County surveyor's ties, said point also being in the centerline of S.R. 135; thence North 00 degrees 46 minutes 54 seconds West along the West line of said half quarter section and said centerline 1313.21 feet; thence North 88 degrees 28 minutes 11 seconds East 30.00 Feet to a point on the East right-of-way line of said S.R. 135, said point marked by an iron pin set and the Point of Beginning of this tract; thence North 00 degrees 46 minutes 54 seconds West on and along said right-of-way line 86.16 feet to a point on the South right-of-way line of Stonegate Drive in the plat of Stonegate Subdivision per plat recorded in the Office of the Johnson County Recorder; thence North 88 degrees 28 minutes 11 seconds East (platted and measured) along said right-of-way line 152.77 feet; thence South O degrees 46 minutes 54 seconds East 86.16 feet to a point marked by an iron pin set; thence South 88 degrees 28 minutes 11 seconds West 152.77 feet to the Point of Beginning, containing 0.3022 acres, more or less.
