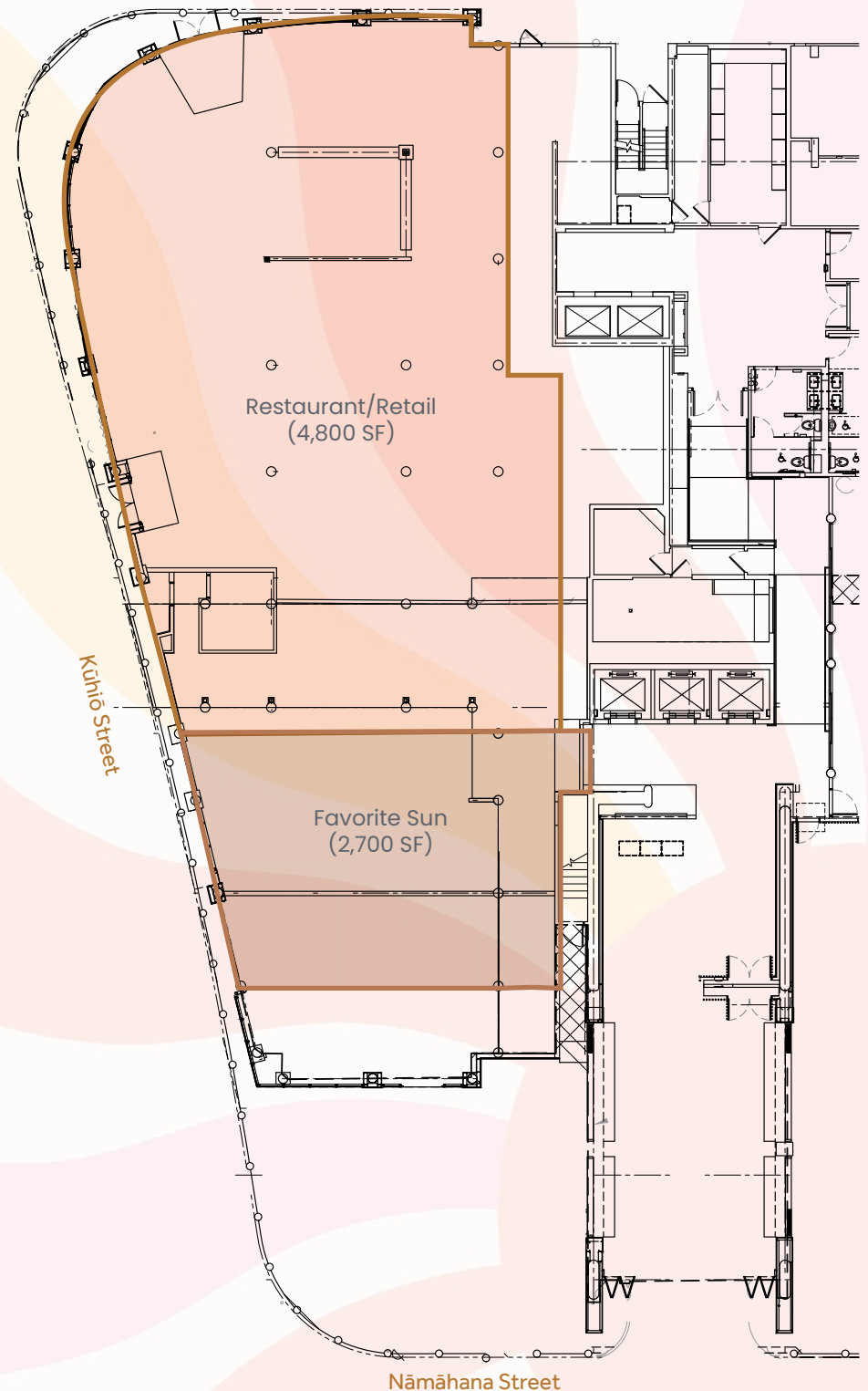

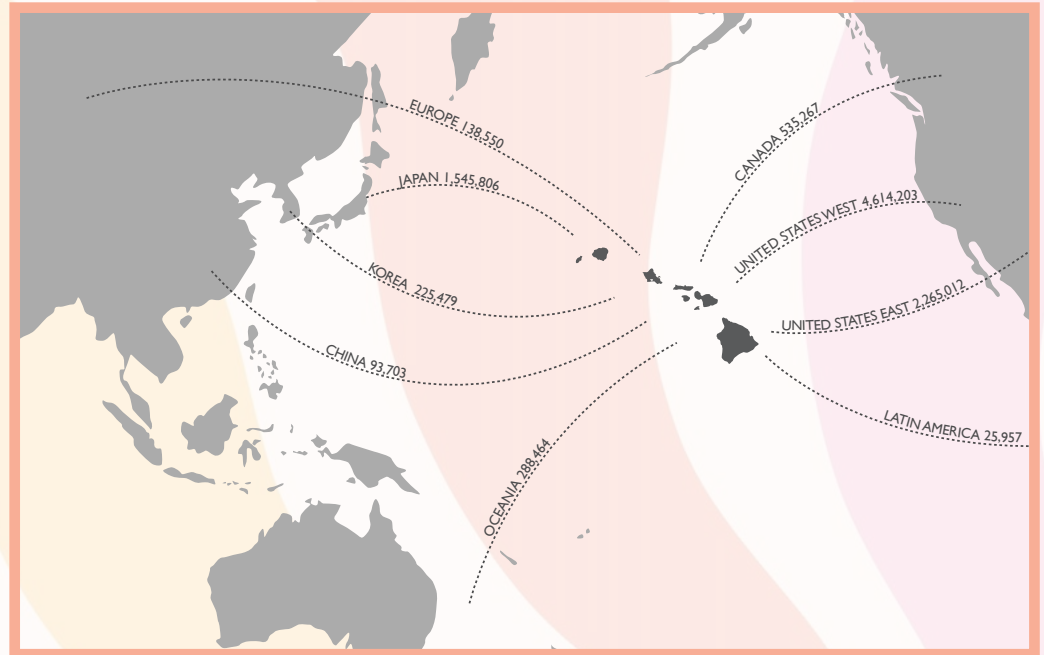






# WAIKIKI STATISTICS & DEMOGRAPHICS
