Zoned C-Commercial in the County which allows for a wide range of commercial uses. The site is served by well and septic. Opportunity for additional land acquisition on the north and east side of the site. Newton Park is located on the southwest adjacent corner of SR 4 and S. Michigan Street/US 31 from the subject property, and the park is a popular venue for baseball, softball and soccer with an average of 500 to 1,500 visitors per weekend from April through November. Near Potato Creek State Park with 165,000 visitors annually

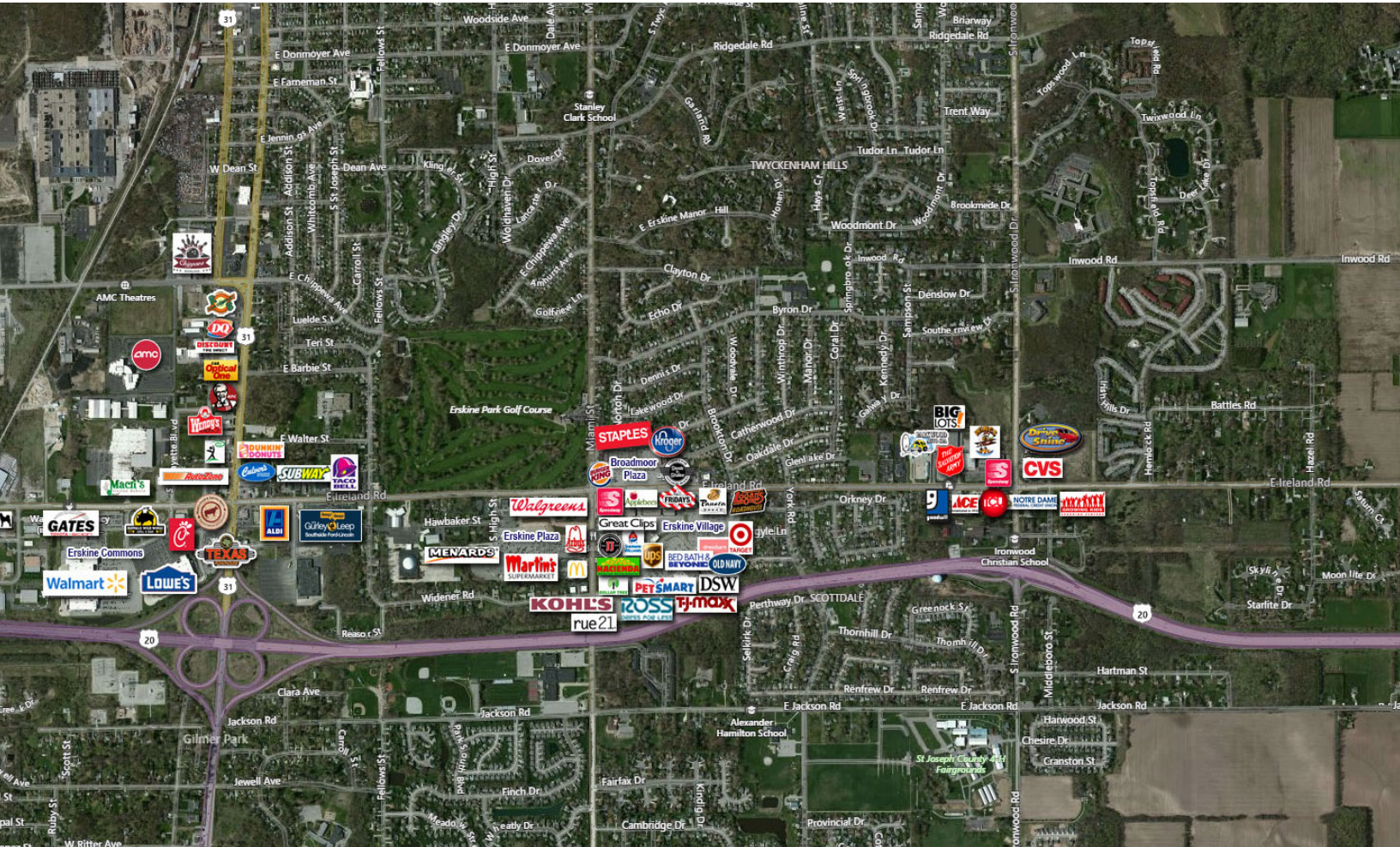

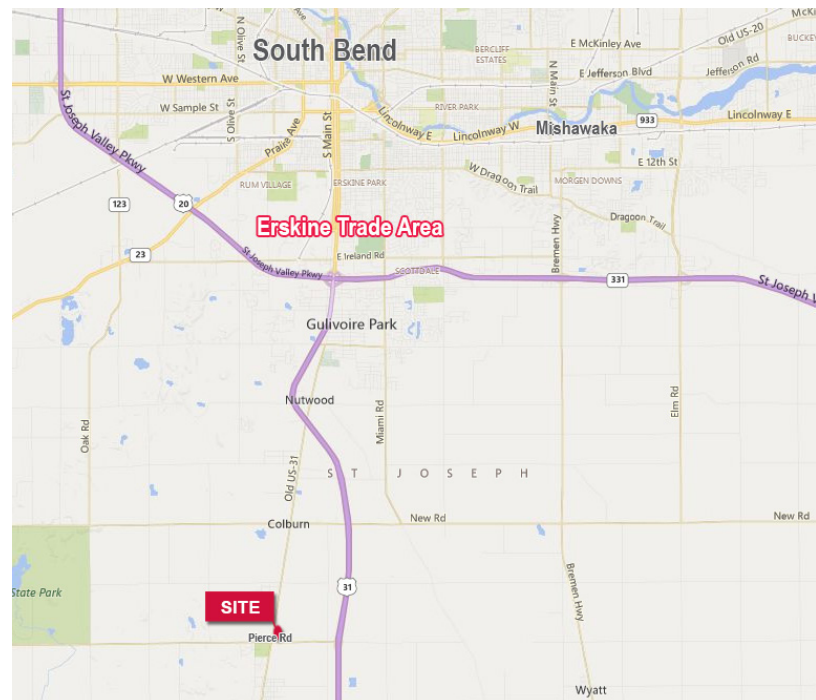

- With the completion of the US 31 ByPass, Pierce Road has become the exit for Lakeville and Potato Creek State Park with all traffic driving by the subject property.

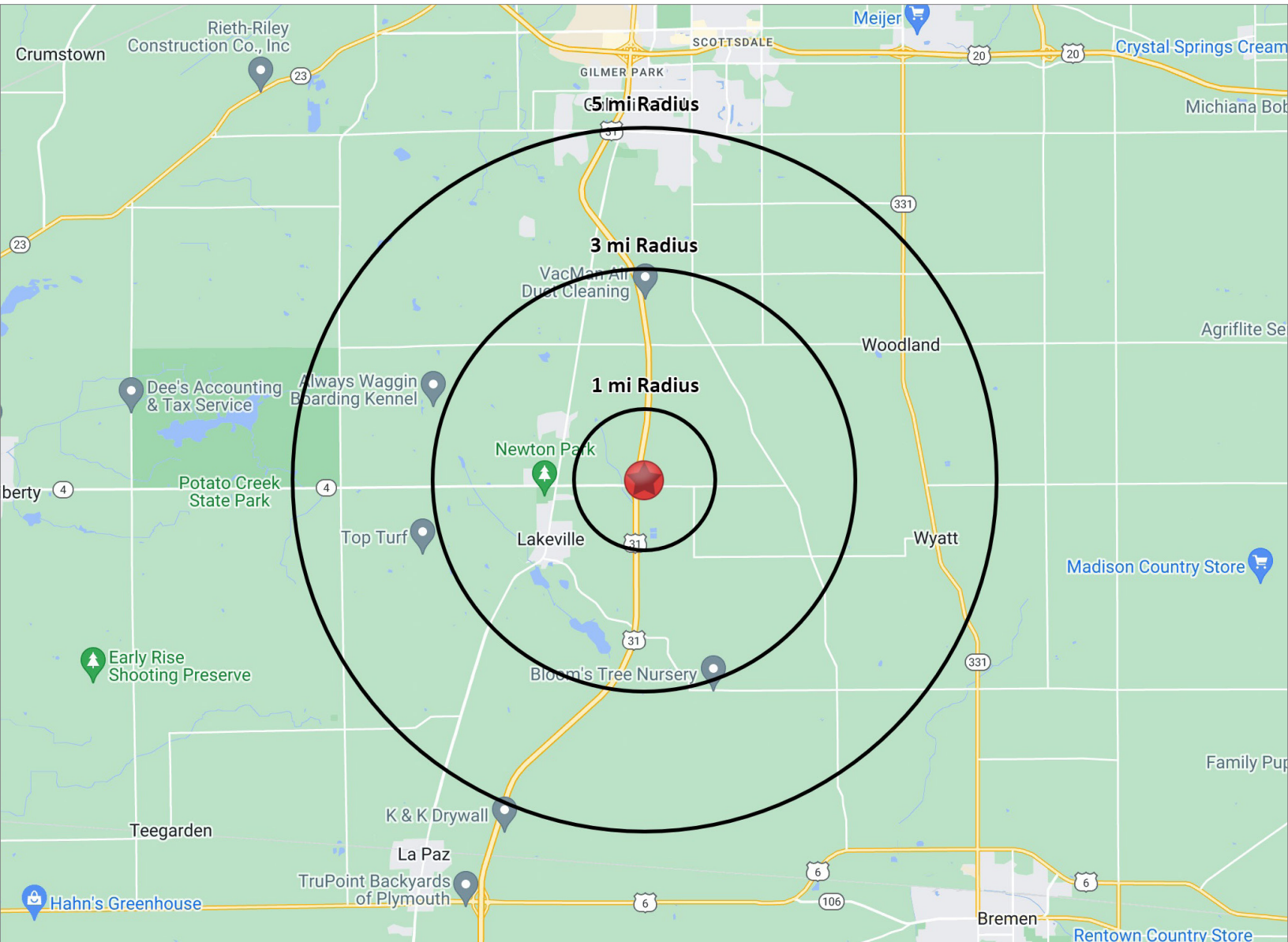
