Description of a 12.58 Acre more or less, Parcel of land out of a portion of Tract 1, Block 23 and a portion of Tract 4, Block 22, San Elizario Grant, El Paso County, Texas, according to the Resurveys of said San Elizario Grant made by El Paso County, Texas, for tax purposes, and out of a parcel described in Instrument No. 20210098118, Real Property Records of El Paso County, Texas, being more particularly described as follow:

COMMENCING, for reference at a found $\frac{1}{2}$ " iron with cap stamped "TX 1976" (as shown on the General Land Office Survey Plan, El Paso County, Sketch File No. 40, surveyed Robert L Pounds LSLs, dated 12/07/1988) on the common southerly corner of Robert E. Nix Survey No. 304 and 305, El Paso County, Texas and on the northerly line of Robert E. Nix Survey No. 306, El Paso County, Texas; **THENCE**, N $87^{\circ} 32' 38''$ W, along the common line of Robert E. Nix Survey No. 304 and 306, a distance of 1480.17 feet to a point; **THENCE**, N $32^{\circ} 10' 38''$ W, along the common line of Robert E. Nix Surveys and H.D. Camp Surveys, a distance of 2,029.18 feet to a found $\frac{1}{2}$ " rebar with cap stamped "B&A Inc." on the easterly common corner of H.D. Camp Survey No. 408-B and 408-C, El Paso County, Texas and the southeasterly corner of said parcel described in Instrument No. 20210098118; **THENCE**, N $32^{\circ} 10' 38''$ W, along the common line of Robert E. Nix Surveys and H.D. Camp Surveys, a distance of 2,421.91 feet to a point; **THENCE**, S $57^{\circ} 49' 22''$ W, leaving said common line, a distance of 2,947.68 feet to the **POINT OF BEGINNING** of this description;

THENCE, S $46^{\circ} 46' 27''$ W, a distance of 485.83 feet to a point;

THENCE, N $43^{\circ} 13' 33''$ W, a distance of 1149.46 feet to a point of a non-tangent curve;

THENCE, 88.81 feet, along an arc of a curve to the right with a radius of 1408.00 feet, an interior angle of $03^{\circ} 36' 51''$, and a chord which bears N $65^{\circ} 10' 55''$ E, a distance of 88.80 feet to a point of a non-tangent curve;

THENCE, 409.76 feet, along an arc of a curve to the left with a radius of 1142.00 feet, an interior angle of $20^{\circ} 33' 30''$, and a chord which bears N $56^{\circ} 42' 36''$ E, a distance of 407.57 feet to a point of a non-tangent curve;

THENCE, 31.54 feet, along an arc of a curve to the right with a radius of 20.00 feet, an interior angle of $90^{\circ} 20' 37''$, and a chord which bears S $88^{\circ} 23' 51''$ E, a distance of 28.37 feet to a point;

THENCE, S $43^{\circ} 13' 33''$ E, a distance of 1011.10 feet to a point of curvature;

THENCE, 31.42 feet, along an arc of a curve to the right with a radius of 20.00 feet, an interior angle of $90^{\circ} 00' 00''$, and a chord which bears S $01^{\circ} 46' 27''$ W, a distance of 28.28 feet to the **POINT OF BEGINNING** of this description and containing in all 12.58 acres of land more or less.


NOTES:





