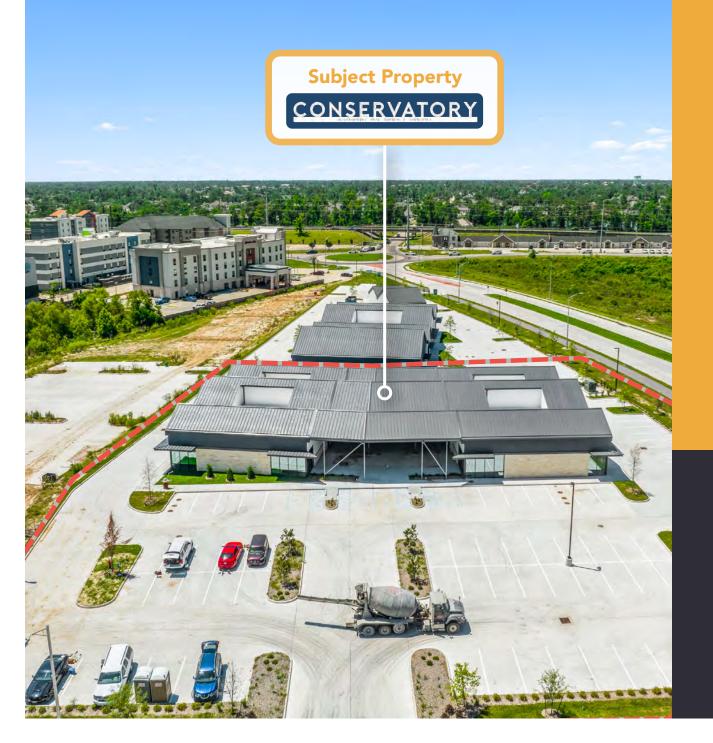

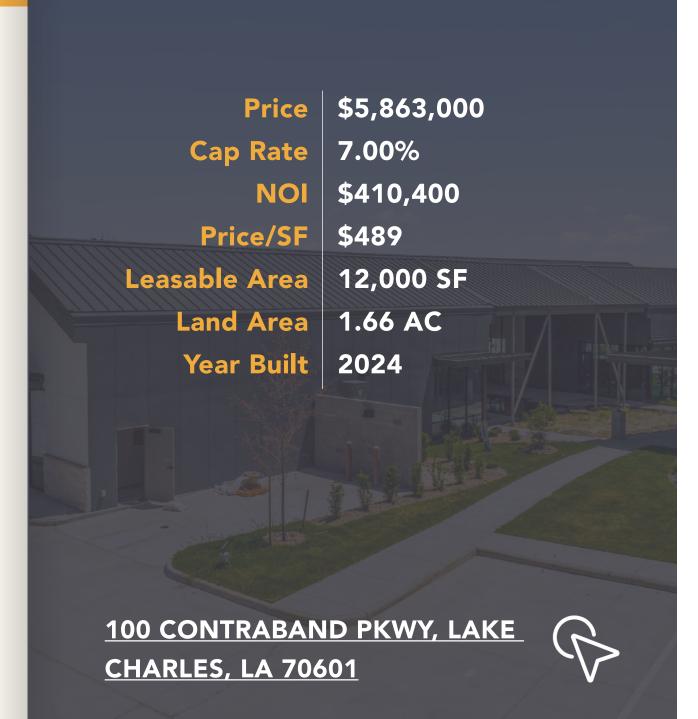

CONSERVATORY

The Conservatory is a **sustainable food hall platform** built for **supporting and incubating small, local businesses**. Founded in Houston, TX, the Conservatorry was the first food hall concept of its kind for the area. The concept quickly gained popularity and is on track to open **three more locations**: two in the Houston MSA, Galleria and Richmond, and one in Lake Charles, LA. In addition to the Conservatory's wide array of local food vendors and small businesses, the food hall also **hosts many live music shows and community events**.

The adjacent sampling of vendors are from the Conservatory's Midtown location in Houston, TX.

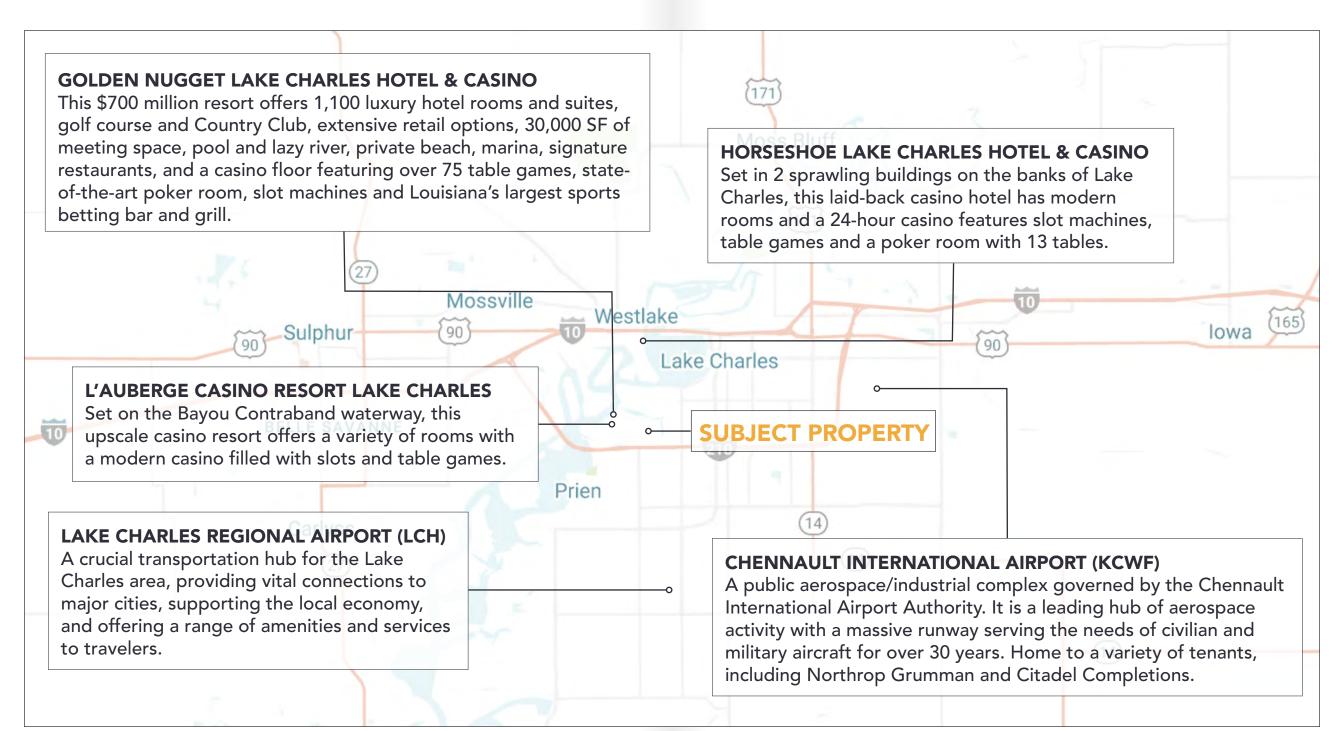




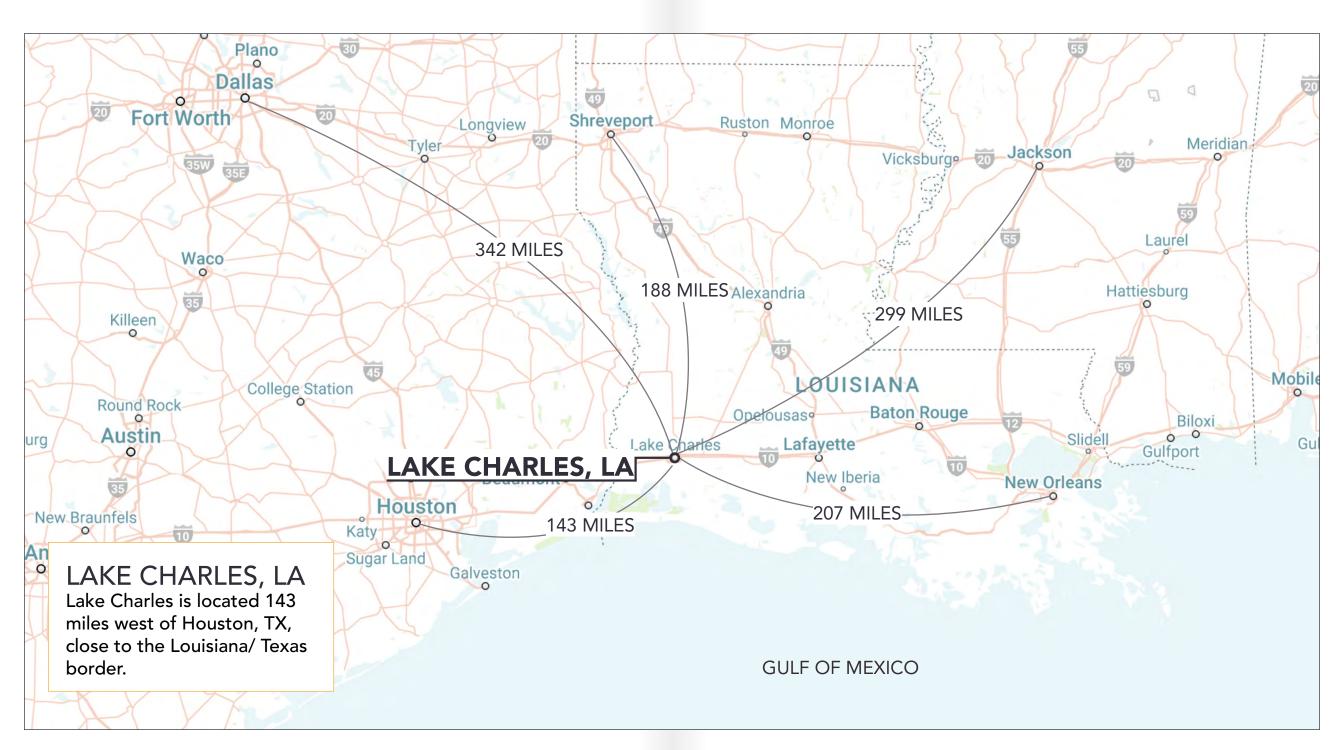














VISITATION DATA

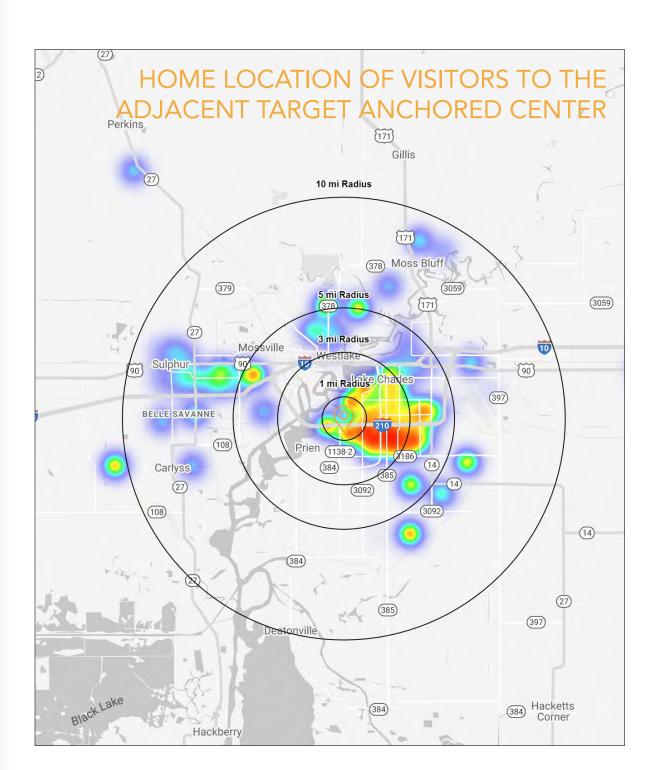
