




Area Overview

Just minutes west of downtown but embodying both small-town and urban vibes, the Grandview community is close-knit and friendly, and people of all ages and walks of life call this walkable area home. Grandview boasts many small businesses, from event venues and boutiques to craft beer and coffee.

The City of Grandview Heights has a rich history, beginning in 1797, when the area was settled by Lucas Sullivant. The community was originally known as

Marble Cliff. It was the first incorporated suburb of Columbus and was nicknamed "the Millionaire Suburb." Grandview Heights was incorporated as a village in 1906 and became a city in 1931.

Today Grandview is known for its thrift and antique shops, modern boutiques for clothing, accessories and home goods. Grandview also hosts the Grandview Hop several times each summer, celebrating local businesses and artisans.


