



















Lease Summary

All Utilities


Tenant pays all gas, electricity, water, telephone, garbage and other utilities directly to the provider/s.

Taxes


Tenant shall reimburse landlord for their proportionate share of all real estate taxes against the lease premises.

Landlord to maintain property taxes and building insurance with tenant reimbursing such costs on a proportionate share basis. Tenant shall maintain liability insurance.










Parcel Map








