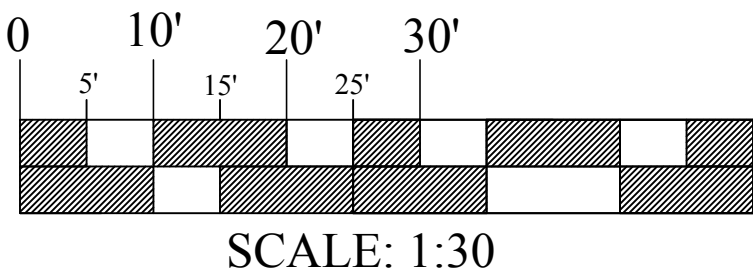
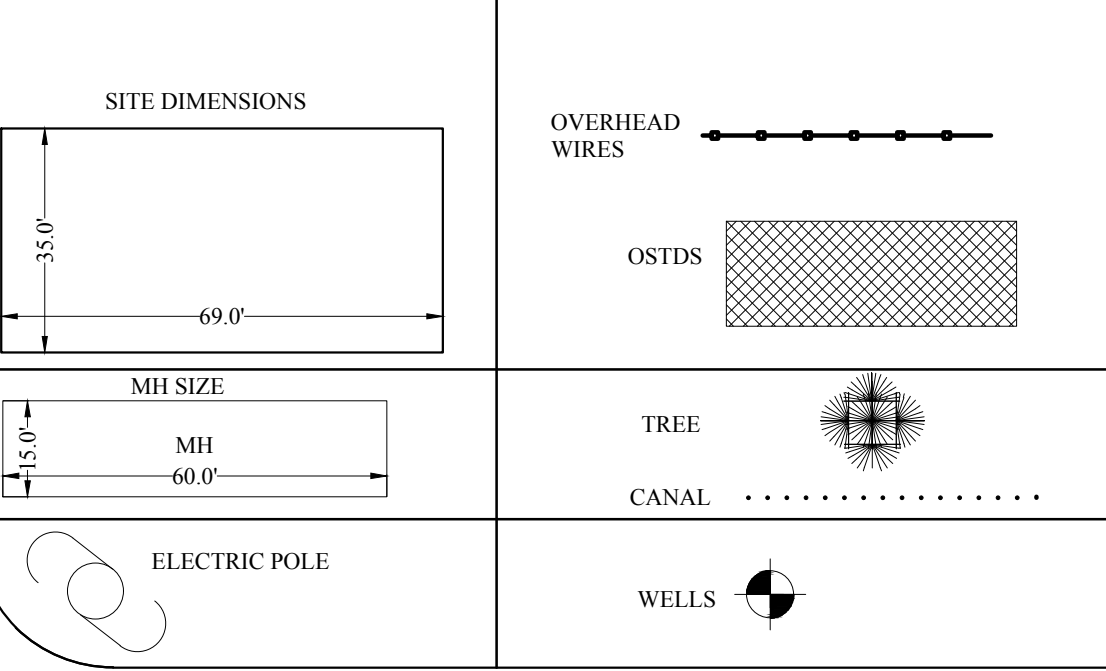


OASIS EVALUATION NOTES:
