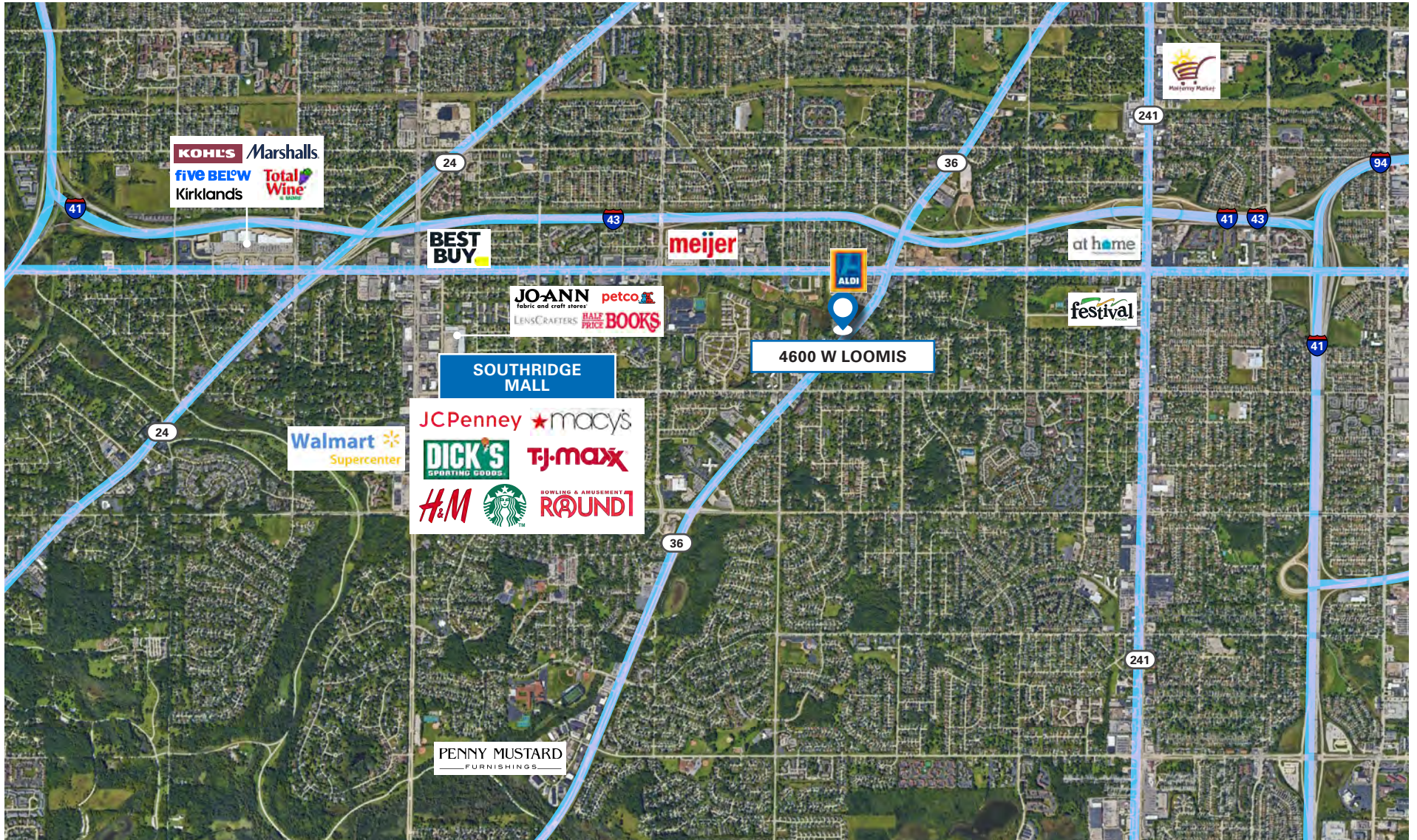

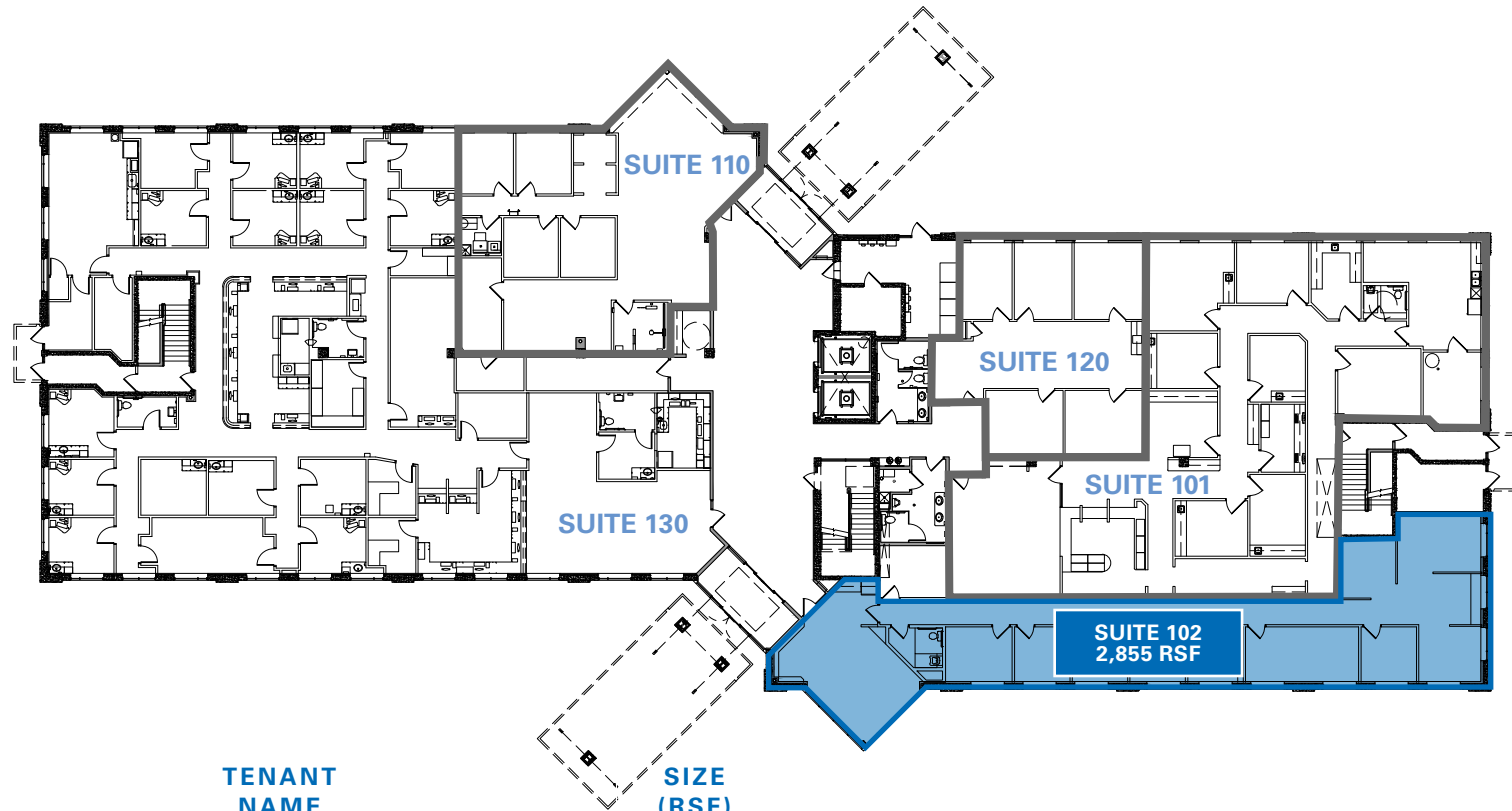

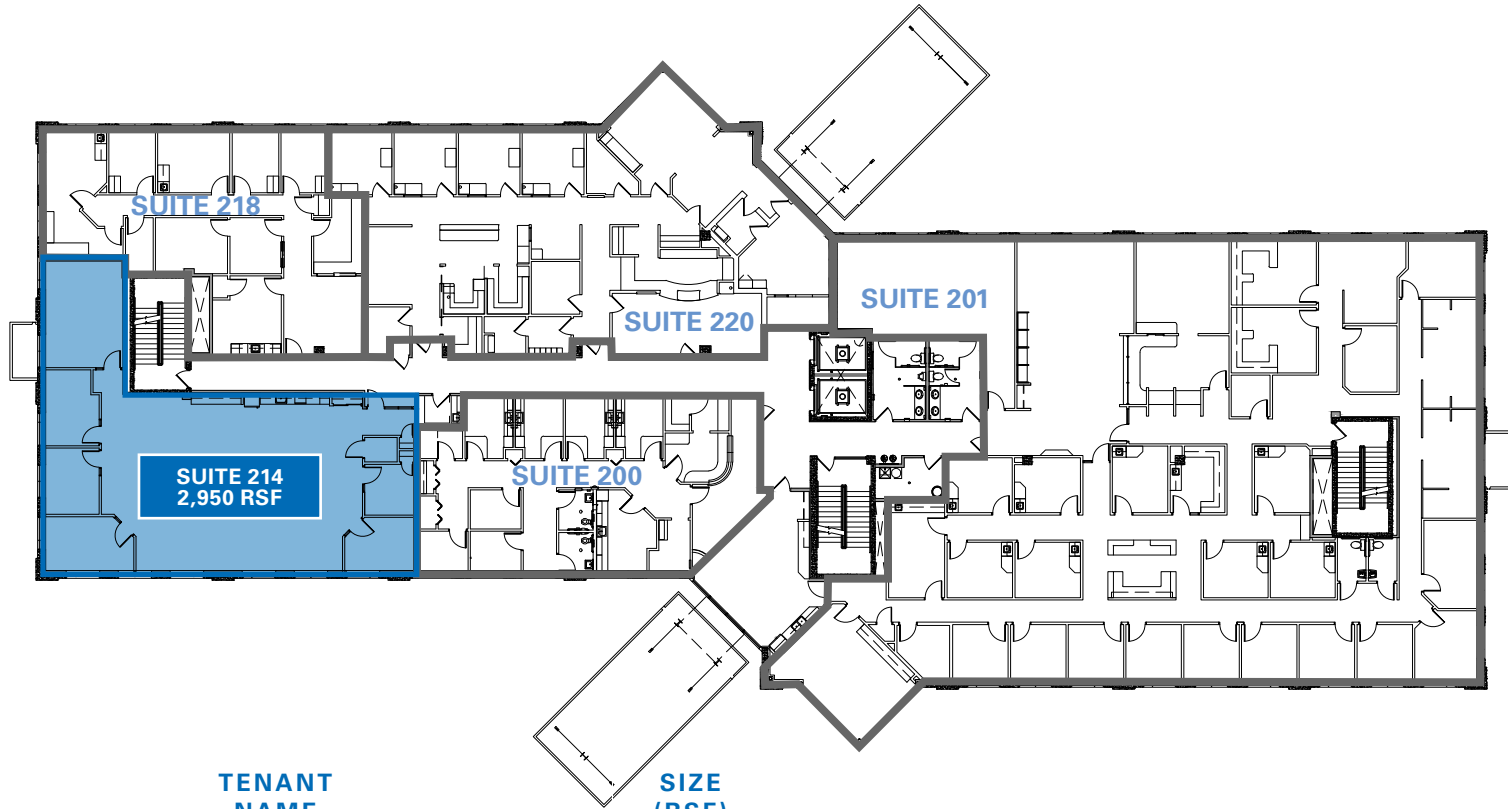
Floor Plan - Level 1

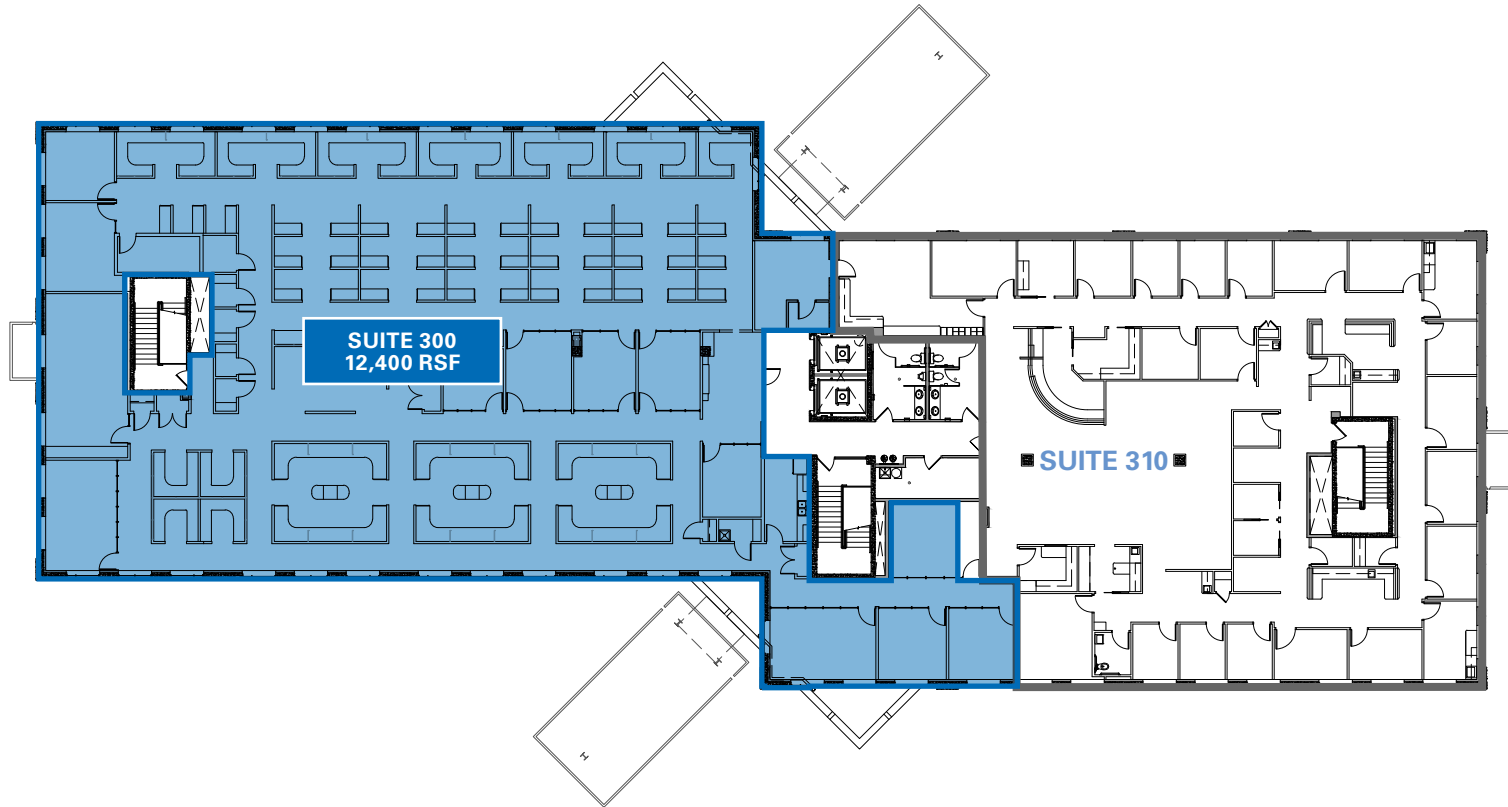
Floor Plan - Level 2

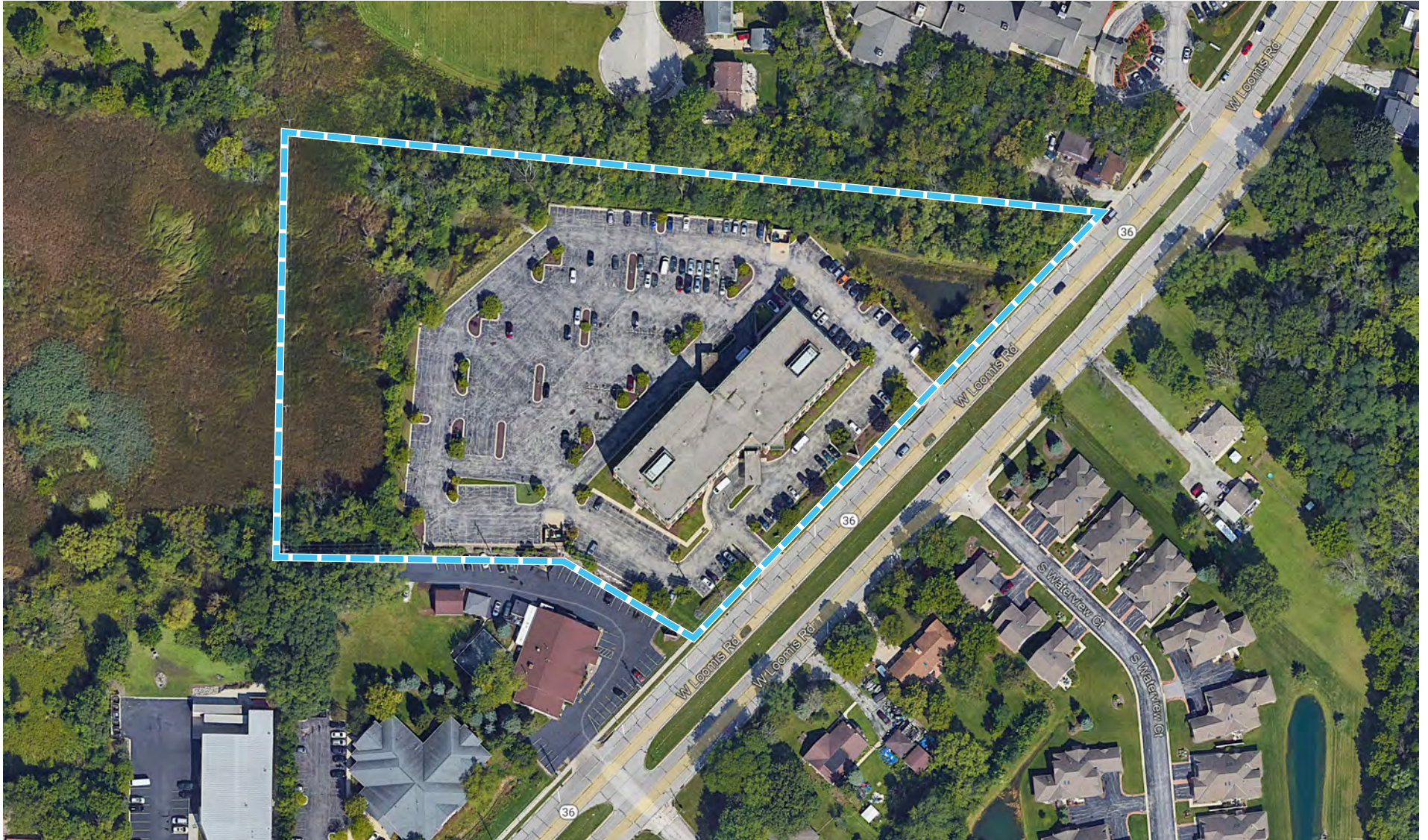
