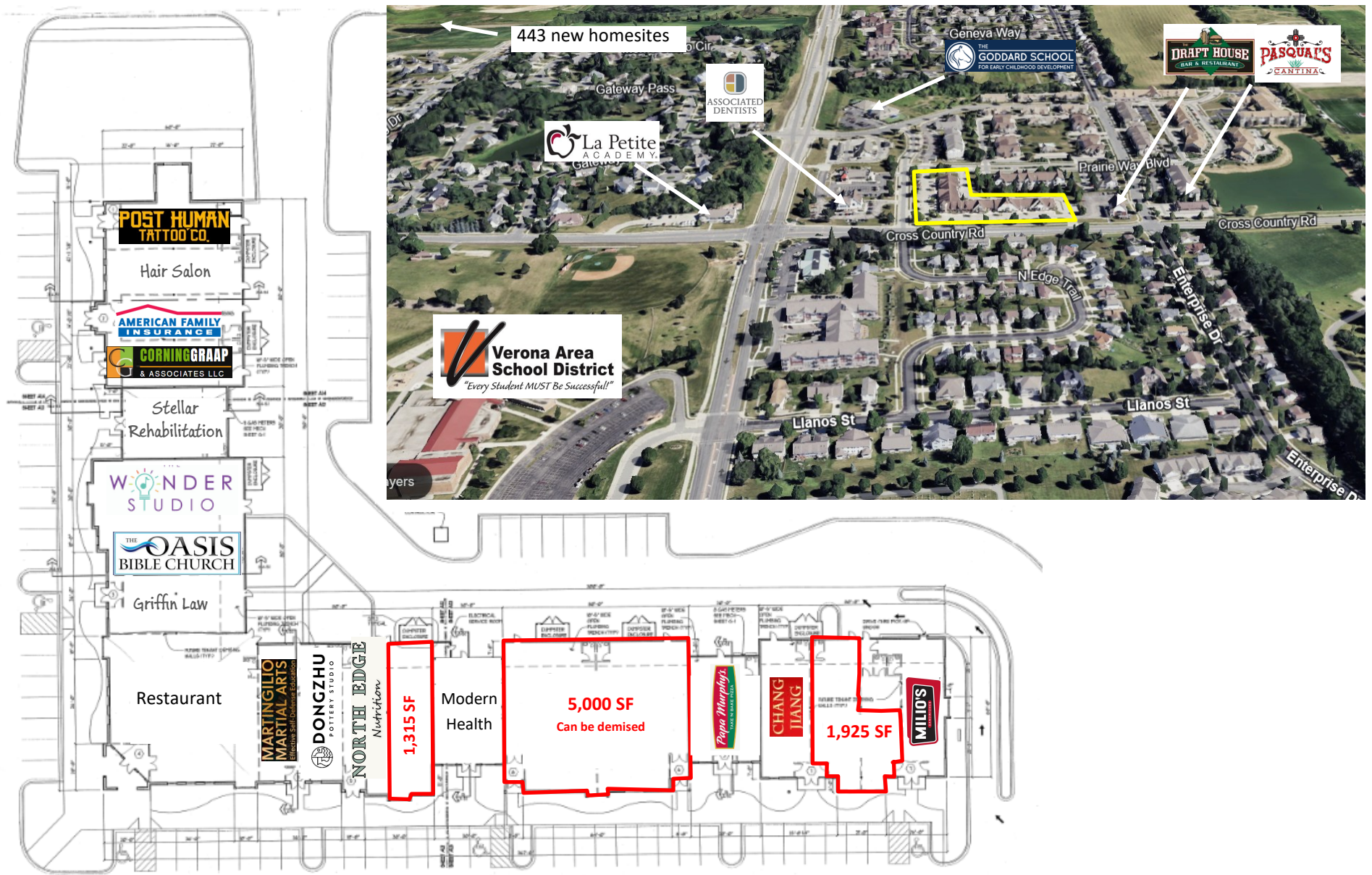

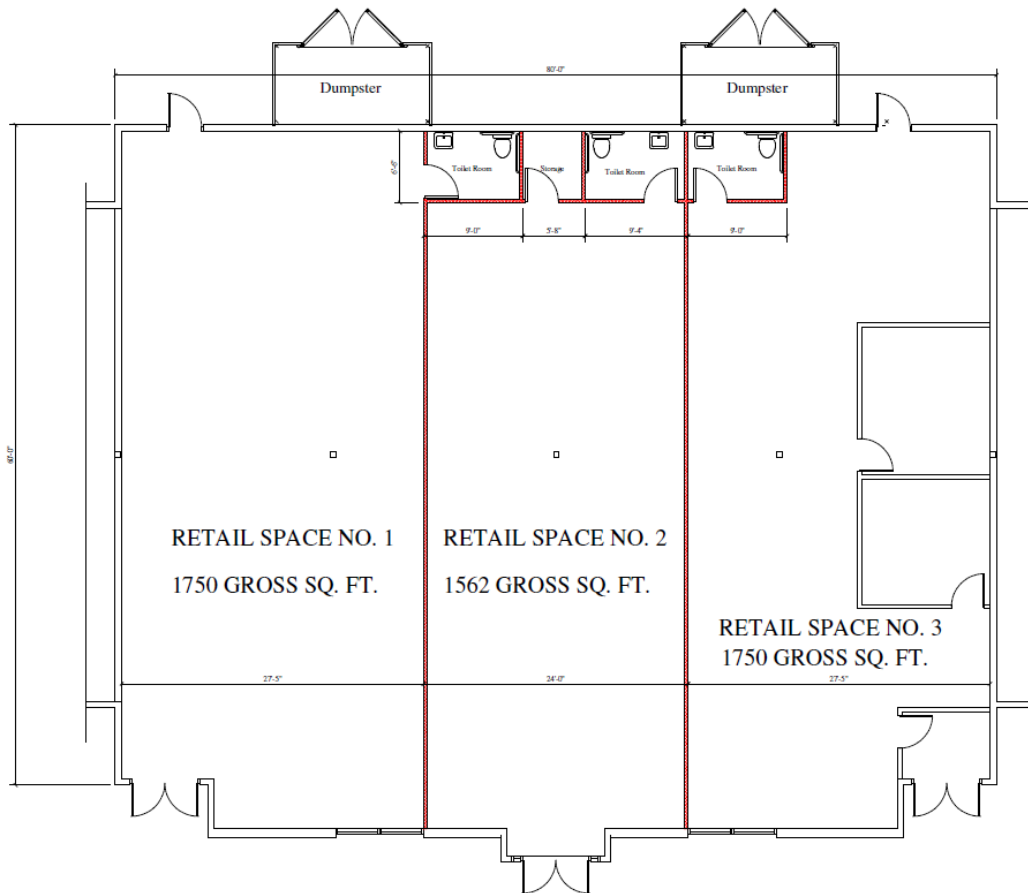

Site Plan & Location



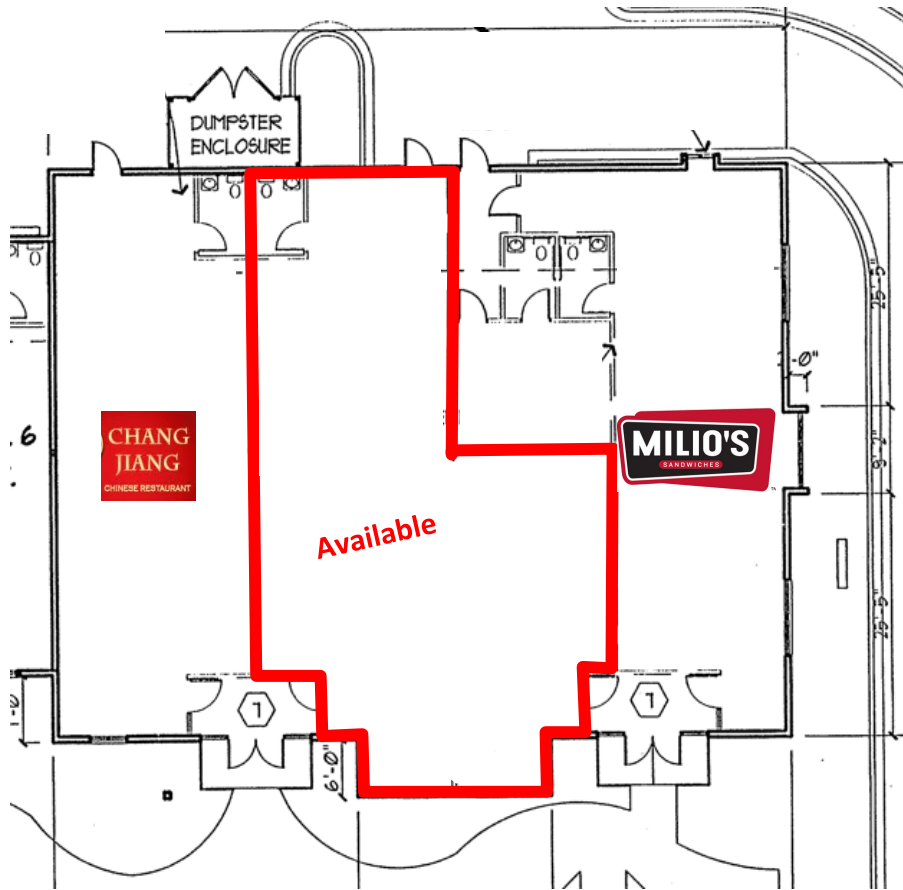
Floor Plan_Suite 1025

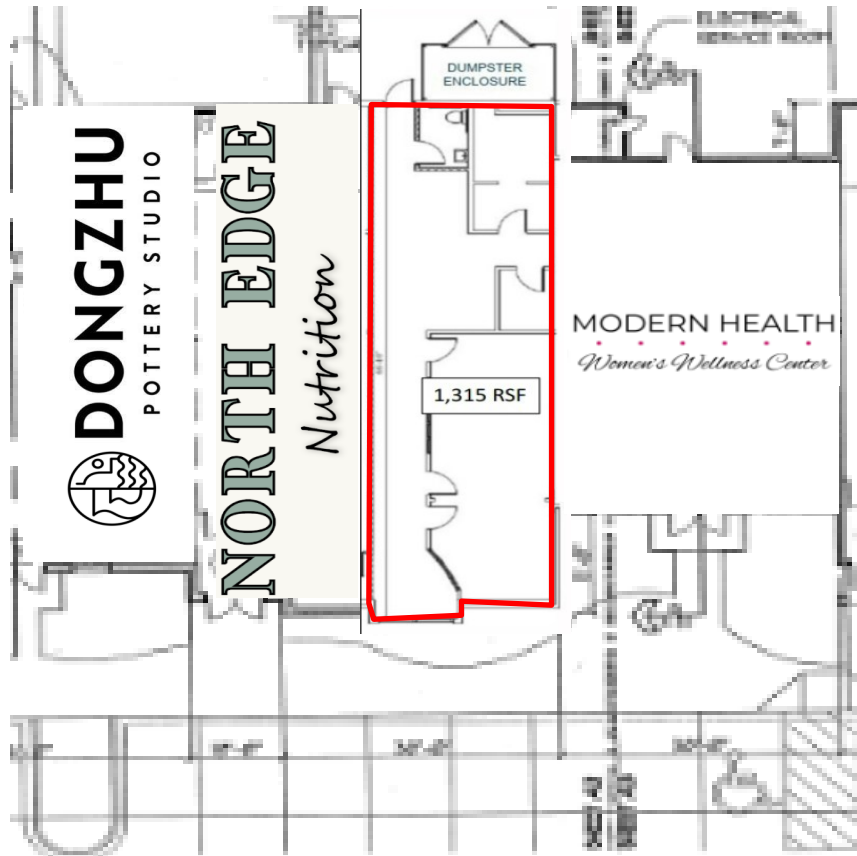


Floor Plan Suite 1015

18 advantages and disadvantages of the proposals.
