

WITNESSETH that Alice Tanner Kendrix, the undersigned, (hereinafter referred to as 'Grantor'), is the owner of a tract of land in HALL County through which Widening and Reconstruction of State Route 53, known as Project No. STP-065-3 (39), has been laid out by the Department of Transportation being more particularly described in a map and drawing of said road in the office of the Department of Transportation, No. 2 Capitol Square, Atlanta, Georgia, to which reference is hereby made.

NOW, THEREFORE, in consideration of the benefit to said property by the construction and maintenance of said road, and in consideration of ONE DOLLAR (\$1.00), in hand paid, the receipt whereof is hereby acknowledged, Grantor does hereby grant, sell and convey to said Department of Transportation, and their successors in office so much land as to make a right of way for said road as surveyed, being more particularly described as follows:

All that tract or parcel of land lying and being in 385 Georgia Militia District of Hall County, Georgia, and being more particularly described on Exhibit "A" attached hereto and made a part hereto by this reference.

Said right of way is hereby conveyed, consisting of **0.011 acres**, more or less, as shown colored yellow on the plat of the property prepared by the Department of Transportation, dated May 31, 2001; revised January 22, 2004, said plat attached hereto and made a part of this deed as Exhibit "B".

For the same consideration Grantor hereby conveys and relinquishes to the Department of Transportation all rights of access between the limited access highway and approaches thereto on the above numbered highway project and Grantor's remaining real property from which said right of way is taken except at such points as designated and shown on the attached plat prepared by the Department of Transportation.

Beginning at a point 78.06 feet right of and opposite Station 12+843.19 on the construction centerline of Winder Highway on Georgia Highway Project No. STP-065-3 (39); running thence N 55°54'20.6" W a distance of 22.35 feet to a point 78.06 feet right of and opposite station 12+850.00 on said construction centerline laid out for SR 53; thence N 34°05'39.8" E a distance of 20.36 feet to a point 98.42 feet right of and opposite station 12+850.00 on said construction centerline laid out for SR 53; thence S 55°54'20.2" E a distance of 25.04 feet to a point 98.42 feet right of and opposite station 12+842.37 on said construction centerline laid out for SR 53; thence S 41°35'40.5" W a distance of 20.54 feet back to the point of beginning.
