
Kidder Mathews is pleased to present for lease, ±80,000- 125,000 SF of outparcel land on this 13.34-acre site. The land can be used for outdoor storage or can be used for a mixed light cannabis cultivation operation. (There is an existing CUP for the cannabis mixed light use.) The existing 91,040 SF building is occupied with cultivation, manufacturing, and distribution operators. This is an opportunity to be the only outdoor mixed light or storage operator at the site. Build out a mixed light canopy with a greenhouse or hoop houses. The property is fenced and there is 24-hour armed security for safety and confidence in the site.

The structure is a former melon packing facility, and hosts cannabis cultivation, distribution and manufacturing. A mixed light or storage operator will have access to the building's bathrooms and break room. The mixed light section of the parcel has electricity and water stubbed at the site: tenant to install their own electric and water meters. Tenant may need to grade land, and tenant shall apply for the license and comply with any city regulations related to the site. (Landlord reserves the right to designate the size and location of the storage area according to the intended storage use.)


