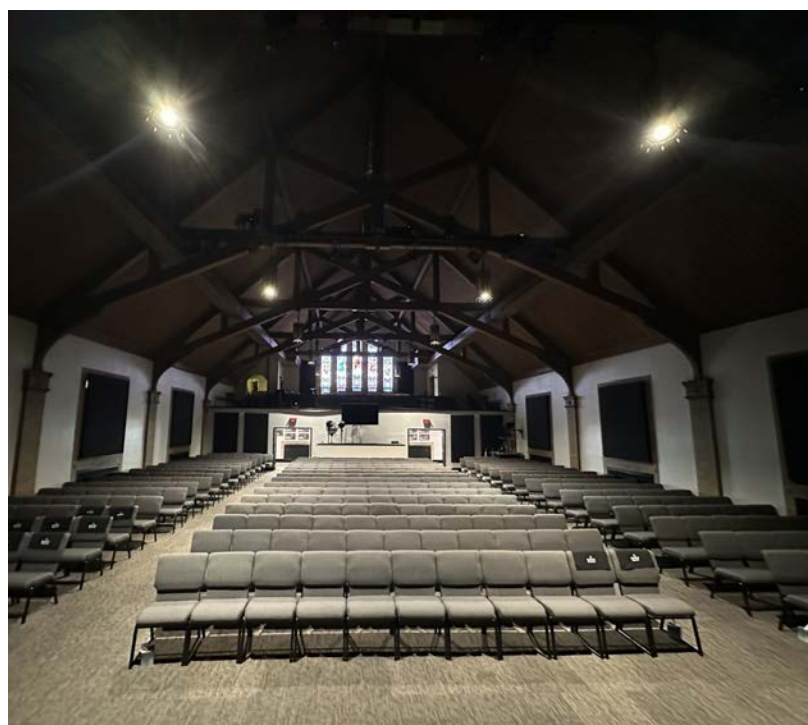
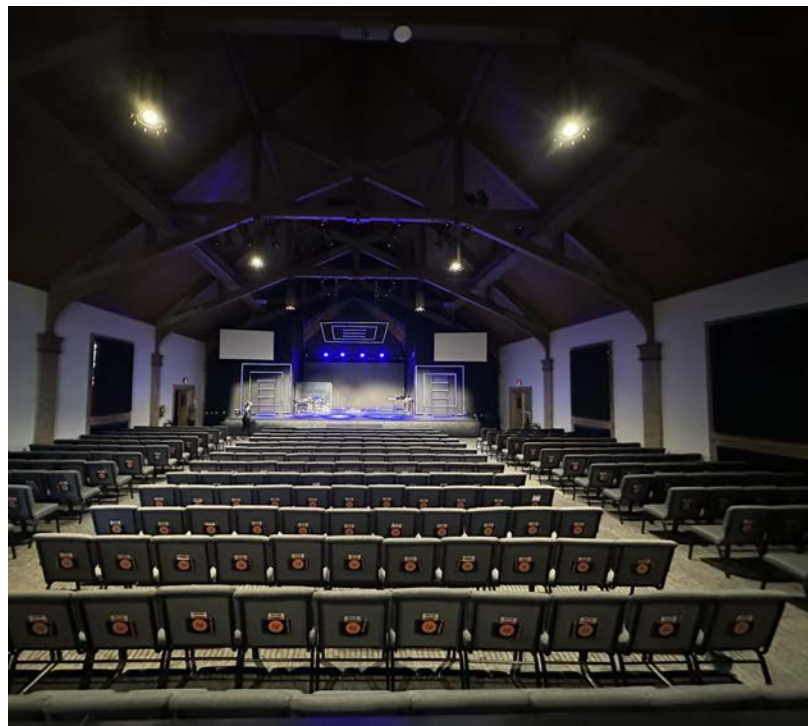

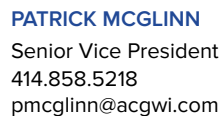

SITE AND LANDSCAPING PLAN | +/- 19,000 SF TURN-KEY CHURCH/SCHOOL FOR SALE

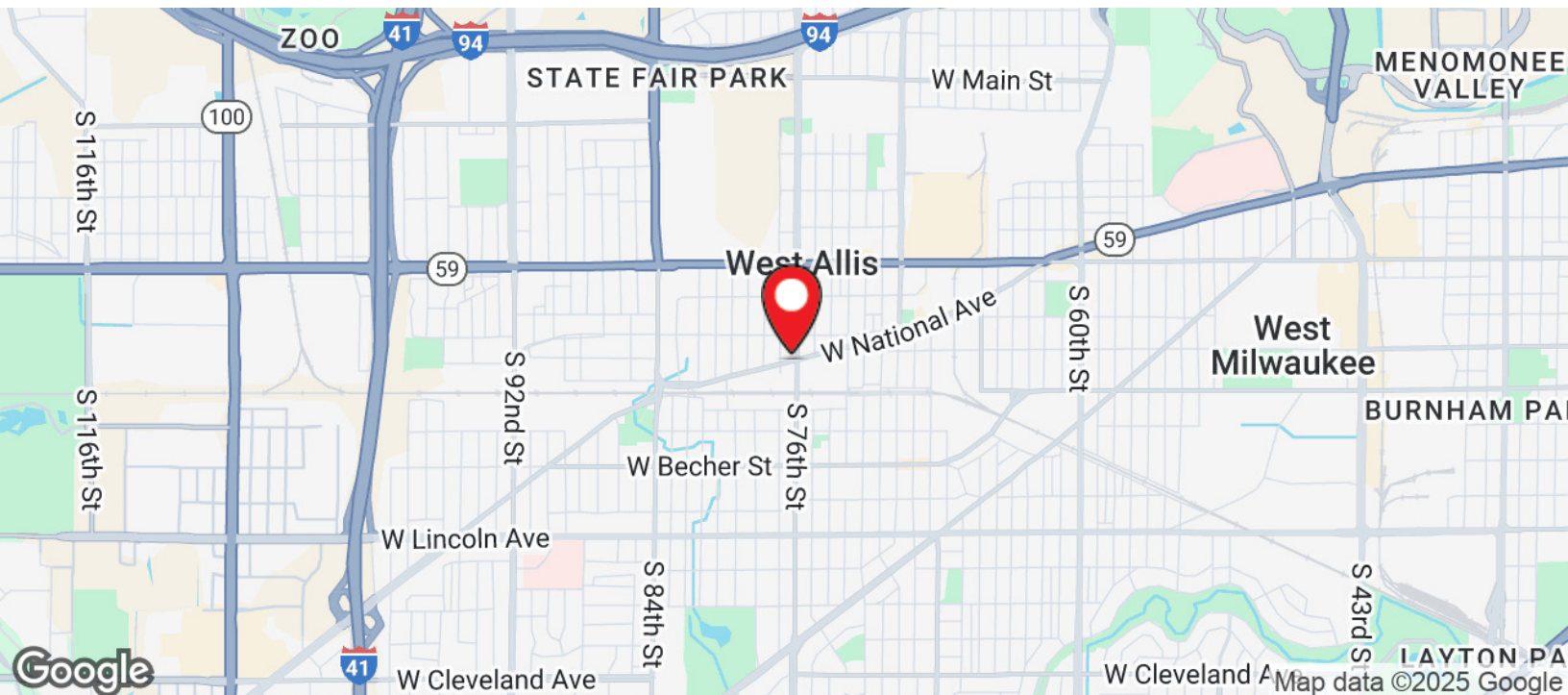
