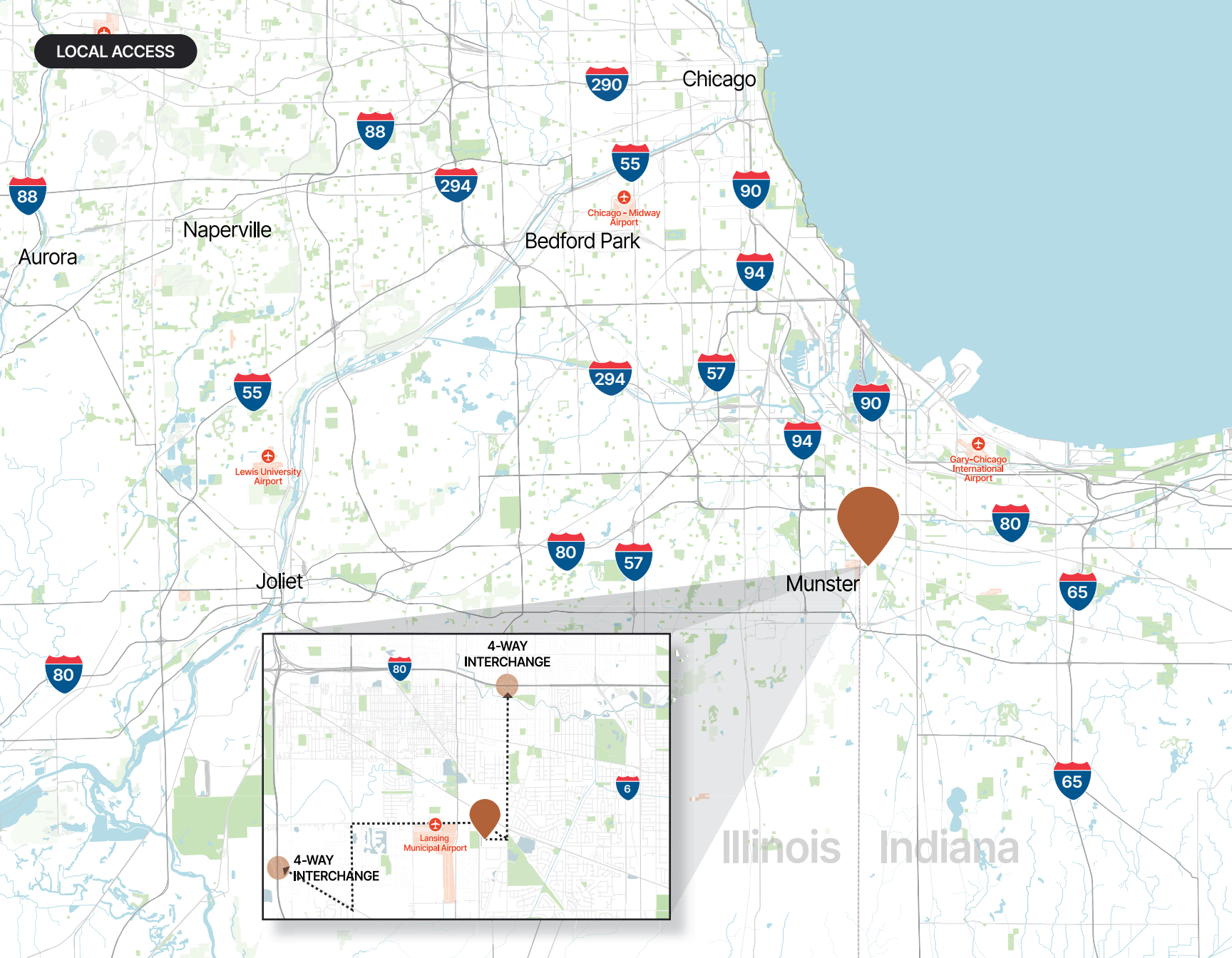
Active CSX Rail, Triple Spur, full building length $\pm 1,050'$

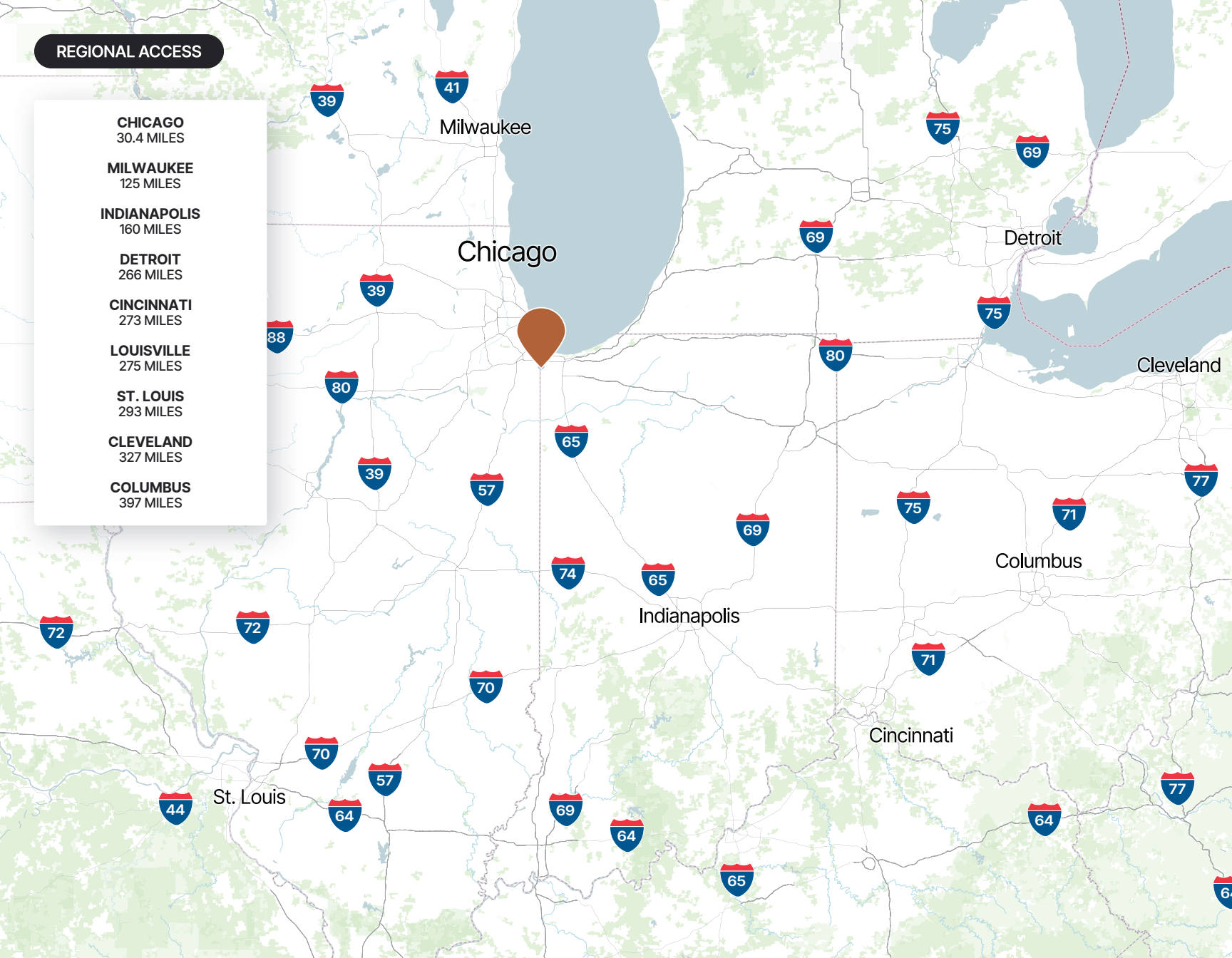

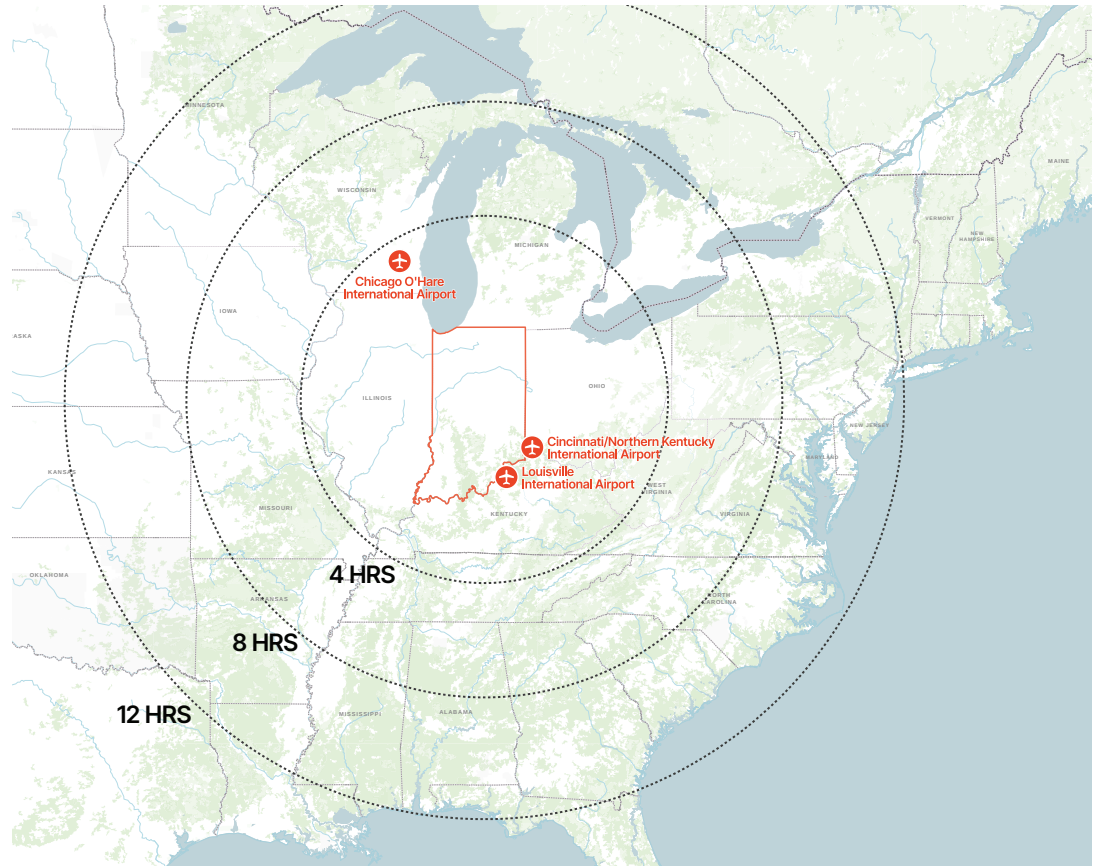
