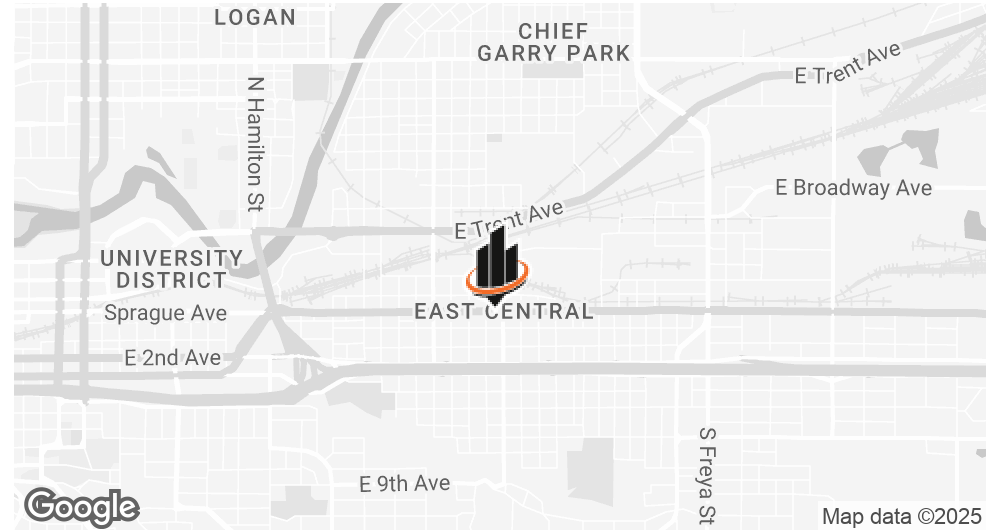

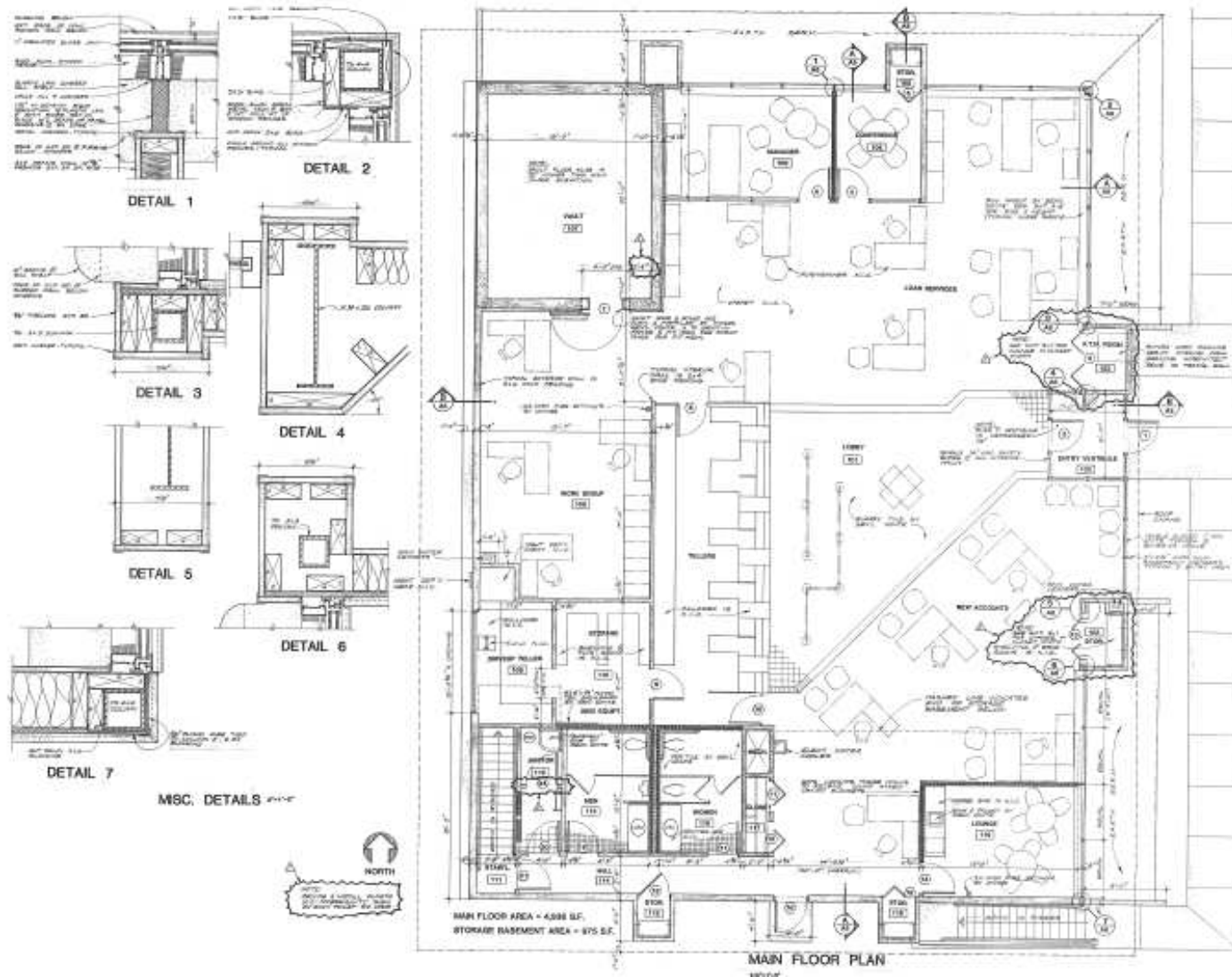

RETAILER MAP



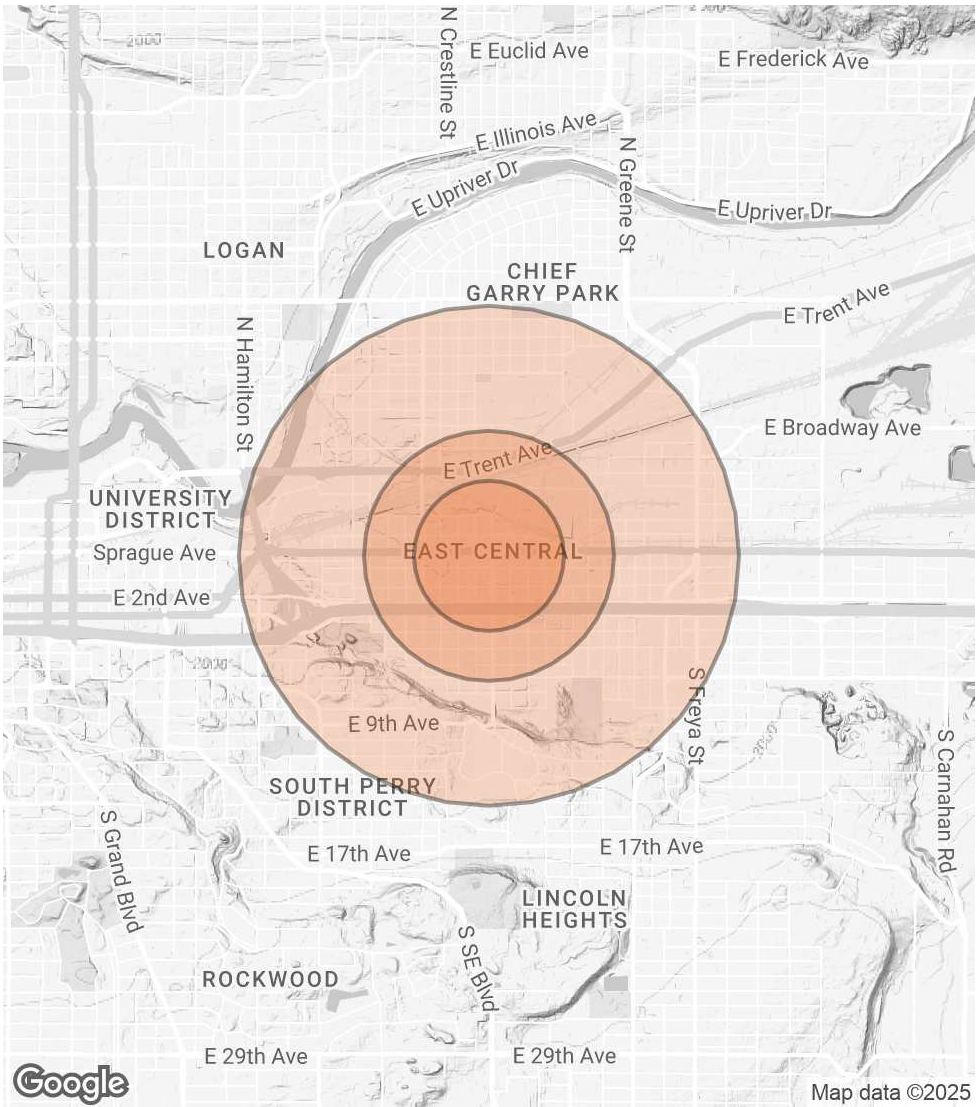
